The Administrative Code of 1929.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 513, act of April 9, 1929, P. L. 177, amended.

Section 1. Section 513, act of April 9, 1929 (P. L. 177), known as "The Administrative Code of 1929," is amended to read:

Section 513. Acceptance of Gifts or Donations.—Every administrative department, every independent administrative board and commission, and, with the approval of the department with which it is connected, every departmental administrative board or commission, may accept gifts or donations of money, securities, or other personal property, which, or the income of which, shall be used in conducting the work of such department, board, or commission, or for the benefit of the inmates or patients of any State institution administered by such department, board, or commission.

[Except] *The Department of Property and Supplies, with the approval of the Governor, may accept for educational purposes on behalf of the Commonwealth real estate, or any interest in real estate, by deed, gift or devise, upon investigation and approval of the title thereto by the Department of Justice, and except as otherwise in this act expressly provided, a department, board, or commission, shall not accept any gift of real estate, or of any interest in real estate, without specific authority from the General Assembly so to do.*

AN ACT

Repealing section 830.1, act of April 29, 1959 (P. L. 58), entitled "An act consolidating and revising the Vehicle Code, the Tractor Code, the Motor Vehicle Financial Responsibility Act and other acts relating to the ownership, possession and use of vehicles and tractors," relating to the marking of certain commercial motor vehicles, truck tractors, trailers and semi-trailers with the names and addresses of the owners or operators.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

The Vehicle Code.

Section 1. Section 830.1, act of April 29, 1959 (P. L. 58), known as "The Vehicle Code," added September 15, 1961 (P. L. 1304), is repealed.

AN ACT

Amending the act of April 29, 1959 (P. L. 58), entitled "An act consolidating and revising the Vehicle Code, the Tractor Code, the Motor Vehicle Financial Responsibility Act and other acts relating to the ownership, possession and use of vehicles and tractors," providing for one wheel brakes where vehicle is constructed with three wheels.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

The Vehicle Code.

Section 1. Subsection (b) of section 816, act of April 29, 1959 (P. L. 58), known as "The Vehicle Code," is amended to read:

Subsection (b), section 816, act of April 29, 1959, P. L. 58, amended.

Section 816. Brakes.—

\* \* \* \* \*

(b) Every motor vehicle using the highways of this Commonwealth, except motorcycles and bicycles with motors attached, shall be equipped with two (2) separate means of applying the brakes so constructed that failure of any one (1) part of the operating mechanism shall not leave the motor vehicle without operative brakes on at least two (2) wheels, *or at least one (1) wheel if the vehicle was constructed with three (3) wheels*. One such means shall be an emergency brake employing a ratchet and pawl, or other suitable locking and releasing mechanism, effective to lock at least two (2) rear wheels on opposite sides of the vehicle, *or the one (1) rear wheel if the vehicle was constructed with a single load carrying wheel in the rear*. The other such means shall be a service brake effective upon all wheels of every such motor vehicle sold new in this Commonwealth on or after January 1, 1956, and upon at least two (2) wheels of every other such motor vehicle.
