Amending the act of June 11, 1935 (P. L. 326), entitled "An act relating to counties of the first class; defining deceased service persons; providing for contributions by the county to the funeral expenses for such persons and their widows; providing for the erection and care of markers, headstones, and flags, and for the compilation of war records," adding the Veterans of World War I of the U. S. A., Inc.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Counties of first class.

Section 1. Section 10, act of June 11, 1935 (P. L. 326), entitled "An act relating to counties of the first class; defining deceased service persons; providing for contributions by the county to the funeral expenses for such persons and their widows; providing for the erection and care of markers, headstones, and flags, and for the compilation of war records," amended June 21, 1961 (P. L. 503), is amended to read:

Section 10, act of June 11, 1935, P. L. 326, amended June 21, 1961, P. L. 503, further amended.

Section 10. Voluntary Assistance by Veterans' Organizations.—For the purpose of locating the burial places of deceased service persons, the Grand Army of the Republic, the United Spanish War Veterans, the Veterans of Foreign Wars of the United States, the American Legion, the Disabled American Veterans, the Veterans of World War I of the U. S. A., Inc., the American Veterans of World War II (AMVETS), the Marine Corps League and The Italian American War Veterans of the United States, Incorporated, through their local camps, posts, and branches in this State, are authorized, without expense to the county, to collect the required data, and prepare and file with the county commissioners, certificates embodying the information provided for in this section.

AN ACT

Amending the act of June 24, 1939 (P. L. 872), entitled "An act to consolidate, amend and revise the penal laws of the Commonwealth," adding the Veterans of World War I of the U. S. A., Inc.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

The Penal Code.

Sections 889 and 891, act of June 24, 1939, P. L. 872, amended June 19, 1961, P. L. 466, further amended.

Section 1. Sections 889 and 891, act of June 24, 1939 (P. L. 872), known as "The Penal Code," amended June 19, 1961 (P. L. 466), are amended to read:

Section 889. Illegally Wearing Military Insignia.—Whoever wilfully wears the insignia, badge, shield or button of the Loyal Legion of the United States, or the Grand Army of the Republic, or the Union Veteran Legion, or the Order Sons of Veterans, or the Spanish-American War Veterans, or the Society of Spanish-American or Philippine Wars, or the American Legion, or the Veterans of Foreign Wars of the United States, or the Disabled American Veterans of the World War, or the Veterans of World War I of the U. S. A., Inc., or the American Veterans of World War II (AMVETS), or the Marine Corps League, or Italian American War Veterans of the United States, Incorporated, or the Air Force Association, or the Civil Air Patrol, or the official decorations of any said organizations, or uses the same to obtain aid or assistance, unless he is entitled to use or wear the same under the constitution and by-laws, rules and regulations of such organizations, is guilty of a misdemeanor, and upon conviction, shall be sentenced to pay a fine not to exceed one hundred dollars (\$100), or be imprisoned for a period not to exceed sixty (60) days, or both.

Section 891. Illegally Wearing Military Uniform.—Whoever wears the uniform, or any distinctive part thereof, of the United States Army, Navy, Marine Corps, Revenue Cutter Service, Coast Guard, or Civil Air Patrol, or of the National Guard, while soliciting alms, or while engaged for personal profit in selling merchandise, or taking orders for the same, or while engaged for personal profit in seeking or receiving contributions in support of any cause, enterprise or undertaking, or while engaged in soliciting or receiving subscriptions to any book, paper or magazine, unless said wearer is a duly authorized solicitor of the Grand Army of the Republic, the United Spanish War Veterans, the Veterans of Foreign Wars of the United States, the American Legion, the Disabled American Veterans of the World War, Veterans of World War I of the U. S. A., Inc., the American Veterans of World War II (AMVETS), the Marine Corps League, the Civil Air Patrol, Italian American War Veterans of the United States, Incorporated, or any local branch, camp or post thereof, is guilty of a misdemeanor, and upon conviction thereof, shall be sentenced to pay a fine not exceeding one hundred dollars (\$100), or undergo imprisonment for not more than two (2) months, or both.

This section shall not apply to any member of the United States Army, Navy, Marine Corps, Revenue Cutter Service, or Coast Guard, or to any member of the National Guard or the Civil Air Patrol, while in service.

Section 2. Section 892 of the act, amended June 7, 1961 (P. L. 252) and June 19, 1961 (P. L. 466), is amended to read:

Section 892 of the act, amended June 7, 1961, P. L. 252 and June 19, 1961, P. L. 466, further amended.

Section 892. *Illegal Sale of Veterans' Flowers.*—Whoever imitates, sells or offers to sell the labeled artificial flowers of the American Legion, Veterans of Foreign Wars, Spanish-American War Veterans, American War Mothers, Disabled American Veterans of the World War, *Veterans of World War I of the U. S. A., Inc.*, the American Veterans of World War II (AMVETS), the Marine Corps League, and the Italian American War Veterans of the United States, Incorporated, namely the poppy, the buddy poppy, carnation, American War Mothers' carnation, the forget-me-not, the four leaf white clover, the poinsettia, and the daisy, except on the day or days designated or appointed by the respective veterans' organizations to conduct such sales, shall, upon conviction, in a summary proceeding, be sentenced to pay a fine of not more than fifty dollars (\$50), and in default of the payment of such fine, and costs, shall be sentenced to imprisonment for ten (10) days.
