priate representative of the United States then assigned to the foreign country, may be filed with the prothonotary or clerk of the [orphans'] court as the procedure established may require in the county of residence of the adopting parents. The fee charged for such filing by the prothonotary or clerk of the court shall be twelve dollars (\$12). The decree and such other documents as may be filed therewith shall be kept in the files of the court as a permanent record thereof, and shall be kept from inspection except on order granted upon cause shown. Upon the filing of a foreign decree of adoption, the prothonotary or clerk of the [orphans courts] court, as the procedure established may require, shall enter upon the docket an entry showing the foreign court, the term and number \*or such other identification used by the foreign court and date of decree. After the decree has been filed, the court shall make a report thereof to the Department of Public Welfare on a form supplied by the department, which the department shall keep in confidential files. Information identifying the natural parents shall not be required.

Section 2. This act shall take effect immediately.
