PROCLAMATION

By virtue of the authority vested in me by Article IV, Section 12, of the Constitution, I, William W. Scranton, Governor of the Commonwealth of Pennsylvania, do hereby convene the General Assembly in extraordinary session, to meet in the Capitol, at Harrisburg, on Tuesday, February 11, 1964, at 12:00 o'clock noon, to consider legislation upon the following subjects:

1. Codifying, amending, revising and consolidating the laws relating to eminent domain.

2. Implementation of the authority granted by Article IX, Section 24, of the Constitution of Pennsylvania, otherwise known as "Project 70."

3. Stabilization of the unemployment compensation fund by amending the provisions of the Unemployment Compensation Law relating to benefits, rates of contribution and procedures.

4. Amending and clarifying the definition of "blind veteran" as defined in Act No. 17 of the 1963 sessions.

5. Providing for institutional care and treatment of aged patients of the State Mental Institutions who do not require treatment for mental disease.

PROCLAMATION

WHEREAS, an extraordinary session of the General Assembly of the Commonwealth of Pennsylvania, has been called under authority of Article IV, Section 12, of the Constitution of Pennsylvania, to meet in the Capitol, at Harrisburg, on Tuesday, February 11, 1964, at 12:00 o'clock noon;

NOW, THEREFORE, I, William W. Scranton, Governor of the Commonwealth of Pennsylvania, do hereby amend Item 3 of the subjects designated in the said Proclamation, to read as follows:

3. Stabilization of the unemployment compensation fund by amending the provisions of the Unemployment Compensation Law relating to benefits, contributions and procedures.
