

monwealth, an amount equal to the costs of these services and equipment multiplied by the district's [reimbursement fraction] aid ratio.

No such expenditures nor purchases may be made by any school district unless in accordance with a budget submitted by the district and approved by the Department of Public Instruction. The total expenditure by the Commonwealth hereunder shall not exceed seventy-five percent of a sum which would have been expended for the tuition and maintenance of any such child in a residential school for the blind, including partially sighted, deaf, hard of hearing, or those afflicted with cerebral palsy, that has been approved by the Department of Public Instruction for the education of the blind, partially sighted, deaf, hard of hearing, or those afflicted with cerebral palsy.

The services of such readers, helpers and guides may be contracted and paid for by the school district irrespective of the age of the person rendering such assistance and of the employment of such person by the school district as a teacher or otherwise and of the time and place where such services are rendered.

The Department of Public Instruction shall establish such necessary rules, regulations and standards as it may deem necessary for carrying out the provisions of this act.

AN ACT

SB 1175

Amending the act of June 22, 1931 (P. L. 594), entitled "An act establishing certain township roads as State highways; authorizing their construction, maintenance, and improvement under certain conditions and restrictions; limiting the obligation of the Commonwealth in the construction of certain structures located on such highways; conferring certain powers upon the Department of Highways and local authorities, persons, associations and corporations for sharing the cost of the maintenance and construction of such highways; and making an appropriation to carry out the provisions of said act," changing a route in Harrison Township, Allegheny County.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The following route, established by the act of June 22, 1931 (P. L. 594), entitled "An act establishing certain township roads as State highways; authorizing their construction, maintenance, and improvement under certain conditions and restrictions; limiting the

obligation of the Commonwealth in the construction of certain structures located on such highways; conferring certain powers upon the Department of Highways and local authorities, persons, associations and corporations for sharing the cost of the maintenance and construction of such highways; and making an appropriation to carry out the provisions of said act," is amended to read:

Route 02158. Beginning at a point on Route 70 [near] at the intersection of Oregon Avenue, thence in a northwesterly direction over Oregon Avenue to its intersection with Carlisle Street, thence in a southwesterly direction over Carlisle Street to its intersection with Pleasantville Road [and extending in a northwesterly direction to a point near Little Bull Creek;] thence in a northwesterly then northeasterly direction over Pleasantville Road to an intersection [at a point near the Fawn Township line;] with Burtner Road; thence in a [southerly] easterly direction over Burtner Road to a point on Route 70 [near the Natrona Road,] and the westerly terminus of Route 02160, in Harrison Township, Allegheny County, a distance of about 2.5 miles.

Section 2. This act shall take effect immediately.

SB 1187

Authorizing the Department of Property and Supplies, with the approval of the Secretary of Public Welfare and the Governor, to convey 5.608 acres, more or less, of land in Somerset Township, Somerset County, in exchange for a tract of land containing 1.086 acres, more or less, with the improvements thereon erected, also situate in Somerset Township, Somerset County.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The Department of Property and Supplies, with the approval of the Secretary of Public Welfare and the Governor, is hereby authorized to convey in the name of the Commonwealth of
