

Tract No. 5. All that certain piece or parcel of land situate in Sandy Lake Township, Mercer County, Pennsylvania, bounded and described as follows:

BEGINNING at the northwest corner of the land herein conveyed which point is at the northeast corner of Parcel No. 2 in Deed of Glenn U. Dickey, et ux, to second party hereto; thence south 3 degrees 56 minutes west along land formerly of Glenn U. Dickey, now second party hereto, a distance of 687.9 feet to a point; thence south 86 degrees 44 minutes east a distance of 1,102.4 feet to a point; thence north 4 degrees 03 minutes east a distance of 686 feet to a point; thence north 86 degrees 45 minutes west a distance of 1,104 feet to a point the place of BEGINNING, containing 18.2 acres of land more or less.

Being the same premises which John F. Faulconbridge and Mary M. Faulconbridge, his wife, by deed dated January 4, 1966, and recorded in the recorder's office in and for Mercer County in Deed Reference No. 121 of 1966, granted and conveyed unto Sandy Creek Conservancy, a non-profit corporation organized under the laws of the Commonwealth of Pennsylvania, the present owners.

Section 2. The land shall not be acquired until its title has been approved by the Department of Justice.

Section 3. The sum of fifty thousand dollars (\$50,000), or as much thereof as may be necessary, is hereby appropriated to the Department of Property and Supplies for the payment of the purchase price and incidental expenses, including the completion of an abstract of title.

Section 4. This act shall take effect immediately.

AN ACT

SB 1224

Amending the act of June 8, 1923 (P. L. 685), entitled "An act prescribing the fees for the office of Secretary of the Commonwealth," eliminating certain fees and conforming a portion of the act to existing law.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. Section 1, act of June 8, 1923 (P. L. 685), entitled "An act prescribing the fees for the office of Secretary of the Common-

wealth," amended November 30, 1959 (P. L. 1607), is amended to read:

Section 1. Be it enacted, &c., That the fees of the Secretary of the Commonwealth for the use of the State, shall be as follows:

For certificate with great seal, two dollars.

Certificate with secretary's seal, one dollar.

Taking or filing bond of any public officer, two dollars.

Taking or filing recognizance of any public officer, two dollars.

Writ of assistance, including great seal, five dollars.

Commission for any city, county, or district officer who receives emoluments, and pays no taxes on commission, five dollars (coroners are by law exempt from this fee).

Commission to take acknowledgment of deeds or other instruments, twenty-five dollars.

Filing praecipe and making search thereon, fifty cents.

Photocopies of records, per photocopy page, or part thereof, one dollar.

Each commission for justice of the peace or alderman, to be collected and paid over to the recorder of deeds, three dollars.

[Requisition for criminals, three dollars.

Warrants on requisition for criminal, three dollars.]

Approving plans of prisons, including certificate and great seal, three dollars.

Each commission for railroad, or other police, five dollars.

Registering assumed or fictitious names under act of Assembly, ten dollars plus twenty-five cents for each registrant in excess of three.

Filing statements of cancellation or withdrawal of assumed or fictitious names under act of Assembly, ten dollars.

Description of bottles under act of Assembly, fifteen dollars.

Registering emblems under act of Assembly, fifteen dollars.

Registering union labels under act of Assembly, fifteen dollars.

Issuing a certificate of authority to a foreign corporation, one hundred dollars.

Issuing an amended certificate of authority to a foreign corporation, fifty dollars.

Issuing a certificate of withdrawal to a foreign corporation, thirty dollars.

Filing power of attorney and statement by foreign corporations, one hundred dollars.

Filing statement of revocation of agent by foreign corporations, twenty-five dollars.

Filing certificate of change of corporate title by foreign corporations, fifty dollars.

Filing statement of change of Pennsylvania office by foreign corporations, ten dollars.

Service of process for each defendant served, five dollars.

Letters patent, certificate of incorporation, or instrument incorporating any corporation or association, forty dollars.

Filing articles of association for railroad or street railway companies and recording the same, fifty dollars.

Letters patent or instrument incorporating any insurance company, fifty dollars.

Filing acceptance of provisions of act of Assembly or Constitution, ten dollars.

Filing an application to reserve a corporate name, five dollars.

Filing an application for registration of nonprofit corporate name and issuance of certificate, ten dollars.

Filing application for change of name of public utility corporations and issuance of certificate, thirty dollars.

Filing articles of association by cooperative associations, including copies, forty dollars.

Filing proceedings in extension of route by street railway companies, thirty dollars.

Filing election return authorizing increase or decrease of capital stock or indebtedness, or sale of franchises, and recording same, thirty dollars.

Filing report of actual increase or decrease of capital stock or indebtedness, or sale of franchises, ten dollars.

Filing a statement of shares to be issued in series, thirty dollars.

Filing a statement of redemption and cancellation of shares, thirty dollars.

Filing a statement of reduction of stated capital without change in share structure, thirty dollars.

Filing each waiver of sixty days' notice, ten dollars.

Filing certificate or statement of change of location of principal or registered office or date of annual meeting, ten dollars.

Filing certificate of change of par value of shares, thirty dollars.

Issuing a certificate of amendment to a corporation, thirty dollars.

Filing amendment to insurance company charter, thirty dollars.

Filing agreement of merger or consolidation, or issuing a certificate of merger or certificate of consolidation on articles of merger or consolidation, thirty dollars, plus an additional fee of ten dollars for each corporation which is a party to the merger or consolidation proceeding.

Issuing a certificate of authorization to any bank, trust company, or bank and trust company, ten dollars.

Issuing a certificate of approval of a merger or consolidation of State banks, or banks and trust companies, with a National bank, thirty dollars, and an additional fee of ten dollars for each State bank, or bank and trust company, which is a party to the merger or consolidation proceedings.

Issuing a certificate of conversion of a State bank, or bank and

trust company, into a National bank, or of a National bank into a State bank, or bank and trust company, forty dollars.

Filing statement of merger or consolidation by a qualified foreign business corporation, twenty dollars, plus ten dollars for each qualified foreign corporation withdrawing thereby.

Filing proceedings in reorganization, forty dollars.

Filing copy of decree of dissolution, ten dollars.

Filing a certificate of election to dissolve, fifteen dollars.

Issuing a certificate of dissolution on articles of dissolution, fifteen dollars.

Filing affidavit of paid up capital stock or paid-in capital, ten dollars.

Filing copy of ¹ articles of association, registered partnership, ten dollars.

Filing cancellation of conditional sales agreement, ten dollars.

And equivalent fees for any like services, though not herein specified.

The Secretary of the Commonwealth shall not be required to receive or file any papers unless the same shall be in accordance with law, except in the case of banks, bank or trust companies, trust companies, savings banks, private banks and employes' mutual banking associations, which determination shall be made by the Department of Banking as provided by Act No. 356, approved November 30, 1965, and except as to business corporations or foreign business corporations, as defined in the "Business Corporation Law," and as to nonprofit corporations or foreign nonprofit corporations, as defined in the "Non-profit Corporation Law," and accompanied by the proper fee.

Section 2. All acts and parts of acts are repealed in so far as they are inconsistent herewith.
