The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. Subsection (5) of section 207, act of June 1, 1959 (P. L. 392), known as the "State Employes' Retirement Code of 1959," added December 1, 1965 (P. L. 1025), is amended to read:

Section 207. Credit for Military Service.—

\* \* \*

(5) Any State employe who is a contributor and who served in the armed forces of the United States subsequent to September 16, 1940, [and who was not a State employe prior to such period of military service] and who commenced or returned to State employment within three (3) years from date of release from active duty, shall be entitled to have full credit for each year or fraction thereof not to exceed five (5) years of the service in the armed forces of the United States upon his payment to the fund of back contributions according to the provisions of article III, section 302 subsection (2).

AN ACT

HB 2635

Authorizing the Department of Property and Supplies, with the approval of the Governor, to sell and convey 1.421 acres with appurtenances situate in McConnellsburg Borough, Fulton County.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The Department of Property and Supplies, with the approval of the Governor, is hereby authorized on behalf of the Department of Highways and the Commonwealth of Pennsylvania, to sell and convey to the Borough of McConnellsburg, Fulton County for a consideration of one dollar (\$1), the following described tract of land situate in McConnellsburg Borough, Fulton County and Commonwealth of Pennsylvania.

Beginning at an iron pin, the corner of McConnellsburg Borough and Ayr Township line; thence by said line south 73 degrees, 59

minutes east, a distance of 235.57 feet to a stone; corner of lot now of the Fulton Electric Light and Power Company; thence by line of Fulton Electric Light and Power Company and Albert D. Hohman properties, also the McConnellsburg Borough and Ayr Township line south 6 degrees, 24 minutes west, a distance of 246.29 feet to an iron pin; thence by the McConnellsburg School property, also the McConnellsburg Borough and Ayr Township line, north 72 degrees, 26 minutes west, a distance of 283.12 feet, to an iron pin; thence by the McConnellsburg Borough and Ayr Township line, north 17 degrees, 34 minutes east, a distance of 235.32 feet to an iron pin, the point of beginning, containing 1.421 acres more or less, with appurtenances.

Section 2. The conveyance shall not be made until such time as the Department of Highways erects a maintenance building and operational facilities at another location.

Section 3. The deed of conveyance shall be approved by the Department of Justice and shall be executed by the Secretary of Property and Supplies in the name of the Commonwealth of Pennsylvania.

Section 4. This act shall take effect immediately.

AN ACT

SB 1564

Amending the act of April 29, 1959 (P. L. 58), entitled "An act consolidating and revising the Vehicle Code, the Tractor Code, the Motor Vehicle Financial Responsibility Act and other acts relating to the ownership, possession and use of vehicles and tractors," authorizing persons who are seventeen years of age and over to operate as paid employes motor vehicles other than commercial motor vehicles or certain vehicles transporting passengers for hire or hazardous substances.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. Section 625, act of April 29, 1959 (P. L. 58), known as "The Vehicle Code," is amended to read:

Section 625. Unlawful for Person Under Eighteen (18) Years to Operate Vehicle as a Paid Employee.—It shall be unlawful for any person under the age of eighteen (18) years to operate a motor vehicle or tractor upon any highway as a paid employe, or for any person to cause or permit any such operation, except
