A SUPPLEMENT

HB 383

To the act of July 3, 1984 (P.L.583, No.117), entitled "An act providing for the capital budget for the fiscal year 1984-1985," itemizing public improvement projects, furniture and equipment projects, transportation assistance projects, flood control projects, site development projects and redevelopment assistance projects to be constructed or acquired or assisted by the Department of General Services, the Department of Transportation, the Department of Commerce, the Department of Community Affairs or the Department of Environmental Resources, together with their estimated financial costs; authorizing the incurring of debt without the approval of the electors for the purpose of financing the projects to be constructed or acquired or assisted by the Department of General Services, the Department of Transportation, the Department of Commerce, the Department of Community Affairs or the Department of Environmental Resources; stating the estimated useful life of the projects; making appropriations; and making a repeal.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. Short title.

This act shall be known and may be cited as the Capital Budget Project Itemization Act for 1984-1985.

Section 2. Total authorizations.

(a) Public improvements.—The total authorization for the additional capital projects in the category of public improvement projects itemized in section 3 and to be acquired or constructed by the Department of General Services, its successors or assigns, and to be financed by the incurring of debt, shall be \$713,393,000.

(b) Furniture and equipment.—The total authorization for the additional capital projects in the category of public improvement projects consisting of the acquisition of original movable furniture and equipment to complete public improvement projects itemized in section 4 and to be purchased by the Department of General Services, its successors or assigns, and to be financed by the incurring of debt, shall be \$43,193,000.

(c) Transportation assistance.—The total authorization for the capital projects in the category of transportation assistance projects itemized in section 5 with respect to which an interest is to be acquired in or constructed by the Department of Transportation, its successors or assigns, and to be financed by the incurring of debt, shall be \$120,897,000.

(d) Flood control.—The total authorization for the capital projects in the category of flood control projects itemized in section 6 and to be constructed by the Department of Environmental Resources, its successors or assigns, and to be financed by the incurring of debt, shall be \$15,830,000.

(e) Site development.—The total authorization for capital projects in the category of site development projects itemized in section 7 for capital grants

by the Department of Commerce, its successors or assigns, and to be financed by the incurring of debt, shall be \$2,255,000.

(f) Redevelopment assistance.—The total authorization for the capital projects in the category of redevelopment assistance projects itemized in section 8 for capital grants by the Department of Community Affairs, its successors or assigns, and to be financed by the incurring of debt, shall be \$697,441,000.

Section 3. Itemization of public improvement projects.

Additional capital projects in the category of public improvement projects to be constructed or acquired by the Department of General Services, its successors or assigns, and to be financed by the incurring of debt, are hereby itemized, together with their respective estimated financial costs, as follows:

Section 9. Heating systems.

(a) **Coal requirement.**—Any heating system or heating unit installed as part of any of the public improvement projects itemized in this act shall be fueled by coal.

(b) **Exemption.**—Any heating system or heating unit shall be exempt from the requirement of subsection (a) if the Department of General Services determines that the application of subsection (a) to that heating system or heating unit would violate existing or reasonably anticipated environmental laws or regulations or would not be cost effective when compared to other forms of energy. The Department of General Services shall report to the House and Senate Appropriations Committees the basis for any determination that a heating system or heating unit shall be exempt from the requirement of subsection (a).

(c) **Section not applicable.**—This section shall not apply to any public improvement project itemized in this act if the fuel to be used in that project is specified in this act.

(d) **Mixture with natural gas.**—For the purposes of this section the phrase “mixture derived, in whole or in part, from coal” includes, but is not limited to, both the intermittent and the simultaneous burning of natural gas with coal or a coal derivative if the intermittent or simultaneous burning of natural gas would:

(1) lower the cost of using coal or a coal derivative produced from mines in Pennsylvania; or

(2) enable coal or a coal derivative produced from mines in Pennsylvania to be burned in compliance with present and reasonably anticipated environmental laws and regulations.

(e) **Definition.**—For the purposes of this section “coal” includes coal, a synthetic derived in whole or in part from coal, or a mixture which includes coal or is derived in whole or in part from coal.

Section 10. Restriction on certain funds.

The additional funds provided for original furnishings and equipment for DGS 948-12, the Capitol Building expansion, itemized in section 4(3)(i)(A), shall only be disbursed upon the written approval of both the Chief Clerk of the Senate and the Chief Clerk of the House of Representatives.

Section 11. Conditions for certain funds.

The funds authorized under section 3(6)(ii) shall be made available for capital construction projects for volunteer fire companies, provided construction for such projects was actually commenced on or prior to January 1, 1986, and for which Federal Community Development funding was committed, in whole or in part. No individual volunteer fire company shall be awarded more than \$75,000. All applications shall be made within 90 days of notice of availability of funding, and awards shall be made within an additional 90 days. All unawarded funds shall lapse at the conclusion of that period.

Section 12. Convention center restriction and limitations.

(a) **Commitment.**—No more than \$48,000,000 of State funds authorized under this act may be paid to the Convention Center Authority and/or the Philadelphia Redevelopment Authority for site acquisitions, relocation, demolition, site preparation costs, project design costs and related administrative expenses until the Mayor of the City of Philadelphia certifies to the Secretary of the Budget of the Commonwealth that he has received a binding written commitment for the development of a major convention headquarters hotel adjacent to or in the immediate vicinity of the convention center. The commitment shall be in such form and subject to such conditions as the Convention Center Authority Chairman shall approve, and such commitment shall be subject to review and acceptance by the Secretary of the Budget. No State funds may be used for the physical construction of the hotel. All State funds paid to the Convention Center Authority and/or the Redevelopment Authority shall be as authorized under this act and other laws, and payments shall be in accordance with a contract between the Department of Community Affairs and the Convention Center Authority and/or the Redevelopment Authority.

(b) **Use of real estate.**—In the event the construction of the convention center on this site is not undertaken by January 1, 1992, all real estate acquired, in whole or in part, with State funds shall be held by the authority for the benefit of the Commonwealth, and the authority shall sell or lease the property consistent with the act of May 24, 1945 (P.L.991, No.385), known as the Urban Redevelopment Law, in such manner and pursuant to such terms as the Commonwealth shall approve. Upon sale or lease of any real estate, a proportion of the proceeds that is equivalent to the percentage of State funds originally used in the acquisition of the real estate shall be returned to the Commonwealth and shall be deposited in the General Fund.

Section 13. Debt authorization.

(a) **Public improvements.**—The Governor, Auditor General and State Treasurer are hereby authorized and directed to borrow, from time to time, in addition to any authorization heretofore or hereafter enacted, on the credit of the Commonwealth, subject to the limitations provided in the current capital budget, money not exceeding in the aggregate the sum of \$713,393,000 as may be found necessary to carry out the acquisition and construction of the public improvement projects specifically itemized in a capital budget.

(b) **Furniture and equipment.**—The Governor, Auditor General and State Treasurer are hereby authorized and directed to borrow, from time to time, in addition to any authorization heretofore or hereafter enacted, on the credit of the Commonwealth, subject to the limitations provided in the current capital budget, money not exceeding in the aggregate the sum of \$43,193,000 as may be found necessary to carry out the public improvement projects consisting of the acquisition of original movable furniture and equipment specifically itemized in a capital budget.

(c) **Transportation assistance.**—The Governor, Auditor General and State Treasurer are hereby authorized and directed to borrow, from time to

time, in addition to any authorization heretofore or hereafter enacted, on the credit of the Commonwealth, subject to the limitations provided in the current capital budget, money not exceeding in the aggregate the sum of \$120,897,000 as may be found necessary to carry out the acquisition and construction of the transportation assistance projects specifically itemized in a capital budget.

(d) **Flood control.**—The Governor, Auditor General and State Treasurer are hereby authorized and directed to borrow, from time to time, in addition to any authorization heretofore or hereafter enacted, on the credit of the Commonwealth, subject to the limitations provided in the current capital budget, money not exceeding in the aggregate the sum of \$15,830,000 as may be necessary to carry out the construction of the flood control projects specifically itemized in a capital budget.

(e) **Site development.**—The Governor, Auditor General and State Treasurer are hereby authorized and directed to borrow, from time to time, in addition to any authorization heretofore or hereafter enacted, on the credit of the Commonwealth, subject to the limitations provided in the current capital budget, money not exceeding in the aggregate the sum of \$2,255,000 as may be necessary to carry out the site development projects specifically itemized in a capital budget.

(f) **Redevelopment assistance.**—The Governor, Auditor General and State Treasurer are hereby authorized and directed to borrow, from time to time, in addition to any authorization heretofore or hereafter enacted, on the credit of the Commonwealth, subject to the limitations provided in the current capital budget, money not exceeding in the aggregate the sum of \$697,441,000 as may be found necessary to carry out the redevelopment assistance projects specifically itemized in a capital budget.

Section 14. Issue of bonds.

The indebtedness authorized in this act shall be incurred, from time to time, and shall be evidenced by one or more series of general obligation bonds of the Commonwealth in such aggregate principal amount for each series as the Governor, Auditor General and State Treasurer shall determine, but the latest stated maturity date shall not exceed the estimated useful life of the projects being financed as stated in section 15.

Section 15. Estimated useful life and term of debt.

(a) **Estimated useful life.**—The General Assembly states that the estimated useful life of the public improvement projects itemized in this act is as follows:

- (1) Public improvement projects:
 - (i) Forest service roads, 10 years.
 - (ii) All other projects, 30 years.
- (2) Furniture and equipment projects, 10 years.
- (3) Transportation assistance projects:
 - (i) Rolling stock, 15 years.
 - (ii) Passenger buses, 12 years.
 - (iii) Furniture and equipment, 10 years.

(iv) All others, 30 years.

(b) Term of debt.—The maximum term of the debt authorized to be incurred under this act is 30 years.

Section 16. Appropriations.

(a) Public improvements.—The net proceeds of the sale of the obligations authorized in this act are hereby appropriated from the Capital Facilities Fund to the Department of General Services in the maximum amount of \$713,393,000, to be used by it exclusively to defray the financial cost of the public improvement projects specifically itemized in a capital budget. After reserving or paying the expenses of the sale of the obligation, the State Treasurer shall pay to the Department of General Services the moneys as required and certified by it to be legally due and payable.

(b) Furniture and equipment.—The net proceeds of the sale of the obligations authorized in this act are hereby appropriated from the Capital Facilities Fund to the Department of General Services in the maximum amount of \$43,193,000, to be used by it exclusively to defray the financial cost of the public improvement projects consisting of the acquisition of original movable furniture and equipment specifically itemized in a capital budget. After reserving or paying the expenses of the sale of the obligation, the State Treasurer shall pay to the Department of General Services the moneys as required and certified by it to be legally due and payable.

(c) Transportation assistance.—The net proceeds of the sale of the obligations authorized in this act are hereby appropriated from the Capital Facilities Fund to the Department of Transportation in the maximum amount of \$120,897,000, to be used by it exclusively to defray the financial cost of the transportation assistance projects specifically itemized in a capital budget. After reserving or paying the expenses of the sale of the obligation, the State Treasurer shall pay to the Department of Transportation the moneys as required and certified by it to be legally due and payable.

(d) Flood control.—The net proceeds of the sale of the obligations authorized in this act are hereby appropriated from the Capital Facilities Fund to the Department of Environmental Resources in the maximum amount of \$15,830,000, to be used by it exclusively to defray the financial cost of the flood control projects specifically itemized in a capital budget. After reserving or paying the expenses of the sale of the obligation, the State Treasurer shall pay to the Department of Environmental Resources the moneys as required and certified by it to be legally due and payable.

(e) Site development.—The net proceeds of the sale of the obligations authorized in this act are hereby appropriated from the Capital Facilities Fund to the Department of Commerce in the maximum amount of \$2,255,000, to be used by it exclusively to defray the financial cost of the site development projects specifically itemized in a capital budget. After reserving or paying the expenses of the sale of the obligation, the State Treasurer shall pay to the Department of Commerce the moneys as required and certified by it to be legally due and payable.

(f) Redevelopment assistance.—The net proceeds of the sale of the obligations authorized in this act are hereby appropriated from the Capital Facil-

ities Fund to the Department of Community Affairs in the maximum amount of \$697,441,000, to be used by it exclusively to defray the financial cost of the redevelopment assistance projects specifically itemized in a capital budget. After reserving or paying the expenses of the sale of the obligation, the State Treasurer shall pay to the Department of Community Affairs the moneys as required and certified by it to be legally due and payable.

Section 17. Federal funds.

In addition to those funds appropriated in section 16, all moneys received from the Federal Government for the projects specifically itemized in this act are also hereby appropriated for those projects.

Section 18. Partial repeal.

Section 3(a)(3)(i) of the act of December 20, 1984 (P.L.1199, No.228), known as the Transportation Assistance Capital Budget Act for 1984-1985, is repealed insofar as it imposes any limitation of the number of buses that may be purchased.

Section 19. Effective date.

This act shall take effect immediately.

APPROVED—The 10th day of July, A. D. 1986, except as to the following:

Section 16. Appropriations.

(a) **Public improvements.**—The net proceeds of the sale of the obligations authorized in this act are hereby appropriated from the Capital Facilities Fund to the Department of General Services in the maximum amount of \$713,393,000, to be used by it exclusively to defray the financial cost of the public improvement projects specifically itemized in a capital budget. After reserving or paying the expenses of the sale of the obligation, the State Treasurer shall pay to the Department of General Services the moneys as required and certified by it to be legally due and payable.

This item is approved in the sum of \$300,650,000. I withhold my approval from the remainder of this amount for the reasons listed below.

(b) **Furniture and equipment.**—The net proceeds of the sale of the obligations authorized in this act are hereby appropriated from the Capital Facilities Fund to the Department of General Services in the maximum amount of \$43,193,000, to be used by it exclusively to defray the financial cost of the public improvement projects consisting of the acquisition of original movable furniture and equipment specifically itemized in a capital budget. After reserving or paying the expenses of the sale of the obligation, the State Treasurer shall pay to the Department of General Services the moneys as required and certified by it to be legally due and payable.

This item is approved in the sum of \$19,158,000. I withhold my approval from the remainder of this amount for the reasons listed below.

(c) **Transportation assistance.**—The net proceeds of the sale of the obligations authorized in this act are hereby appropriated from the Capital Facilities Fund to the Department of Transportation in the maximum amount of \$120,897,000, to be used by it exclusively to defray the financial cost of the transportation assistance projects specifically itemized in a capital budget.

After reserving or paying the expenses of the sale of the obligation, the State Treasurer shall pay to the Department of Transportation the moneys as required and certified by it to be legally due and payable.

This item is approved in the sum of \$53,310,000. I withhold my approval from the remainder of this amount for the reasons listed below.

(e) Site development.—The net proceeds of the sale of the obligations authorized in this act are hereby appropriated from the Capital Facilities Fund to the Department of Commerce in the maximum amount of \$2,255,000, to be used by it exclusively to defray the financial cost of the site development projects specifically itemized in a capital budget. After reserving or paying the expenses of the sale of the obligation, the State Treasurer shall pay to the Department of Commerce the moneys as required and certified by it to be legally due and payable.

I withhold my approval from this entire amount. All of the projects in Section 7 are to be deleted because these projects can more reasonably be undertaken under other programs operated by the State.

(f) Redevelopment assistance.—The net proceeds of the sale of the obligations authorized in this act are hereby appropriated from the Capital Facilities Fund to the Department of Community Affairs in the maximum amount of \$697,441,000, to be used by it exclusively to defray the financial cost of the redevelopment assistance projects specifically itemized in a capital budget. After reserving or paying the expenses of the sale of the obligation, the State Treasurer shall pay to the Department of Community Affairs the moneys as required and certified by it to be legally due and payable.

This item is approved in the sum of \$400,762,000. I withhold my approval from the remainder of this amount for the reasons listed below.

There are several reasons why the amounts in House Bill 383 are being reduced.

(1) Certain of the projects do not qualify under the category of the capital project where they are listed. Under the category of Public Improvement Projects, the Commonwealth may not fund any project for a non-State-owned facility. In addition, the criteria of eligibility for redevelopment assistance projects has been clarified in House Bill 1676, which is also before me for signature. Many of the projects in Section 8 do not meet these criteria.

(2) Several of the projects do not meet the \$100,000 minimum in order to qualify for bond funding as required by the Capital Facilities Debt Enabling Act.

(3) Certain projects are maintenance or repair in nature, the purpose of which is to preserve or restore existing assets rather than make an improvement or betterment to it and, as such, cannot be bond funded.

(4) Certain projects are listed at higher amounts than are necessary to undertake the project. In those cases I have reduced them to an amount sufficient to allow them to be completed.

(5) The approved amounts for certain higher education projects assume that a portion of total project costs will be met from non-State sources.

(6) Certain projects are not of a sufficiently high priority to warrant the further indebtedness needed for their funding if we are to operate in a fiscally responsible manner.

House Bill 383, as it was presented to me, authorized \$1,593,099,000 in projects in all categories combined. It is not reasonable to expect that all these projects could be undertaken. The Commonwealth cannot afford such an increase in indebtedness and retain the fiscally responsible position which this Administration has worked toward achieving. The recent improvement in our bond ratings has been a direct result of this fiscal responsibility and our efforts to reduce the outstanding bonded indebtedness of the Commonwealth. To approve a bill authorizing such massive increases is in direct conflict with all these efforts throughout the past seven years.

Further, the Commonwealth already has a backlog of projects which has been authorized by the General Assembly in previous capital budgets. The current backlog of projects in the public improvement category which has not yet been awarded for construction amounts to approximately \$595 million. The approved projects contained in House Bill 383 will increase this existing backlog.

I have approved those projects in the Redevelopment Assistance section of the bill (Section 8) which comply, and only to the extent that they comply, with the eligibility criteria contained in House Bill 1676, Printer's No. 3873. These projects can only be funded to the extent that debt service on bonds issued for the projects can be met by the Redevelopment Assistance Sinking Fund established by that bill.
