AN ACT

Appropriating to the Department of Health certain moneys received and to be received from the United States Government for the care and treatment of certain discharged, sick, and disabled soldiers and sailors and marines.

Department of Health.

Section 1. Be it enacted, &c., That all moneys heretofore or hereafter received by the State Treasurer from the United States Government in payment of the cost of the care and treatment of sick and disabled soldiers, sailors, and marines, placed by the United States Government in State institutions under the control of the Department of Health, are hereby appropriated to the State Department of Health, shall be credited by him to the Tuberculosis Fund of the said department, and shall be paid out of the State Treasury in the same manner as other appropriations to the State Department of Health are paid.

AN ACT

Authorizing the State Treasurer to appoint a Deputy State Treasurer and Commissioner of Trusts; defining his powers and duties; providing for the care, custody, safe-keeping, and recording of stocks, bonds, mortgages, securities, and indemnity bonds, held in trust or otherwise, or owned by the Commonwealth or by any of the departments, bureaus, divisions, commissions, or agencies thereof; and fixing his salary.

Section 1. Be it enacted, &c., That the State Treasurer is authorized to appoint a Deputy State Treasurer, who shall also be a Commissioner of Trusts. The Deputy State Treasurer and Commissioner of Trusts shall, before he enters upon the duties of his office, take and subscribe the oath of office prescribed by the Constitution, and shall file with the Secretary of the Commonwealth a bond with corporate surety, to be approved by the Attorney General, in the penal sum of five hundred thousand dollars (\$500,000). The premium thereof shall be paid by the Commonwealth. The Deputy State Treasurer and Commissioner of Trusts shall receive a salary of eight thousand dollars (\$8,000) per annum, together with all expenses necessarily incurred in the performance of his duties. All clerical assistance necessary for carrying into effect the provisions of this act shall be assigned to the Deputy State Treasurer and Commissioner of Trusts by the State Treasurer.

Section 2. The Deputy State Treasurer and Commissioner of Trusts, under the supervision of the State Treasurer, shall inaugurate, install and keep a system of books, wherein all stocks, mortgages, bonds, and other valuable securities and all indemnity bonds, held by the Commonwealth or any of its departments or agencies, in trust or as security or otherwise, shall be clearly indexed and described as to character, value, and ownership.

Section 3. It shall be the duty of the head of every department, bureau, division, commission, or other governmental agency of the Commonwealth, holding bonds given to indemnify the Commonwealth from any obligation, or given for the faithful performance of any obligation or contract, or given for the faithful accounting or return of moneys lodged with the obligor by the Commonwealth or any of its officers, or given for the purpose of securing the execution of an obligation the supervision of which falls within the jurisdiction of any department, bureau, division, commission or agency of the Commonwealth, or any bonds given in which the Commonwealth is in any manner
