## AN ACT

To amend section fourteen of an act, approved the twenty-first day of July, one thousand nine hundred and nineteen (Pamphlet Laws, one thousand seventy-seven), entitled "An act to provide for the administration of the Workmen's Compensation Act of one thousand nine hundred fifteen by creating the Bureau of Workmen's Compensation of the Department of Labor and Industry; providing for the establishment of the Workmen's Compensation Board to have charge of such bureau; authorizing the division of the Commonwealth into workmen's compensation districts, and the appointment of workmen's compensation referees; defining the powers and duties of the Commissioner of Labor and Industry, the Bureau of Workmen's Compensation, the Workmen's Compensation Board, the workmen's compensation referees and the factory inspectors of the Department of Labor and Industry, in enforcing the said act; and fixing the salaries of the members of the Workmen's Compensation Board, the workmen's compensation referees, and certain of their employes and assistants; and repealing certain acts."

Workmen's Compensation Board.

Section 1. Be it enacted, &c., That section fourteen of the act, approved the twenty-first day of July, one thousand nine hundred and nineteen (Pamphlet Laws, one thousand seventy-seven), entitled "An act to provide for the administration of the Workmen's Compensation Act of one thousand nine hundred fifteen by creating the Bureau of Workmen's Compensation of the Department of Labor and Industry; providing for the establishment of the Workmen's Compensation Board to have charge of such bureau; authorizing the division of the Commonwealth into workmen's compensation districts, and the appointment of workmen's compensation referees; defining the powers and duties of the Commissioner of Labor and Industry, the Bureau of Workmen's Compensation, the Workmen's Compensation Board, the workmen's compensation referees and the factory inspectors of the Department of Labor and Industry, in enforcing the said act; and fixing the salaries of the members of the Workmen's Compensation Board, the workmen's compensation referees, and certain of their employes and assistants; and repealing certain acts," which reads as follows:-

"Section 14. The salary of each member of the board shall be seven thousand dollars per annum, except that of the chairman, which shall be seven thousand five hundred dollars per annum.

The salary of each referee shall be five thousand dollars per annum.

The salary of the supervisory referee shall be six thousand dollars per annum.

The salaries of the attorneys shall not in the aggregate exceed the sum of twelve thousand dollars per annum.

The salary of each physician shall be three thousand dollars per annum.

Section 14, act of July 21, 1919 (P. L. 1077), cited for amendment.

The salary of the secretary shall be five thousand dollars per annum.

The salary of the assistant secretary shall be three thousand dollars per annum.

The salary of the actuary shall be five thousand dollars per annum.

The salary of the Director of the Bureau of Workmen's Compensation shall be four thousand five hundred dollars per annum.

The salary of the Assistant Director of the Bureau of Workmen's Compensation shall be four thousand dollars per annum.

The salary of the chief adjuster shall be three thou-

sand dollars per annum.

The salary of the chief clerk of the Exemption and Insurance Division shall be three thousand dollars per annum.

The salary of the chief clerk of the Division of Accident Reports shall be two thousand five hundred dollars per annum.

The salary of the chief clerk of the Division of Agreements and Receipts shall be two thousand five hundred dollars per annum.

The salary of the appeal clerk shall be two thousand

dollars per annum.

The salary of the sergeant-at-arms shall be one thousand eight hundred dollars per annum.

The salary of the clerk to the chairman shall be two thousand dollars per annum.

The salary of the clerk for each referee shall be one thousand eight hundred dollars per annum.

The salary of the stenographer for each member of the board shall be one thousand eight hundred dollars per annum," is hereby amended to read as follows:-

sand dollars per annum.
