Chester and Darby Turnpike where said Turnpike crosses Crum Lynne Creek.

Route Five Hundred and Forty-three. Beginning at the intersection of Route One Hundred Forty-two and Old Eagle School or Valley or Port Kennedy Road; thence along the said Old Eagle School or Valley or Port Kennedy Road to where it intersects and meets the State or Centerville Road, known as Route One Hundred Forty-three, in the County of Chester.

Route Five Hundred and Forty-four. Beginning at the intersection of Port Kennedy Road or King-of-Prussia Road and Gulph Road; thence along the said Gulph Road to where the said Gulph Road meets the Phoenixville, Valley Forge, Port Kennedy, and Bridgeport Roads, or the Highway Route Two Hundred and One, in the Counties of Chester and Montgomery.

Section 2. After May thirty-first, one thousand nine hundred and twenty-six, the cost and expense of maintenance, construction, and improvement of all the highways herein described shall be paid out of moneys appropriated to the State Highway Department for the maintenance, reconstruction, or improvement of State Highways: Provided, however, That routes contained in this act which are now toll roads may be taken over and maintained, constructed, and improved by the State Highway Department at any time prior to May thirty-first, one thousand nine hundred and twenty-six.

AN ACT

To amend section one of an act, approved the eleventh day of April, one thousand eight hundred and sixty-six (Pamphlet Laws, ninety-nine), entitled "A supplement to an act, approved the twenty-seventh day of February, Anno Domini one thousand eight hundred and sixty-five (Pamphlet Laws, two hundred fifty-five), entitled 'An act empowering railroad companies to employ police force,'" by extending the same to certain other companies.

Police force, employment of, by corporations.

Section 1 of act of Feb. 27, 1865 (P. L. 225), amended. Section 1. Be it enacted, &c., That section one of the act, approved the eleventh day of April, one thousand eight hundred and sixty-six (Pamphlet Laws, ninety-nine), entitled "A supplement to an act. approved the twenty-seventh day of February, Anno Domini one thousand eight hundred and sixty-five (Pamphlet Laws, two hundred fifty-five), entitled 'An act empowering railroad companies to employ police force,'" is hereby amended to read as follows:

Date effective.

Section 1. Be it enacted, &c., That the provisions Act extended to of the act of the twenty-seventh of February, in the year of our Lord one thousand eight hundred and sixty-five, entitled "An act empowering railroad companies to employ police force," be and the same are hereby extended to embrace all corporations, firms, or individuals, owning, leasing, or being in possession of, any colliery, furnace, or rolling mill, and all water companies, water supply companies, water power companies, electric light companies, electric power companies, electric transmission companies, mineral mining and quarrying companies, and express companies, within this Commonwealth; and that, upon the application of any such corporation, firm, or individual, the Governor may appoint and commission policemen, under the provisions of the act, to which this is a supplement: Provided, That the words, "coal and iron police," "water police," "electric power police," or "mine and quarry police," "express police," as the case may be, shall be engraved upon the shields, to be worn by the policemen, appointed under this act, instead of the words, "railway police," as provided by the act, to which this is a supplement: And provided further, That the Governor shall have power to decline to make any such appointment, sought to be commission. made, under the provisions of this supplement, whenever the circumstances of the case, in his opinion, do not require it, and at any time, to revoke the commission of any policeman appointed hereunder.

AN ACT

To provide for a second additional law judge of the court of common pleas of the Fourteenth Judicial District.

Section 1. Be it enacted, &c., That in addition to the Fourteenth Judicial District. judges provided for by existing law, a second additional law judge is hereby authorized and provided law judge. for the court of common pleas of the Fourteenth Judicial District, who shall possess the same qualifications which are required by the Constitution and laws for the president judge of said district, and who shall hold his office for a like term and by the same tenure, and shall have the same powers, authority, and jurisdiction, and shall be subject to the same duties, restrictions, and penalties, and shall receive the same compensation provided by law for judges of the courts of said judicial district.
