AN ACT

Authorizing the Governor to appoint a commission for further study of the subject of old age pensions, and making an appropriation.

Old age pensions.

Commission to be appointed.

Appropriation.

Section 1. Be it enacted, &c., That the Governor is hereby authorized and directed to appoint a commission to consist of five reputable citizens of Pennsylvania, who shall serve without compensation other than for their reasonable expenses, to make further study of the subject of old age pensions with special reference as to the advisability and practicability of a contributory system as against the straight pension idea, and to secure all the available facts as to the actual working out of these plans in this country and abroad, in order to give to the people of this Commonwealth the most complete information possible regarding the subject; said commission to make its report to the Legislature not later than January fifteenth, one thousand nine hundred and twenty-seven. Said commission shall formulate such plans and shall employ such assistance as may seem desirable to its membership, and an appropriation of twenty thousand dollars (\$20,000), or so much thereof as may be necessary, is hereby specifically made for the purpose of carrying out the work of said commission.

A JOINT RESOLUTION

Continuing the committee to study and investigate systems of compulsory liability insurance for motor vehicles.

Section 1. Be it resolved by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, That the committee created by concurrent resolution of the General Assembly of the session of one thousand nine hundred and twenty-three, Number Eighty-seven, approved by the Governor on the eighteenth day of June, one thousand nine hundred and twenty-three, and printed in the Pamphlet Laws of one thousand nine hundred and twenty-three on page one thousand one hundred and eight, to make a complete study and investigation of

all existing systems of compulsory liability insurance for motor vehicles and motor vehicle owners or drivers, is hereby continued for a further period of two years. Section 2. Any unexpended balance of any appropriation made to said committee by the General Assembly at the session of one thousand nine hundred priated. and twenty-three is hereby reappropriated to said committee for the two fiscal years commencing June first, one thousand nine hundred and twenty-five.

To further amend section two of the act, approved the fifth day of March, one thousand nine hundred and six (Pamphlet Laws, sixty-three), entitled "An act to provide for the personal regis-tration of electors in cities of the third class of this Common-wealth, to make such registration a condition of the right to vote in such cities, and to provide penalties for violation of its provisions," by changing the compensation of registrars.

Section 1. Be it enacted, &c., That section two of the act, approved the fifth day of March, one thousand nine hundred and six (Pamphlet Laws, sixty-three), entitled "An act to provide for the personal registration of electors in cities of the third class of this Commonwealth, to make such registration a condition of the right to vote in such cities, and to provide penalties for violation of its provisions," which was amended by section one of the act, approved the twenty-fifth day of May, one thousand nine hundred and seven (Pamphlet Laws, two hundred fifty-one), entitled "An act amending sections three, seven, twelve, and thirteen of an act, entitled 'An act to provide for the personal registration of electors in cities of the third class of this Commonwealth, to make such registration a condition of the right to vote in such cities, and to provide penalties for violation of its provisions,' approved the fifth day of March, Anno Domini one thousand nine hundred and six; increasing the compensation of registrars in said cities, and providing for an additional registra-tion day," is hereby further amended to read as follows:
