Commencing at the termination of Seventeenth Street in the City of Chester; and running thence across Ridley Creek into Ridley Township; and thence to Bullens Lane; thence north across private property to Crum Creek Bridge; thence easterly by Third Avenue to Parker Avenue in the Borough of Collingdale, to the intersection of Parker Avenue at the Chester Pike.

Route seven hundred and thirty-five. Commencing at a point where the Penowa-Ohio River road intersects the State line in the county of Washington; and running thence by way of Penowa and Avella to a point in State highway route number two hundred and forty-two at the Manchester Schoolhouse.

Route seven hundred and thirty-six. Commencing at the county line of the Counties of Allegheny and Washington at Floreffe; and running thence by way of Elrama, Shire Oaks, Coal Bluff, and Courtney to New Eagle Borough, and intersecting with State highway route number two hundred and forty-seven.

Commencing at a Route 741. point on Brown Avenue in the Borough of Turtle Creek, Allegheny County, on the boundary line between the borough of Turtle Creek and Wilkins Township; thence in a northwesterly direction, by way of Beulah road, paralleling Saw Mill Run, to State highway route number one hundred and eighty-seven at or near the Beulah Presbyterian Church.

Commencing at the public school building in the village of Linhart in Wilkins Township, Allegheny County; thence in a northeasterly direction, following the stream of Thompson Run, crossing and recrossing the dividing lines of Wilkins township and Patton township, to State highway route number one hundred and eigh'ty-seven, near the Union Railroad right of way, at or near the line dividing the township of Patton and the township of Penn.

Route seven hundred and forty-five. Commencing at State highway route number one hundred and eighty-seven near the Union Railroad right of way at or near the line dividing the township of Penn and the township of Patton in Allegheny County; thence, in a northerly direction in Penn township, to improved highway known as Universal Road in the village of Universal, near State highway route number two hundred and twenty-eight.

Section 2. After July first, one thousand nine hundred Effective date. and twenty-eight, the cost and expense of maintenance, construction, and improvement of all the highways herein described, shall be paid out of moneys appropriated to the State Highway Department for the maintenance, reconstruction, or improvement of State highways: Provided, Proviso. however, That any route contained in this act, which leads into a new industrial community, may be constructed, reconstructed, or improved prior to July first, one thousand nine hundred and twenty-eight, if the State Highway Department, in its discretion, considers such improvement necessary.
