AN ACT

Fixing the pay of election officers and clerks appointed by the inspectors, except in cities of the first class and counties of the second class.

Section 1. Be it enacted, &c., That the minimum pay of all judges of election, inspectors of election, and clerks, appointed by inspectors, except in cities of the first class and counties of the second class, is hereby fixed at five dollars per day. In any such election district, where more than one hundred votes are cast at any election, the judge and each inspector and clerk shall be paid one dollar, for each one hundred ballots, or fractional part thereof, cast after the first one hundred ballots, in addition to the minimum pay herein provided for: Provided, That ten dollars Proviso. per day shall be the maximum pay allowed under this act.

Section 2. The act, approved the fifth day of July, one thousand nine hundred and seventeen (Pamphlet Laws, six hundred eighty-four), entitled "An act fixing the pay of election officers," and its amendment approved the eighth day of May, one thousand nine hundred and nineteen (Pamphlet Laws, one hundred fifteen), entitled "An act to amend an act, approved the fifth day of July, one thousand nine hundred seventeen (Pamphlet Laws, six hundred eighty-four), entitled 'An act fixing the pay of election officers,' and also clerks appointed by the inspectors," be and the same are hereby repealed.

To amend section four of article fourteen of an act, approved the seventh day of March, one thousand nine hundred and one (Pamphlet Laws, twenty), entitled "An act for the government of cities of the second class," as amended, fixing the maximum compensation of councilmen.

Cities of second class.

Section 4 of article 14 of act of March 7, 1901 (P. L. 20), as amended by act of May 31, 1911 (P. L. 461), further amended.

Section 1. Be it enacted, &c., That section four of article fourteen of an act, approved the seventh day of March, one thousand nine hundred and one (Pamphlet Laws, twenty), entitled "An act for the government of cities of the second class," which was amended by the act, approved the thirty-first day of May, one thousand nine hundred and eleven (Pamphlet Laws, four hundred and sixty-one), entitled "An act amending and supplementing article fourteen of an act, entitled 'An act for the government of cities of the second class.' approved the seventh day of March, Anno Domini one thousand nine hundred and one, as same was amended and supplemented by an act, approved the twentieth day of June, Anno Domini one thousand nine hundred and one; by abolishing the present select and common councils; providing a new body to be known as the council, and fixing their terms of office; and providing for the selection of members of council, prescribing the qualifications of members thereof, their powers and duties, and fixing their salaries," is hereby further amended to read as follows:

Section 4. Said councilmen shall receive for their services during their term of service annual salaries, to be fixed by ordinance, payable in monthly instalments: Provided, however, The same shall not be less than two thousand dollars nor exceed [six thousand five hundred] *eight thousand* dollars per annum, and that councils shall, by the ordinance fixing said salaries, provide for the assessment and retention therefrom of reasonable fines for absence from regular or special meetings of council or councilmanic committees.
