

tion to duty should be made as an inspiration for similar service by future generations; therefore,

Section 1. Be it enacted, &c., That a commission consisting of the Auditor General, the State Treasurer, and five citizens of the Commonwealth to be appointed by the Governor, within thirty days from the passage of this act, is hereby created and authorized and directed to procure a suitable statue to commemorate the services of the colored soldiers from the Commonwealth who served in the Civil War, the Spanish-American War, and the World War, or in any other war in which the United States has been engaged, and cause the same to be erected in the city of Philadelphia, on a suitable site to be selected by such commission, and provide for the dedication thereof in a fitting manner.

Section 2. The said commission shall organize within fifteen days after their appointment. The members of the commission shall serve without compensation, but shall be allowed their actual traveling expenses necessarily incurred in the performance of their duties.

Section 3. The sum of sixty thousand (\$60,000) dollars, or so much thereof as may be necessary, is hereby specifically appropriated for the procuring and erection and dedication of the said statue, including the expenses of the commission.

Section 4. After the dedication of said statue the Pennsylvania Historical Commission in the Department of Public Instruction shall assume and be charged with the care and maintenance thereof.

Approved—The 4th day of May, A. D. 1927, in the sum of \$50,000. I withhold my approval from the remainder of said appropriation because of insufficient State revenue.

AN ACT

Making an appropriation to the Public Service Commission of the Commonwealth of Pennsylvania to be used by said commission in the payment of the cost of the construction, reconstruction, relocation, alteration, or abolition of any crossing of the tracks of railroad corporations or street railways corporations at, above, or below grade of public highways, exclusive of State highways designated as primary routes; and regulating the expenditure of the amount hereby appropriated.

Section 1. Be it enacted, &c., That the sum of two hundred and fifty thousand dollars (\$250,000), or so much thereof as may be necessary, be and the same is specifically appropriated, out of the Motor License Fund, to the Public Service Commission of the Commonwealth of Pennsylvania for the two fiscal years commencing on the first day of June, one thousand nine hundred and twenty-seven, for the purpose of the payment of such proportion of the cost of the construction, reconstruction, relocation, alteration, or abolition of any crossing of the tracks of railroad corpora-

tions or street railway corporations at, above, or below grade of public highways other than those State highways designated as primary routes, as shall be determined by the Public Service Commission of the Commonwealth of Pennsylvania, to be paid by the Commonwealth: Provided, That this appropriation shall not limit the power of the Public Service Commission of the Commonwealth of Pennsylvania to direct payment by the Commonwealth of a portion of the cost of the construction, reconstruction, relocation, alteration, or abolition of any crossing of the tracks of a railroad corporation or a street railway corporation over State highways, conferred upon it by the act, approved July twenty-six, one thousand nine hundred and thirteen (Pamphlet Laws, one thousand three hundred and seventy-four), and the amendments thereto.

Section 2. The amounts payable hereunder shall, in each instance, be paid by the State Treasurer, out of the Motor License Fund, on a warrant drawn by the Auditor General upon the presentation to that officer of a certificate signed by the Chairman of the Public Service Commission of the Commonwealth of Pennsylvania, setting forth the amount to be paid as aforesaid and whether said sum is the entire amount assessed upon the Commonwealth or the portion of said sum is the entire amount due and payable at the date of said certificate.

Section 3. In no case shall the Public Service Commission of the Commonwealth of Pennsylvania authorize the payment out of the amount herein appropriated of more than fifty percent (50%) of the cost, including the compensation due to adjacent property owners, of any construction, reconstruction, location, alteration, or abolition of a crossing at, above, or below grade, including the approaches to any overhead or underpass structure in connection therewith.

AN ACT

Making an appropriation out of the Motor License Fund to the Board of Finance and Revenue, for the payment of the loan and transfer agent of the Commonwealth.

Section 1. Be it enacted, &c., That the sum of thirty thousand dollars (\$30,000), or so much thereof as may be necessary, is hereby specifically appropriated out of the Motor License Fund to the Board of Finance and Revenue, for the two fiscal years commencing June first, one thousand nine hundred and twenty-seven, for the payment of the compensation to the Commonwealth's loan and transfer agent for services rendered in connection with the registration, transfer, and payment of interest on highway bonds, and for other services required to be performed by the said loan and transfer agent. Payments from such appropriation shall be made at such time and in such amounts and upon such basis as may be provided by law or agreed upon between the

Board of Finance and Revenue and the said loan and transfer agent.

AN ACT

Making an appropriation of moneys in the Motor License Fund to meet sinking fund requirements of the State Bond Road Sinking Fund.

Section 1. Be it enacted, &c., That the sum of fourteen million seventy-six thousand fifty-two dollars and eighty-eight cents (\$14,076,052.88) is hereby specifically appropriated from moneys in the Motor License Fund for payment into the State Bond Road Sinking Fund to meet sinking fund requirements for the two fiscal years commencing June first, one thousand nine hundred and twenty-seven. The amount hereinbefore appropriated shall be transferred by the Auditor General and State Treasurer from the Motor License Fund to the State Bond Road Sinking Fund on or before the dates, and in the amounts, set forth in the following schedule:

AN ACT

Making an appropriation for the purchase of copies of the history of the Twenty-eighth Division during the World War, and providing for the distribution thereof by the Governor.

Whereas, A history of the Twenty-eighth Division, being a record of the National Guard of Pennsylvania since its organization, has been published by the Twenty-eighth Division Publishing Company, in five volumes, which was edited by Colonel Edward Martin, who was appointed as historian by the commanding general of the Twenty-eighth Division during the World War, and by associates from the several units composing said division; and

Whereas, It is eminently fitting and proper that copies of this history should be available for distribution among the several American Legion Posts and Posts of the Veterans of Foreign Wars, of Pennsylvania, State armories, United States hospitals in Pennsylvania, high schools, approved libraries, colleges, educational State institutions, and historical societies; therefore,

Section 1. Be it enacted, &c., That the sum of thirty-six thousand dollars (\$36,000), or so much thereof as may be necessary, is hereby specifically appropriated for the purchase of as many copies of said history as may be necessary to make the distribution hereinafter provided, at a cost not to exceed forty dollars for each set of five volumes. Such copies, when published and purchased, shall be furnished to the Governor of the Commonwealth and shall be by him distributed to the American Legion Posts and Posts of the Veterans of Foreign Wars, of Pennsylvania, State armories, United States hospitals in Pennsylvania, high schools, normal schools, to such libraries, colleges, educational institutions and historical societies as may be approved by the Governor which have not already received copies of said history from the Commonwealth, and one set each to the Governor and heads of the various departments of the State Government, and one set each to Senators and Members of the General Assembly of Pennsylvania, session of one thousand nine hundred and twenty-seven, for further distribution within their respective districts.

AN ACT

Making an appropriation to the Department of Justice to refund moneys erroneously paid into the State Treasury for the maintenance of William B. Weiss at the Farview State Hospital.

Section 1. Be it enacted, &c., That the sum of two hundred and thirty-seven dollars and eleven cents (\$237.11) is hereby specifi-

cally appropriated to the Department of Justice for the purpose of refunding to Mrs. Mary E. Weiss Dahl, mother of William B. Weiss, an inmate of the Farview State Hospital, moneys erroneously paid into the State Treasury for the maintenance of the said William B. Weiss in said State hospital. Payments from said appropriation shall be made to the person entitled thereto on requisition of the Attorney General, upon proof filed to the satisfaction of the Attorney General that such erroneous payment was actually made.

AN ACT

Making an appropriation to the Department of Forests and Waters to continue the Pymatuning Swamp project and the purchase of land therefor.

Section 1. Be it enacted, &c., That the sum of three hundred and fifty thousand dollars (\$350,000), or so much thereof as may be necessary, is hereby specifically appropriated to the Department of Forests and Waters for the purchase of lands in Crawford County for the purpose of establishing a reservoir and conserving the water entering the Pymatuning Swamp, and to regulate the flow thereof, in accordance with the provisions of the act, approved the thirteenth day of May, one thousand nine hundred and twenty-five (Pamphlet Laws, six hundred fifty-two), entitled "An act authorizing the Department of Forests and Waters, through the Water and Power Resources Board, to complete the work begun and continued under an act, approved the twenty-fifth day of July, one thousand nine hundred and thirteen (Pamphlet Laws, one thousand two hundred seventy), entitled An act providing for the erection of a dam at the outlet of Pymatuning Swamp, and the establishment of a reservoir to conserve the waters thereof; providing for the taking of land and materials necessary thereto; vesting certain powers and duties in the Water Supply Commission; and making an appropriation, and its amendments and supplements; and making an appropriation for such purpose." Payments from said appropriation shall be made on requisition of the Secretary of Forests and Waters by warrant of the Auditor General, in the manner provided by law.

AN ACT

Making an appropriation to the Lake Erie and Ohio River Canal Board of Pennsylvania, for the payment of expenses incurred in printing, distributing, and making available for public use reports, maps, documents, and records of the board in securing the cooperation and aid of the Government of the United States and other public authorities in the construction of the canal or waterway authorized to be constructed by the board; for the payment of incidental office expense, and for the payment of salaries, fees, and expenses.

Section 1. Be it enacted, &c., That there is hereby specifically appropriated to the use of the Lake Erie and Ohio River Canal Board of Pennsylvania the sum of five thousand dollars (\$5,000), or so much thereof as may be necessary, for the two fiscal years beginning June first, one thousand nine hundred and twenty-seven, for the payment of expenses incurred in printing, distributing, or otherwise making available for public use reports, maps, documents, and records issued by or in possession of the board; for the payment of expenses incurred in doing such things as the board may deem expedient to secure the cooperation and aid of the Government of the United States and other public authorities in the construction of the canal or waterway authorized to be constructed by the said act; and for the payment of expenses incidental to the maintenance of the offices of the board in the city of Pittsburgh, the traveling expenses of the board, and any of its officers or employes; and the payment of the salaries, fees, and expenses of such engineers, draftsmen, attorneys, experts, and clerical assistance as the board may employ.

AN ACT

Making an appropriation to the Pennsylvania State Park and Harbor Commission, of Erie.

Section 1. Be it enacted, &c., That the sum of fifty thousand dollars (\$50,000), or so much thereof as may be necessary, is hereby specifically appropriated to the Pennsylvania State Park and Harbor Commission, of Erie, for the two fiscal years beginning June first, one thousand nine hundred and twenty-seven, for the payment of salaries, wages, and other compensation of employes, office rents, planting trees, clearing trails, constructing roads, bath-houses, camp sites, park gates, and docks, the purchase of necessary supplies, materials, and equipment, and for the expense of the members of the commission and its employes,

including postage, freight, telegrams, telephone toll charges, and for other incidental expenses.

AN ACT

Making an appropriation to the Pennsylvania State Park and Harbor Commission, of Erie, Pennsylvania, to build jetties and works for the protection of Presque Isle Peninsula and the peninsular highway.

Section 1. Be it enacted, &c., That the sum of eighty thousand (\$80,000) dollars, or so much thereof as is necessary, is hereby specifically appropriated to the Pennsylvania State Park and Harbor Commission, of Erie, Pennsylvania, for the purpose of building jetties and other necessary works to protect the Presque Isle Peninsula and the peninsular highway at Erie from erosion by storms. Payment from said appropriation shall be made on requisition of the chairman of the commission by warrant of the Auditor General on the State Treasurer in the manner provided by law.

AN ACT

Making an appropriation to the Valley Forge Park Commission.

Section 1. Be it enacted, &c., That the sum of ninety thousand dollars (\$90,000), or so much thereof as may be necessary, is hereby specifically appropriated to the Valley Forge Park Commission for the two fiscal years beginning June first, one thousand nine hundred and twenty-seven, for the payment of salaries, wages, and other compensation of such superintendents, guards, wardens, and workmen as may be needed for the repair and construction of roads, removal or improvement of buildings, grading, seeding, mowing, planting, and other work necessary in the care, preservation, and maintenance of Valley Forge Park; for the expenses of the members of the commission, its officers and employes, including office rent, freight, postage, telegrams, telephone charges, and other incidental expenses; for the purchase of fertilizers, seeds, weed-killers, flags, markers, trucks, mowers, fuel, and other material, equipment, and supplies necessary in the development and improvement of the park.

AN ACT

Making an appropriation to the Washington Crossing Park Commission for the purpose of paying for land heretofore condemned and designated as a part of Washington Crossing Park, and the making of improvements in accordance with the provisions of the act of July twenty-fifth, one thousand nine hundred and seventeen (Pamphlet Laws, one thousand two hundred and nine), entitled "An act to authorize the acquisition, by purchase or condemnation, of land for a park, and the erection of a monument commemorative of Washington crossing the river Delaware, and for the appointment of a commission to acquire said lands and erect such monument; and making an appropriation for the purpose of this act."

Section 1. Be it enacted, &c., That the sum of one hundred and twenty-five thousand dollars (\$125,000), or so much thereof as may be necessary, is hereby specifically appropriated for the two fiscal years beginning June first, one thousand nine hundred and twenty-seven, to the Washington Crossing Park Commission, constituted and appointed under the provisions of the act of the twenty-fifth day of July, one thousand nine hundred and seventeen (Pamphlet Laws, one thousand two hundred and nine), entitled "An act to authorize the acquisition, by purchase or condemnation, of lands for a park and the erection of a monument commemorative of Washington crossing the River Delaware, and for the appointment of a commission to acquire said lands and erect such monument, and making an appropriation for the purpose of this act," for the following purposes, namely:

For the payment of salaries, wages, or other compensation of necessary employes in the maintenance and improvement of Washington Crossing Park and the buildings thereon; for the purchase of materials, tools, trucks, flags, monuments, and markers, equipment and other supplies; and for the expenses of the members of the commission and its employes, including printing, photographing, distribution, or in otherwise making available for public use maps, documents, records, historical information and reports issued by or in the possession of the commission, the sum of one hundred thousand dollars (\$100,000), or so much thereof as may be necessary.

For the payment of the purchase price and awards of juries of view, with the costs and interest accruing thereon, for the land heretofore condemned and designated as a part of Washington Crossing Park, the sum of twenty-five thousand dollars (\$25,000), or so much thereof as may be necessary.

AN ACT

Making an appropriation to the Conrad Weiser Memorial Park Association to assist in the development of the Conrad Weiser Memorial Park, near Womelsdorf, Berks County.

Section 1. Be it enacted, &c., That the sum of twenty thousand dollars (\$20,000), or so much thereof as may be necessary, is hereby specifically appropriated to the Conrad Weiser Memorial Park Association, of Reading, for the purpose of assisting said association in the development of the Conrad Weiser Park, near Womelsdorf, Berks County, and for the completion of roads, paths, and a pool, for grading, shrubbery and trees, lawn, grass and planting, for removal or repair of the stone house, the erection of a comfort station and plumbing, for lighting equipment, granite stone and other stone, and cement, and for drayage and trucking. Payment from said appropriation shall be made on requisition of the association by warrant of the Auditor General on the State Treasurer, in the manner provided by law.

Making an appropriation to the Board of Trustees of Ashland State Hospital.

Section 1. Be it enacted, &c., That the sum of four hundred and ten thousand dollars (\$410,000), or so much thereof as may be necessary, is hereby specifically appropriated to the Board of Trustees of Ashland State Hospital for the two fiscal years beginning June first, one thousand nine hundred and twenty-seven, for the following purposes, namely:

The sum of two hundred forty-five thousand dollars (\$245,000), or so much thereof as may be necessary, for maintenance, including salaries, wages, or other compensation of a superintendent, assistants, and employes, cost of supplies, equipment, repairs, postage, expressage, telephone rentals, toll charges, and such other expense of every kind and description as may be necessary for the proper conduct of the work of the board and the operation of the institution.

The sum of thirty thousand dollars (\$30,000), or so much thereof as may be necessary, for carrying out the recommendations of the Department of Labor and Industry for the elimination of hazardous conditions, repairs and improvements of buildings and equipment, renovation of kitchen, equipment for laundry and kitchen, painting of buildings, and the purchase of a motor bus and truck.

The sum of one hundred and thirty-five thousand dollars

(\$135,000), or so much thereof as may be necessary, for the construction and equipment of an addition to the nurses' home.

Making an appropriation to the Board of Trustees of Blossburg State Hospital.

Section 1. Be it enacted, &c., That the sum of one hundred and ten thousand dollars (\$110,000), or so much thereof as may be necessary, is hereby specifically appropriated to the Board of Trustees of Blossburg State Hospital for the two fiscal years beginning June first, one thousand nine hundred and twenty-seven, for the following purposes, namely:

The sum of one hundred thousand dollars (\$100,000), or so much thereof as may be necessary, for maintenance, including salaries, wages, or other compensation of a superintendent, assistants, and employes, cost of supplies, equipment, repairs, postage, expressage, telephone rentals, toll charges, and such other expense of every kind and description as may be necessary for the proper conduct of the work of the board and the operation of the institution.

The sum of ten thousand dollars (\$10,000), or so much thereof as may be necessary, for installation of a telephone switchboard and service sanitary flooring in hospital building, construction of garage, improvement of grounds, purchase of nurses' training school library books, and major repairs and replacements.

Making an appropriation to the Board of Trustees of the Coaldale State Hospital.

Section 1. Be it enacted, &c., That the sum of three hundred and sixty thousand dollars (\$360,000), or so much thereof as may be necessary, is hereby specifically appropriated to the Board of Trustees of Coaldale State Hospital for the two fiscal years beginning June first, one thousand nine hundred and twenty-seven, for the following purposes, namely:

The sum of one hundred and fifty thousand dollars (\$150,000),

or so much thereof as may be necessary, for maintenance, including salaries, wages, or other compensation of a superintendent, assistants, and employes, cost of supplies, equipment, repairs, postage, expressage, telephone rentals, toll charges, rental of accommodations for nurses, and such other expense of every kind and description as may be necessary for the proper conduct of the work of the board and the operation of the institution.

The sum of seventy thousand dollars (\$70,000), or so much thereof as may be necessary, to continue alterations to and renovation of the old hospital building, including the elimination of hazardous conditions as recommended by the Department of Labor and Industry, repairs to buildings and equipment, including painting and refinishing of walls, installation of emergency lighting system, improvements of grounds and roadways, purchase of an incinerating plant, and general repairs and replacements.

The sum of one hundred and forty thousand dollars (\$140,000), or so much thereof as may be necessary, for the construction and equipment of a nurses' home and the completion and equipment of basement rooms in the hospital annex.

Making an appropriation to the Board of Trustees of the Connellsville State Hospital.

Section 1. Be it enacted, &c., That the sum of eighty-nine thousand five hundred dollars (\$89,500), or so much thereof as may be necessary, is hereby specifically appropriated to the Board of Trustees of Connellsville State Hospital for the two fiscal years beginning June first, one thousand nine hundred and twenty-seven, for the following purposes, namely:

The sum of thirty-five thousand dollars (\$35,000), or so much thereof as may be necessary, for maintenance, including salaries, wages, or other compensation of a superintendent, assistants, and employes, cost of supplies, equipment, repairs, postage, expressage, telephone rentals, toll charges, rental of accommodations for nurses, and such other expense of every kind and description as may be necessary for the proper conduct of the work of the board and the operation of the institution.

The sum of four thousand five hundred dollars (\$4,500) or so much thereof as may be necessary, for the reconstruction and equipment of laundry and improvement of grounds.

The sum of fifty thousand dollars (\$50,000), or so much thereof as may be necessary, for the furnishing and equipment of a new hospital building now under construction.

Making an appropriation to the Board of Trustees of the Hazleton State Hospital.

Section 1. Be it enacted, &c., That the sum of two hundred and twenty thousand dollars (\$220,000), or so much thereof as may be necessary, is hereby specifically appropriated to the Board of Trustees of Hazleton State Hospital for the two fiscal years beginning June first, one thousand nine hundred and twenty-seven, for the following purposes, namely:

The sum of one hundred and ten thousand dollars (\$110,000), or so much thereof as may be necessary, for maintenance, including salaries, wages, or other compensation of a superintendent, assistants, and employes, cost of supplies, equipment, repairs, postage, expressage, telephone rentals, toll charges, and such other expense of every kind and description as may be necessary for the proper conduct of the work of the board and the operation of the institution.

The sum of sixty thousand dollars (\$60,000), or so much thereof as may be necessary, for alterations, repairs, and improvements in the hospital building, to provide better service facilities, quarters for employes, new children's ward, for the purchase of X-ray equipment, laundry, equipment, ambulance, and for the replacement of a fence to protect the hospital grounds.

The sum of fifty thousand dollars (\$50,000), or so much thereof as may be necessary, for the construction of an addition to the hospital building, to provide for a surgical operating unit, equipment, and improvements.

Making an appropriation to the Board of Trustees of the Locust Mountain State Hospital.

Section 1. Be it enacted, &c., That the sum of two hundred and thirty thousand dollars (\$230,000), or so much thereof as may be necessary, is hereby specifically appropriated to the Board of Trustees of Locust Mountain State Hospital for the two fiscal years beginning June first, one thousand nine hundred and twenty-seven, for the following purposes, namely:

The sum of one hundred and ten thousand dollars (\$110,000), or so much thereof as may be necessary, for maintenance, including salaries, wages, or other compensation of a superintendent, assistants, and employes, cost of supplies, equipment, repairs,

postage, expressage, telephone rentals, toll charges, rental of accommodations for nurses, and such other expense of every kind and description as may be necessary for the proper conduct of the work of the board and the operation of the institution.

The sum of ten thousand dollars (\$10,000), or so much thereof as may be necessary, for equipment, including refrigerating equipment, water tank and dumb-waiter, alterations of hospital building to provide improved facilities, installation of telephone exchange, repair of roads, and purchase of motor equipment.

The sum of one hundred and ten thousand dollars (\$110,000), or so much thereof as may be necessary, for the construction and equipment of a nurses' home, purchase of necessary land for said home, and improvements to hospital property.

Making an appropriation to pay for the care, treatment, removal, and maintenance of the indigent insane, for two years ending the thirty-first day of May, one thousand nine hundred and twenty-nine.

Section 1. Be it enacted, &c., That the sum of five million five hundred and fifty-five thousand dollars (\$5,555,000), or so much thereof as may be necessary, be and the same is hereby specifically appropriated to pay for the care, treatment, removal, and maintenance of the indigent insane, for and during the two years beginning June first, one thousand nine hundred and twenty-seven and ending May thirty-first, one thousand nine hundred and twenty-nine.

The said appropriation shall be paid on the warrant of the Auditor General on the basis of settlement by that officer and the State Treasurer, but no warrant shall be drawn or settlement made until the directors, trustees, or managers of the several hospitals and asylums for the insane shall have made, on oath or affirmation, to the Auditor General, a monthly or quarterly report as may be required by the Auditor General, setting forth the actual total number of weeks of service rendered to indigent patients in said hospitals and asylums for the insane, respectively, during the period for which the report is made: Provided, also That no payment shall be made on account of the care and treatment of the insane until the Secretary of Welfare shall have certified to the Auditor General that the monthly or quarterly report of the cost of such care and treatment contains no charge except for "care, treatment, removal and maintenance," which words, as used in this act, shall be construed to mean medical and surgical treatment and nursing, food, and clothing, and absolutely necessary repairs to existing buildings of such hospitals and asylums.

Section 2. It shall be the duty of directors or trustees of the several hospitals and asylums for the insane to make, on oath or affirmation, to the Auditor General, a report on the fifteenth day of June, one thousand nine hundred and twenty-seven, setting forth the name of each and every indigent patient resident in said hospitals and asylums for the insane, respectively, on the first day of June preceding. Such list shall show the date of admission or readmission of each such patient, the identification number of such patient, and the county or poor district from which such patient was committed.

Each month or quarter during the period covered by this appropriation thereafter, as may be requested by the Auditor General, the directors or trustees of the several hospitals and asylums for the insane shall make, on oath or affirmation, a report to the Auditor General setting forth the name of each indigent patient admitted or readmitted during the period of the report, together with the identification number of such patient, the date of admission or readmission, and the county or poor district from which such patient was committed. Said report shall also contain the name of each indigent patient removed from such hospitals or asy-

lums by death, discharge, or parole, together with the identification number of such patient, the date of removal, and the county or poor district from which such patient was committed.

For the general maintenance of instruction in the school of agriculture, and of instruction, research, and extension in the school of engineering, the school of liberal arts, the school of mines and metallurgy, the school of chemistry and physics, the school of education, the graduate school, the department of physical education, the department of military science, and the Carnegie Library, including repairs to grounds and buildings, service, light, heat, power, water, and sewage disposal, salaries and wages, materials, and supplies, and equipment, street paving, insurance and interest, and such other expenditures as the trustees may deem necessary and practicable, the sum of two million one hundred and eighty-one thousand dollars (\$2,181,000).

For the maintenance and equipment, for research and experimental investigations on problems related to the agricultural industry of the State, including administration and operation, maintenance and repair of physical plant, the sum of four hundred and three thousand five hundred dollars (\$403,500).

For meeting the provisions of the act of Congress, approved May eighth, one thousand nine hundred and fourteen, providing for agricultural and home economics extension, and for other forms of extension work in agriculture and home economics, including administration and operation, maintenance and repair of physical plant, the sum of six hundred and fifty thousand dollars (\$650,000).

For the erection of new buildings and the enlargement or alteration of existing buildings, including equipment, furnishings, and the necessary extension of electric, water, steam, and sewage service lines as in the judgment of the trustee may be required, the sum of one million dollars (\$1,000,000).
