A PROCLAMATION

I, JOHN S. FISHER, Governor of the Commonwealth of Pennsylvania, have caused this proclamation to issue, and in compliance with the provisions of article four, section fifteen of the Constitution thereof, do hereby give notice that I have filed in the office of the Secretary of the Commonwealth, with my objections thereto, the following bills passed by both Houses of the General Assembly, viz:

House bill No. 341, entitled "An act to repeal an act, approved the fourth day of June, one thousand eight hundred and seventy nine (Pamphlet Laws, ninety-seven), entitled 'An act for the assessment and collection, in cities of the third class, of the cost of grading, paving, curbing, or otherwise improving streets heretofore improved and running in whole or part through rural districts."

House bill No. 1903, entitled "An act providing for the division of certain wards in cities of the first class by the court of quarter sessions."

Senate bill No. 127, entitled "An act classifying patrolmen, firemen, and fire alarm operators in second class cities; for the payment of salaries or compensation; providing an election to ascertain the will of the electors as to the minimum salaries or compensation for such employes and fixing the minimum salaries or compensation of such employes if the electors vote in favor of the same."

House bill No. 1055, entitled "An act to amend section one of the act, approved the twelfth day of June, one thousand nine hundred

and thirteen (Pamphlet Laws, four hundred and ninety-two), entitled 'An act fixing the salaries and providing for the expenses of county solicitors in counties of this Commonwealth over one hundred and fifty thousand population and less than two hundred and fifty thousand population increasing the salary of the county solicitor.'"

Senate bill No. 108, entitled "An act to amend section eight of an act approved the twenty-third day of June, one thousand nine hundred and eleven (Pamphlet Laws, eleven hundred and twenty-three), entitled 'An act establishing in each county a board of viewers; prescribing their duties; providing for their appointment as viewers, road juries, juries of view, and commissioners to view land; and providing for the charges upon the respective counties in the matter of salaries, costs, and expenses thereof'; authorizing boards of viewers in counties of the fourth class to employ and fix the compensation of stenographers; and providing for the payment by the county of such compensation."

Senate bill No. 284, entitled "An act to amend subdivision three of section three of an act, approved the twenty-ninth day of April, one thousand eight hundred and seventy-four (Pamphlet Laws, seventy-three), entitled 'An act to provide for the incorporation and regulation of certain corporations,' by regulating the weekly advertisements for corporate charters."

Senate bill No. 356, entitled "An act regulating the location of cemeteries in townships; prescribing the powers of boards of township commissioners, boards of health, and the State Secretary of Health in connection therewith; and providing penalties."

Senate bill No. 703, entitled "An act creating a housing commission; defining its powers and duties: and making an appropriation."

Senate bill No. 1090, entitled "An act providing for the service of process in the civil suits upon nonresident operators or nonresident owners whose motor vehicles are operated within the State of Pennsylvania without being licensed under the provisions of the laws of the State of Pennsylvania; providing for the registration and licensing of drivers and operators and of motor vehicles; requiring the execution by them of a power of attorney to the Secretary of Highways of the State of Pennsylvania to accept civil process for them under certain conditions."

Senate bill No. 1153, entitled "An act making it unlawful for any individual or individuals to associate themselves by whatever name, style, or designation, for the purpose of carrying on or making any investigations, inquiries into, reports upon, or disseminating publicity regarding any civic, political or other activities of any city or township unless upon the filing of a certificate to that effect in the office of the Secretary of the Commonwealth and of the prothonotary; requiring county commissioners, at the expense of the county, to provide books for the entry of such certificates; fixing the fees of the Secretary of the Commonwealth and prothonotary; permitting the cancellation of such certificate or an entry to be made on the margin of the book in which such certificate was entered showing who have withdrawn from the said association; providing a method therefor; and prescribing penalties."

House bill No. 166, entitled "An act to amend section one of the

act, approved the eighteenth day of April, one thousand nine hundred and five (Pamphlet Laws, two hundred twelve), entitled 'An act for the better regulation of public pool rooms, billiard rooms, bowling saloons and tenpin alleys in the Commonwealth of Pennsylvania,' as amended, permitting the employment in bowling and tenpin alleys of male minors under eighteen years when employed in accordance with the labor laws regulating the employment of minors."

House bill No. 501, entitled "An act authorizing building and loan associations within the Commonwealth, incorporated under the authority of the same, to increase their capital stock irrespective of the limitations of their charters, and providing the procedure for such increase."

House bill No. 693, entitled "An act to amend section two hundred and twenty of the act, approved the seventeenth day of May, one thousand nine hundred and twenty-one (Pamphlet Laws, seven hundred and eighty-nine), entitled 'An act relating to insurance; establishing an insurance department; and amending, revising, and consolidating the law relating to the licensing, qualification, regulation, examination, suspension, and dissolution of insurance companies, Lloyds associations, reciprocal and inter-insurance exchanges, and certain societies and orders; the examination and regulation of fire insurance rating bureaus, and the licensing and regulation of insurance agents and brokers; providing penalties; and repealing existing laws,' as amended, providing for the appropriation of fees collected by the department for administration purposes."

House bill No. 831, entitled "An act to amend section five hundred and one of the act approved the twenty-fourth day of May, one thousand nine hundred and twenty-three (Pamphlet Laws, three hundred and fifty-nine), entitled 'An act concerning game and other wild birds and wild animals; and amending, revising, consolidating, and changing the law relating thereto,' as amended, changing the open season for raccoon."

House bill No. 883, entitled "An act to amend section forty-two of the act, approved the fifteenth day of April, one thousand eight hundred and thirty-four (Pamphlet Laws, five hundred thirty-seven), entitled 'An act relating to counties and townships and county and township officers,' as amended, permitting county treasurers to retain commissions collected as agents for the Commonwealth."

House bill No. 885, entitled "An act to amend section two hundred and twenty-five of the act, approved the second day of May, one thousand nine hundred and twenty-five (Pamphlet Laws, four hundred and forty-eight), entitled 'An act relating to fish; and amending, revising, consolidating, and changing the law relating to fish in the inland waters and the boundary lakes and boundary rivers of the Commonwealth'; permitting county treasurers to retain for their own use the fees collected for services as agents of the Commonwealth."

House bill No. 1001, entitled "An act to amend section six of the act, approved the twelfth day of July, one thousand nine hundred and nineteen (Pamphlet Laws, nine hundred and forty-one), entitled 'An act providing for the preparation, contents, style, printing, and binding of the Legislative Journal, and its delivery and distribution; providing for the preparation, printing, and binding

of the Journals of the Senate and House of Representatives; authorizing the appointment of official reporters, expert typewriters, clerks, and other employes, and providing for their compensation and mileage; providing for the making of an appendix and index the printing of wrappers or envelopes for mailing the Legislative Journal, and repealing all acts or parts of acts inconsistent herewith,' providing an interim salary for the chief official reporters and official reporters."

House bill No. 1004, entitled "An act to provide for the treatment and care of sick or disabled United States veterans having a legal residence in the State of Pennsylvania."

House bill No. 1051, entitled "An act to amend section one of the act, approved the first day of June, one thousand nine hundred and seven (Pamphlet Laws, three hundred and sixty-four), entitled 'An act to increase the pay of jurors and witnesses in this Commonwealth,' as amended."

House bill No. 1122, entitled "An act providing for the certification of unsatisfied judgments, recovered as a result of an automobile accident, to the Secretary of Highways, and for the revocation of the operators' licenses and motor vehicle registrations of defendants, in such judgments to operate motor vehicles."

House bill No. 1396, entitled "An act empowering the prison board or salary board of counties of the fourth class to fix the salary of the prison warden."

House bill No. 1439, entitled "An act providing for the presentation of libels in divorce to the several courts of common pleas, and awarding of subpoenas thereon."

House bill No. 1523, entitled "An act creating a commission to study the laws relating to first class townships; to revise, restate, and harmonize existing laws, and to eliminate inconsistent, overlapping and redundant provisions of law, which appear obsolete or repealed by implication; and to draft such new legislation as may appear necessary, and to consolidate such laws; and making an appropriation."

House bill No. 1535, entitled "An act to amend paragraph five of section eight, and clauses one, two, three, and four of section twelve of the act, approved the twenty-seventh day of June, one thousand nine hundred and twenty-three (Pamphlet Laws, eight hundred fifty-eight), entitled 'An act establishing a State employes' retirement system, and creating a retirement board for the administration thereof; establishing certain funds from contributions by the Commonwealth and contributing State employes, defining the uses and purposes thereof and the manner of payments therefrom, and providing for the guaranty by the Commonwealth of certain of said funds; imposing powers and duties upon the heads of de-

partments in which State employes serve; excepting annuities, allowances, returns, benefits, and rights from taxation and judicial process; and providing penalties; providing for the payment by the State of annuities to certain former State employes retired for disability before the establishment of the present State employes' retirement system."

House bill No. 1543, entitled "An act requiring cities of the second class to increase the salaries of certain employes."

House bill No. 1752, entitled "An act to amend clause ten, section three, article five of the act, approved the twenty-seventh day of June, one thousand nine hundred and thirteen (Pamphlet Laws, tive hundred sixty-eight), entitled 'An act providing for the incorporation, regulation, and government of cities of the third class; regulating nomination and election of municipal officers therein; and repealing, consolidating, and extending existing laws in relation thereto,' as amended."

House bill No. 1801, entitled "An act authorizing sheriffs to appoint special deputies for court service at the request of any judge, or when needed to guard prisoners being brought to court, and fixing the fees to be paid by counties for such services."

House bill No. 446, entitled "An act to amend section nine of an act, approved the fifteenth day of June, one thousand nine hundred and twenty-three (Pamphlet Laws, eight hundred and thirty-four), entitled 'An act imposing a State tax, including an additional emergency State tax, on liquid fuels, including all liquids ordinarily, practically, and commercially usable in internal combustion engines for the generation of power, and all distillates of, and condensates from petroleum, natural gas, coal, coal tar, and vegetable ferments so usable and sold in this Commonwealth except for the purpose of resale; providing for the collection of such tax, and for the distribution and use of the revenues derived therefrom; providing for the filing of certificates and reports of the sale of such liquid fuels to dealers; and fixing penalties,' as amended; extending the use of the county share of said tax to the construction, reconstruction, maintenance, and repair of county bridges."

House bill No. 218, entitled "An act to amend section two of the act, approved the twenty-eighth day of June, one thousand eight hundred and ninety-five (Pamphlet Laws, four hundred and eight), entitled 'A supplement to the twenty-fourth section of an act, entitled "An act to provide revenue by taxation, approved the seventh day of June, one thousand eight hundred and seventy-nine," approved the first day of June, one thousand eight hundred and eighty-nine, amending the twenty-fourth section by providing for the payment by the State Treasurer of one-half of the two per centum tax on premiums paid by foreign fire insurance companies to the treasurers of the several cities and boroughs within this Commonwealth.'"

House bill No. 1377, entitled "An act authorizing counties of the second class to appropriate moneys for Armistice Day purposes."

Senate bill No. 983, entitled "An act fixing the sheriff's salary

in counties of the fourth class."

second class to increase the salaries of certain employes."

House bill No. 1307, entitled "An act to amend section eight of an act, approved the tenth day of July, one thousand nine hundred and nineteen (Pamphlet Laws, eight hundred fifty-seven), entitled 'An act to provide for the personal registration of electors as a condition of their right to vote at elections, and their enrollment as members of political parties as a further condition of their right to vote at primaries, in cities of the first class of this Commonwealth, by removing from office all existing registration commissioners and their appointees in said cities, and authorizing the Governor to appoint registration commissions therein; defining the jurisdiction of said commissions and the powers and duties of the commissioners constituting same, and of their appointees, including registrars, inspectors of registration, clerks, and counsel; fixing their qualifications, terms of office and compensation; granting them certain immunity from arrest on registration days and, empowering such inspectors to arrest without warrant certain persons committing certain offenses in violation of this act in their presence, as well as to enter and inspect buildings given as residences of electors to interrogate the inmates thereof, to copy or demand a list of the lodgers therein, and to supervise the conduct of registrars; regulating the registration of electors at polling places by registrars, and at the offices of commissions by commissioners, and the right of parties or bodies of electors to have watchers thereat, and the preparation and use of street lists and other records of those registered; allowing the names of persons not entitled to vote to be struck from the registers in certain cases; permitting all records regarding registration to be inspected and copied by any elector under certain conditions; directing how the registers shall be used at elections and primaries; compelling the attendance of witnesses and payment of witness fees; and providing penalties for refusal to obey subpoenas; directing receivers of taxes to appoint chief clerks of commissions as deputies to collect poll taxes and to give receipts therefor; authorizing such clerks to administer oaths, sign subpoenas and vouchers, and to collect and disburse witness fees; prescribing a method for challenging persons applying for registration, and the procedure for the correction of registers, and for appealing from actions of registrars to said commissions; and allowing for appeals from the decisions of the commissions in certain cases to courts of common pleas; imposing certain duties upon election officers and upon the councils, treasurers, controllers, receivers of taxes, police officers, and other officials of said cities, and upon the courts, judges, prothonotaries, sheriffs, commissioners, peace officers, and other officials of the judicial districts and counties in which said cities are situated or with which they are coextensive; legalizing certain acts required hereby if done on any Sunday or legal holiday; requiring said cities to provide for the maintenance of said commissions, and the compensation of their appointees, and the payment of all expenses necessary to carry out the provisions of this act, and to transfer the unexpended balances of all appropriations heretofore made for the personal registration of electors of said cities during the year one thousand nine hundred and nineteen to and for the use of the said commissions; punishing and fixing penalties for violations hereof; and repealing all legislation inconsistent herewith."

House bill No. 1408, entitled "An act to amend sections three, twelve, and twenty-three of the act, approved the fourteenth day of June, one thousand nine hundred and twenty-three (Pamphlet Laws, seven hundred and ten), entitled 'An act allowing and regulating boxing, sparring, and wrestling matches and exhibitions; establishing a State Athletic Commission; making an appropriation therefor, and appropriating moneys received for monument and memorial purposes; and prescribing penalties'; increasing the salary of the secretary of the commission; exempting certain amateur contests; and permitting attendance of children under certain conditions."

House bill No. 1615, entitled "An act constituting a commission to act with a similar commission of the State of New Jersey for the purpose of providing a new bridge over the Delaware River from Dingman's Ferry to a point in Sussex County, New Jersey; defining the powers and duties of the joint commission; and making an appropriation."

House bill No. 1802, entitled "An act making an appropriation for the payment of unpaid claims owing by the Commonwealth for materials or supplies furnished through the Department of Property

and Supplies."

House bill No. 1499, entitled "An act making an appropriation for providing, erecting, completing armories and stables for the use of the Pennsylvania National Guard, including title insurance, advertisement for bids, and other necessary expenses incident to the erection of State armories.

heretofore held or possessed by national banks which were attempted to be made escheatable by an act, approved the seventh day of June, one thousand nine hundred and fifteen (Pamphlet Laws, eight hundred seventy-eight), entitled 'An act providing for the escheat of deposits of moneys or property of another received for storage or safe-keeping; the dividends, profits, debts, and interests on debts of corporations, companies, banks, trust companies, insurance companies, limited partnerships, and partnership associations, organized under the laws of this Commonwealth, except mutual saving-fund society not having a capital stock represented by shares, and except also building and loan associations, and property held for the benefit of another by the same, and the profits, accretions, and interest on such property, as well as interest thereon accrued, or which should have accrued, between the fixing of the amount of such property by the award of any court and the actual distribution thereof,' and amendments thereto, which have been wrongly collected from said national banks by the said Commonwealth, and making an appropriation."

House bill No. 670, entitled "An act lapsing unexpended balances of appropriations heretofore made to the Water Supply Commission for the purpose of widening, deepening, and improving French Creek, in Crawford County."

Senate bill No. 269, entitled "A supplement to an act, approved the twenty-third day of June, one thousand nine hundred eleven (Pamphlet Laws, one thousand one hundred and twenty-three), entitled 'An act establishing in each county a board of viewers; prescribing their duties; providing for their appointment as viewers, road juries, juries of view, and commissioners to view land; and providing for the charge upon the respective counties in the matter of salaries, costs, and expenses thereof,' as the same was amended and supplemented by subsequent acts, by providing for the compensation to be paid to the members of the board of viewers in counties of the third class."

House bill No. 1685, entitled "An act fixing the salary of the prothonotary in counties of the fifth class."

House bill No. 1449, entitled "An act to permit general contractors to withdraw retained percentages on public works contracts, and to substitute therefor United States Government, Commonwealth of Pennsylvania, or municipal bonds."

House bill No. 1636, entitled "An act to provide for the safety of the highways of cities of the second class A, authorizing councils to provide by ordinance for the filing of maps of excavations under highways, and for the inspection thereof."

House bill No. 1392, entitled "An act to amend section one of an act, approved the twenty-second day of March, one thousand nine hundred and seven (Pamphlet Laws, thirty-one), entitled 'An act to provide for the assignment of counsel in murder cases, and for the allowance of expenses and compensation in such cases."

House bill No. 1730, entitled "An act fixing the salaries of county controllers in counties of the fourth class."

House bill No. 1713, entitled "An act authorizing the county commissioners of any county of the first and second class to sup-

plement an increase of indebtedness authorized for the purpose of erecting public buildings."

House bill No. 314, entitled "An act to amend section thirty-eight of the act, approved the twentieth day of June, one thousand nine hundred and nineteen (Pamphlet Laws, five hundred and twenty-one), entitled 'An act providing for the imposition and collection of certain taxes upon the transfer of property passing from a decedent who was a resident of this Commonwealth at the time of his death, and of property within this Commonwealth of a decedent who was a nonresident of the Commonwealth at the time of his death; and making it unlawful for any corporation of this Commonwealth, or national banking association located therein, to transfer the stock of such corporation or banking association, standing in the name of any such decedent, until the tax on the transfer thereof has been paid; and providing penalties; and citing certain acts for repeal,' reducing the interest rate on unpaid taxes."

House bill No. 436, entitled "An act to amend section one of the act, approved the twenty-eighth day of May, one thousand nine hundred and thirteen (Pamphlet Laws, three hundred and fifty-six), entitled 'An act to fix the salaries of the clerks of the State Department, in the office of the county treasurer of any county of this Commonwealth having a population of one million or over,' by increasing the salaries thereof in counties of the first class."

House bill No. 741, entitled "An act to amend sections six hundred and seventeen as amended, and seven hundred and eight, of the act, approved the eighteenth day of May, one thousand nine hundred and eleven (Pamphlet Laws, three hundred nine), entitled 'An act to establish a public school system in the Commonwealth of Pennsylvania, together with the provisions by which it shall be administered, and prescribing penalties for the violation thereof; providing revenue to establish and maintain the same, and the method of collecting such revenue; and repealing all laws, general, special, or local, or any parts thereof, that are or may be inconsistent therewith'; regulating advertisements and notices for bids and the public opening thereof."

House bill No. 790, entitled "An act imposing an annual charge on lands of State institutions for road and school purposes."

House bill No. 865, entitled "An act to prevent the employment in this State of any child residing in another State during the time when the laws of his own State require his attendance at school."

House bill No. 908, entitled "An act to amend section one and section seventeen as amended, of an act approved the seventeenth day of June, one thousand nine hundred and thirteen (Pamphlet Laws, five hundred seven), entitled 'An act to provide revenue for State and county purposes and, in cities coextensive with counties, for city and county purposes; imposing taxes upon certain classes of personal property; providing for the assessment and collection of the same; providing for the duties and compensation of prothonotaries and recorders in connection therewith; and modifying existing legislation which provides for raising revenue for State purposes.'"

House bill No. 1145, entitled "An act to amend section eighteen criers and tipstaves in counties of the third class."

House bill No. 944, entitled "An act fixing the salaries of court of an act, approved the fourth day of April, one thousand eight hundred sixty-eight (Pamphlet Laws, six hundred sixty), entitled 'An act authorizing the erection of a poorhouse by the townships of North Abington, South Abington and Newton, in the county of Luzerne.'"

House bill No. 1151, entitled "An act providing that the times for the opening and closing of the tax duplicates in cities of the first class shall be as prescribed by the councils of the said cities; that duplicates of real estate assessments and taxes shall be furnished by the Board of Revision of Taxes to the Receiver of Taxes between January first and January twenty-fifth; and providing that, in addition to the matters now required by law to be included therein, the amounts which may be due at various intervals during the year in

which such taxes are payable, upon each piece of taxable property, shall be shown, as well as the total amount of taxes payable for the said year; and repealing inconsistent legislation."

House bill No. 1291, entitled "An act to amend section thirteen, article seven of an act, approved the nineteenth day of February, one thousand eight hundred and fifty (Pamphlet Laws, eighty-nine), entitled 'An act relative to the Lancaster county prison,' by increasing the compensation of the members of the board of prison inspectors of Lancaster county.'"

House bill No. 1316, entitled "An act to amend section two of the act, approved the eleventh day of April, one thousand eight hundred and seven (Pamphlet Laws, two hundred fifty-nine), entitled 'An act to provide for the erection of a poorhouse for the better relief and employment of the poor in the townships of Oxford and Lower Dublin, in the county of Philadelphia'; changing the corporate name of said district, and providing for the purchase, acquisition, dedication, and sale of property and the use of the proceeds acquired from sales and conveyances."

House bill No. 1397, entitled "An act requiring poor districts and hospitals for mental disease to establish a pension fund for all emeployes of district, including district, city, and county homes and hospitals for mental disease, and regulating the administration and payment of such pensions."

House bill No. 1624, entitled "An act to further amend clause (a) one of section forty-one of the act, approved the seventh day of June, one thousand nine hundred and seventeen (Pamphlet Laws, four hundred forty-seven), entitled 'An act relating to the administration and distribution of the estates of decedents and of minors, and of trust estates; including the appointment, bonds, rights, powers, duties, liabilities, accounts, discharge and removal of executors, administrators, guardians, and trustees, herein designated as fiduciaries: the administration and distribution of the estates of presumed decedents; widow's and children's exemptions; debts of decedents, rents of real estate as assets for payment thereof, the lien thereof, sales and mortgages of real estate for the payment thereof, judgments and executions therefor, and the discharge of real estate from the lien thereof; contracts of decedents for the sale or purchase of real estate; legacies, including legacies charged on land; the discharge of residuary estates and of real estate from the lien of legacies and other charges; the appraisement of real estate devised at a valuation; the ascertainment of the curtilage of dwelling houses or other buildings devised; the abatement and survival of actions and the substitution of executors and administrators therein, and suits against fiduciaries; investments by fiduciaries; the organization of corporations to carry the business of decedents; the audit and review of accounts of fiduciaries; refunding bonds; transcripts to the court of common pleas of balances due by fiduciaries; the rights, powers, and liabilities of nonresident and foreign fiduciaries; the appointment, bonds, rights, powers, duties, and liabilities of trustees durante absentia; the recording and registration of decrees, reports and other proceedings, and the fees therefor; appeals in certain cases; and, also, generally dealing with the jurisdiction, powers, and procedure of the orphans' court in all matters relating to fiduciaries concerned with the estates of decedents.'"

House bill No. 1658, entitled "An act to amend section one of an act, approved the ninth day of April, one thousand eight hundred and forty-nine (Pamphlet Laws, five hundred thirty-three), entitled 'An act to exempt property to the value of three hundred dollars from levy and sale on execution and distress for rent."

House bill No. 1757, entitled "An act authorizing cities of the second class of this Commonwealth to store motor vehicles abandoned or seized in violation of the law; to advertise and sell such motor vehicles if not reclaimed within thirty (30) days after such seizure; providing for the payment of charges of such seizure, advertising and sale; and applying the proceeds of the sale, first, to the payment of such charges, and the balance to be paid to the city treasurer."
