Whereas, It is fitting that the recurring anniversary of this day be commemorated with suitable, patriotic and public exercises in observing and commemorating the death of this American hero of the Revolutionary War; therefore,

Section 1. Be it enacted, &c., That the Governor of General Pulaski's Memorial Day. the Commonwealth of Pennsylvania shall annually issue a proclamation calling upon officials of the Government to display the flag of the United States on all governmental buildings on October eleventh of each year, and invite the people of the Commonwealth to observe the day, in the schools, churches and other suitable places, Observance. with appropriate ceremonies in commemoration of the death of General Casimir Pulaski.
