Rape-seed, fifty pounds. Raspberries, forty-eight pounds. Redtop grass seed, fourteen pounds. Rice, rough, forty-five pounds. Rutabagas, sixty pounds. Rye, fifty-six pounds. Ryemeal, fifty pounds. Salt (coarse), eighty-five pounds. Salt (ground), sixty-two pounds. Sand, one hundred pounds. Shorts, twenty pounds. Sorghum-seed, fifty pounds. Spelt, forty pounds. Spinach, twelve pounds. Strawberries, forty-eight pounds. Timothy-grass seed, forty-five pounds. Tomatoes, fifty-six pounds. Turnips, fifty-six pounds. Walnuts (common), fifty pounds. Wheat, sixty pounds.

Provided, That when any fruits or vegetables named in this section are sold in Pennsylvania standard containers, which are the original packages and are filled in standard containers. accordance with good commercial practices, such fruits and vegetables shall be exempt from the provision of this section.

A JOINT RESOLUTION

Providing for the observance and commemoration of the one hundredth anniversary of the signing of the common schools law.

Whereas, On April first, one thousand nine hundred Preamble. and thirty-four, will occur the one hundredth anniversary of the signing of the common schools law; and

Whereas, The service rendered to the State, through the enactment of that law, has been of such outstanding importance as to make the date of its signing one of historical significance; and

Whereas, It is fitting that proper recognition should be given the efforts of Governor George Wolfe, Samuel Brecht, Thaddeus Stevens, and the others, who so ardently advocated the enactment of the common schools law; therefore.

Section 1. Be it resolved by the Senate and Pennsylvania House of Representatives of the Commonwealth of Penn-

Observance of hundredth anniversary.

sylvania in General Assembly met, That the Governor of the State of Pennsylvania is hereby authorized to issue a proclamation designating the week beginning Sunday, April first, one thousand nine hundred and thirty-four, as Pennsylvania Education Week, and calling upon the school authorities, teachers, school children, and the people of the State to display the United States Flag and the Pennsylvania Flag during said education week, in honor of the one hundredth anniversary of the signing of the common schools law.

Duty of superintendent.

Section 2. The Superintendent of Public Instruction is authorized to organize such an educational program as will signally mark the centennial anniversary of the signing of the common schools law, and will visualize the progress that public education has made in the State of Pennsylvania during the one hundred years then completed.

Educational history to be stressed.

Section 3. The Superintendent of Public Instruction shall request the school authorities and school teachers of the Commonwealth so to stress, during the centennial celebration, the educational history of Pennsylvania for the past one hundred years that school children will understand the meaning and significance of the public schools to the people of the State.

AN ACT

To amend section two of an act, approved the first day of May, one thousand nine hundred and twenty-nine (Pamphlet Laws, one thousand one hundred eighty-four), entitled "An act conferring and imposing certain powers and duties upon the State Board of Pardons with respect to inmates of State penal and correctional institutions released on parole," by authorizing field parole agents to arrest parole violators.

State Board of Pardons.

Section 2, act of May 1, 1929, (P. L. 1184), amended. Section 1. Be it enacted, &c., That section two of an act, approved the first day of May, one thousand nine hundred and twenty-nine (Pamphlet Laws, one thousand one hundred eighty-four), entitled "An act conferring and imposing certain powers and duties upon the State Board of Pardons with respect to inmates of State penal and correctional institutions released on parole," is hereby amended to read as follows:

Powers and duties of board.

Section 2. The Board of Pardons shall have the following powers and duties: (a) It shall establish standards to govern the selection of field agents for the supervision of prisoners on parole, and to govern the supervision.
