mit an original signed copy thereof to the Secretary of the Commonwealth for filing in his office.

Covernor to apply to Congress for consent and approval.

The Governor is hereby authorized to Section 3. apply, on behalf of the Commonwealth of Pennsylvania. to the Congress of the United States for its consent and approval to the aforesaid compact or agreement; but in the absence of such consent and approval, The Delaware River Joint Commission shall have all of the powers which the Commonwealth of Pennsylvania and the State of New Jersey may confer upon it without the consent and approval of Congress.

Appropriation.

Section 4. The sum of two hundred and fifty thousand dollars (\$250,000), or as much thereof as may be necessary, is hereby specifically appropriated to The Delaware River Joint Commission, to be used by it, together with a like appropriation made by the State of New Jersey, for any of the purposes of the said commission, except the operation, maintenance, improvement or construction of new facilities for the existing bridge over the Delaware River between Philadelphia and Camden. The money hereby appropriated shall be disbursed upon requisition of the Governor, presented to the Auditor General, who shall direct his warrant upon the State Treasurer in the usual manner.

Disbursement.

Section 5. This act shall become effective on July first, one thousand nine hundred and thirty-one; but the Governor shall not enter into any agreement hereunder until the State of New Jersey shall have passed a substantially similar act embodying the agreement between the two States herein set forth, and making a

AN ACT

Authorizing the Department of Property and Supplies to acquire lands in Harris Township, Centre County, for the use of the Department of Military Affairs; and making an appropriation.

Department of Property and Supplies.

Acquisition of certain land for use of Department of Military Affairs authorized.

Section 1. Be it enacted, &c., That the Department of Property and Supplies, subject to the approval of the Department of Military Affairs, is hereby authorized to acquire, in the name of the Commonwealth and in the manner provided by the Administrative Code of one thousand nine hundred and twenty-nine, a tract or contiguous tracts of lands located in Harris Township,

Centre County, not exceeding seventy acres, including all buildings and improvements, for the Department of Military Affairs. The said department shall have power to acquire said property subject to the existing lease of the Twenty-eighth Division Officers' Club, and to turn said property over to the Department of Military Affairs for management.

Section 2. The Department of Military Affairs shall Military cemetery. set aside approximately twenty-eight acres of the tract so acquired for use as a military cemetery, as con-templated by section one thousand four hundred and six of the Administrative Code of one thousand nine hundred and twenty-nine, and approximately thirty acres as a military reservation. The portion set aside Military for a military cemetery shall include the tract upon reservation. which is located the shrine erected by the officers of the Twenty-eighth Division.

Section 3. The sum of twenty-six thousand five hun- Appropriation. dred dollars (\$26,500), or so much thereof as may be necessary, is hereby specifically appropriated to the Department of Property and Supplies, for the payment of the land acquired and the cost of title searches in connection therewith.

## AN ACT

To promote the public health and safety, by providing for the examination and licensure of those who desire to engage in the occupation of barbering; regulating barber shops, barber schools and barber colleges, and apprentices and students therein; conferring certain powers and duties on the Department of Public Instruction; and providing penalties.

Section 1. Be it enacted, &c., That it shall be unlawful for any person to follow the occupation of barber in this Commonwealth unless he or she shall have first passed an examination and obtained a certificate of registration as provided in this act. Nothing contained in this act, however, shall apply to or affect any person who is now actually engaged in such occupation, except as hereinafter provided.

Section 2. Every person now engaged in the occupation of a barber shall, within ninety days after the effective date of this act, file with the Department of Public Instruction, hereinafter termed department, an application under oath or affirmation, which shall set Application for forth his or her name, age, residence, and length of certificate of registration.
