the plaintiff could not properly have joined all such parties as defendants.

To repeal certain special acts pertaining to taxation in Bucks County.

Taxation. , Bucks County. Acts repealed. Section 1. Be it enacted, &c., That the following acts or parts of acts are hereby repealed, as respectively indicated:

Act of March 29, 1859 (P. L. 294). (a) The act, approved the twenty-ninth day of March, one thousand eight hundred and fifty-nine (Pamphlet Laws, two hundred ninety-four), entitled "An act relating to the collection of State and county taxes in the county of Bucks," absolutely.

Act of March 31, 1864 (P. L. 177). (b) The act, approved the thirty-first day of March, one thousand eight hundred and sixty-four (Pamphlet Laws, one hundred seventy-seven), entitled "A supplement to an act relating to the collection of State and county taxes in the county of Bucks," absolutely.

Act of February 14, 1867 (P. L. 201). (c) The act, approved the fourteenth day of February, one thousand eight hundred and sixty-seven (Pamphlet Laws, two hundred one), entitled "An act supplementary to a supplement to "An act relating to the collection of State and county taxes in the county of Bucks," approved thirty-first day of March, one thousand eight hundred and sixty-four," absolutely.

Act of April 1, 1868 (P. L. 588). (d) The act, approved the first day of April, one thousand eight hundred and sixty-eight (Pamphlet Laws, five hundred eighty-eight), entitled "A further supplement to an act relating to the collection of State and county taxes in the county of Bucks," absolutely.

Act of April 10, 1873 (P. L. 604). (e) The act, approved the tenth day of April, one thousand eight hundred and seventy-three (Pamphlet Laws, six hundred four), entitled "An act in relation to fees of county treasurer of Bucks County, Pennsylvania," absolutely.

Section 52, act of April 1, 1836 (P. L. 436), so far as applies to Pucks County, (f) Section fifty-two of the act, approved the first day of April, one thousand eight hundred and thirty-six (Pamphlet Laws, four hundred thirty-six), entitled "An act regulating election districts, and for other purposes," so far as the same applies to Bucks County.

Tax collections.

Section 2. Nothing in this act shall be deemed to affect the authority of the county treasurer of Bucks County to collect taxes already in his hands for collec-

tion, and for such purposes said laws shall be deemed to remain in force.

Section 3. The above repeal shall be deemed effective Effective date. as of January first, one thousand nine hundred and thirty-two.

# No. 238 A SUPPLEMENT

To the act, approved the eighth day of May, one thousand nine hundred and one (Pamphlet Laws, one hundred fortythree), entitled "An act providing that where any court of quarter sessions of the peace or court of over and terminer in this Commonwealth has heretofore made or entered, or shall hereafter make or enter, any order, sentence, decree or judgment for the payment of any moneys whatsoever, in any matter or thing within its jurisdiction, a copy of said order, sentence, decree or judgment may be certified to any court of common pleas of the same county, and be entered and indexed therein as a judgment and collected with like force and effect as if the same had been recovered as a judgment in the latter court," to limit the lien of such judgments and regulate the revival thereof.

Section 1. Be it enacted, &c., That no such order, Judgment of court sentence, decree or judgment, certified in accordance of quarter sessions or over and with the act to which this is a supplement, shall be a terminer. lien upon the real estate of the defendant until entered and indexed in the court of common pleas, in compliance with the provisions of the act to which this is a Not to be Hen supplement, and then shall remain a lien for the period until entered in court of common of five years only, unless, within said period, the same pleas. is revived in manner provided in the act to which this Revival. is a supplement.
