Be it enacted, &c., That section one of the act, approved the third day of May, one thousand nine hundred and twenty-three (Pamphlet Laws, one hundred thirty-four), entitled "An act making the proceedings of the conventions of the Departments of Pennsylvania of the Grand Army of the Republic and the United Spanish War Veterans a part of the public records of the State; and providing for their publication and distribution," which was amended by the act, approved the eighth day of May, one thousand nine hundred and twenty-nine (Pamphlet Laws, one thousand six hundred seventy-seven), entitled "An act to amend section one of the act, approved the third day of May, one thousand nine hundred and twenty-three (Pamphlet Laws, one hundred thirty-four), entitled 'An act making the proceedings of the conventions of the Departments of Pennsylvania of the Grand Army of the Republic and the United Spanish War Veterans a part of the public records of the State; and providing for their publication and distribution,' by extending the provisions of said act to the Veterans of Foreign Wars of the United States, the American Legion, and the Disabled American Veterans of the World War," is hereby further amended to read as follows:
