To amend route five hundred and fifty-six as amended, route five hundred and seventy-one as amended, route five hundred and eighty-one as amended, route six hundred and fourteen as amended, route six hundred and forty-one as amended, route six hundred and sixty-one as amended, route six hundred and eighty-one as amended, route seven hundred and twenty-nine as amended, and routes five hundred and forty-five, five hundred and seventy-nine, six hundred and eighteen, six hundred and sixty-eight, six hundred and seventy, and six hundred and ninety-five of an act, approved the fifth day of May, one thousand nine hundred and twenty-seven (Pamphlet Laws, seven hundred eighty-seven), entitled "An act establishing certain public roads as State highways, and providing for their construction and maintenance at the expense of the Commonwealth."

Certain routes established by act of May 5, 1927 (P. L. 787), and amended by act of May 7, 1929 (P. L. 1598), further amended. dred and fifty-six of section one of an act, approved the fifth day of May, one thousand nine hundred and twenty-seven (Pamphlet Laws, seven hundred eighty-seven), entitled "An act establishing certain public roads as State highways, and providing for their construction and maintenance at the expense of the Commonwealth," as amended by act of Assembly, approved the seventh day of May, one thousand nine hundred and twenty-nine (Pamphlet Laws, fifteen hundred ninety-eight), is hereby further amended to read as follows:

Section 1. Be it enacted, &c., That route five hun-

Commencing on State highway route number ninety-seven, [at its intersection with East Avenue] in the borough of Johnsonburg, Elk County; and extending thence Southeasterly toward St. Marys to connect with [the western end of Maurus Street and the borough line of the borough of St. Marys, and connecting therein] State highway route number ninety-nine. [by way of Maurus Street and Saint Michael Street.]

Section 2. That route five hundred and seventy-one of said act as amended by act of Assembly, approved the seventh day of May, one thousand nine hundred and twenty-nine (Pamphlet Laws, fifteen hundred ninety-eight), is hereby further amended to read as follows:

That route six hundred and fourteen of said act as amended by act of Assembly, approved the seventh day of May, one thousand nine hundred and twenty-nine (Pamphlet Laws, fifteen hundred ninetyeight), is hereby further amended to read as follows:

Route Six Hundred and Fourteen. Commencing at Route 614. a point on State highway route number two hundred and forty-six [thence westward on Potter Run Road] at Leesburg in Mercer County; thence southwestwardly to a point on the Mercer-Lawrence county line, to the borough of Volant; thence [southwestward] southwardly to the village of Eastbrook; [where same intersects with State-aid road thence over State-aid road into New Castle, Lawrence County.

Section 5. That route six hundred and forty-one of said act as amended by act of Assembly, approved the seventh day of May, one thousand nine hundred and twenty-nine (Pamphlet Laws, fifteen hundred ninetyeight), is hereby further amended to read as follows:

Commencing at a Route 641. point on the dividing line between Beaver and Allegheny counties, on the Beaver Road; thence by way of said Beaver Road, in Beaver County, to Merchant Street in the borough of Ambridge; [by way of Duss Avenue;] thence over [said] Duss Avenue, thru Harmony Township, to the borough of Baden; thence [by way of State Street, thru the borough of Baden, and by way of the Philipsburg and Beaver Road, in Economy Township, to Conway Borough; thence through Conway Borough [by way of Second Avenue] to Freedom Borough; thence by way of Third Avenue in Freedom Borough to Rochester Borough, by way of Second Street, through East Rochester and [Rochester Township; and thence through] Rochester Borough [by way of Railroad Street, Harrison Street, overgrade bridge, Main Street, and Madison Street, to Big Beaver Bridge into West Bridgewater connecting with State highway route number two hundred and four.

Allegheny County; thence to a connection with route number six hundred and eighty in North Fayette Township.

Section 8. That route seven hundred and twentynine of said act as amended by act of Assembly, approved the seventh day of May, one thousand nine hundred and twenty-nine (Pamphlet Laws, fifteen hundred ninety-eight), is hereby further amended to read as fol-

lows:

Route Seven Hundred and Twenty-nine. ing [at the termination of Seventeenth Street in the city of Chester; and running on the boundary line between the States of Delaware and Pennsylvania, northwest of the Baltimore and Ohio Railroad: thence to the city of Chester; thence across Ridley Creek into Ridley Township; and thence to Bullens Lane; thence to Crum Creek Bridge; thence easterly, by Third Avenue, to Parker Avenue in the borough of Collingdale, to the intersection of Parker Avenue at the Chester Pike in Delaware County.

Section 9. That routes five hundred and forty-five. five hundred and seventy-nine, six hundred and eighteen, six hundred and sixty-eight, six hundred and seventy, and six hundred and ninety-five of said act are hereby amended to read as follows:

Beginning at a Route 618. point on route number one hundred twenty-nine, [at Center Square in the borough of Middletown, Dauphin County, Pennsylvania;] near the eastern borough line of the borough of Middletown; and extending thence in a [northerly direction through the borough of Middletown and Lower Swatara Township to Coble's schoolhouse; and thence northwardly through Lower Swatara Township, Ebenezer, Oberlin and through Swatara Township] northwestwardly direction, by way of Middletown Borough, Lower Swatara and Swatara Townships, to a point near the village of Oberlin; thence to a point in Paxton Street [in] on the city line of Harrisburg, Pennsylvania.

Beginning [at] on route number two hundred and thirty-four in the borough [line] of Houtzdale, in the county of Clearfield; [and on the north side of said borough on Brisbin Street; thence northward through Woodward to Brisbin Borough and through on Swope Street; and thence in a northwesterly direction in Woodward Township and following the Pike to Henderson, and through in the direction of Jeffries for a distance of three miles from point of beginning, in the direction of Clearfield, the countyseat, on the Lakes to Sea Highway.] and thence in a northwesterly direction through Brisbin to Henderson.

Route Six Hundred and Ninety-five. Commencing Route 695. at Greenville in Mercer County, at an intersection with State highway route number two hundred and thirtyeight; and running thence [by way of Maysville] to the Ohio State Line, and connecting with the Ohio Federal Road at Vernon. Ohio.
