claimant, or by providing that such costs shall be shared by the parties in such proportions as the board shall direct.

Section 9. Within thirty (30) days after any final award made by the board, the secretary of the board shall certify to the secretary of the department involved, under the seal of the board, a statement of such award, or in the event it shall dismiss the said claim, a statement of such costs that it may assess against the claimant. The amount of such award shall be paid by said secretary out of any funds appropriated against the contract out of which the claim upon which the award is based was originally charged, said award shall thereafter be paid to the claimant from the said fund or appropriation in the manner now provided by law. In the event that costs are assessed against the claimant, the amount of such costs shall be deducted from whatever balance may be due the claimant upon the contract out of which the claim arose.

Section 10. The board shall establish such rules for its government, and regulations governing practice before it as it shall deem proper and necessary. All papers herein filed shall be matters of public record, and the public, subject to the reasonable requirements of the board, shall at all times have access thereto and shall be permitted to examine the same.

This act shall become effective immedi-Section 11. ately upon its approval by the Governor.

Section 1607. In every elementary public and private Courses of study. school, established and maintained in this Commonwealth, the following subjects shall be taught, in the English language and from English texts: English, including spelling, reading, and writing, arithmetic, geography, the history of the United States and of Pennsylvania, civics, including loyalty to the State and National Government, safety education, and the humane treat- Safety education ment of birds and animals, health, including physical training and physiology, music, and art. Other subjects shall be taught in the public elementary schools and also in the public high schools as may be designated or approved by the State Board of Education. All such subjects, except foreign languages, shall be taught in the English language and from English texts. Each school district in this Commonwealth shall provide and distribute to each pupil, enrolled in the eighth grade of the public schools, one illustrated copy of the National Flag Code, and shall, from time to time, make available such copies as are necessary for replacements from year to year, and it shall be the duty of each teacher in the public schools to make use of the said code as may, from time to time, seem proper.

AN ACT

To amend section one of the act, approved the first day of June, one thousand nine hundred thirty-three (Pamphlet Laws, one thousand four hundred six), entitled "An act authorizing the Attorney General, under certain conditions, to enter into agreements to collect certain claims from boroughs for the main-tenance of State highways in installments after such claims have been reduced to judgment, and to compound certain judgments," by extending the act to all pending claims of the De-partment of Highways against boroughs for the construction, reconstruction or maintenance of State highways.
