## No. 274 AN ACT

Concerning vocational education; providing for the acceptance by the Commonwealth of Pennsylvania of the provisions of the act of Congress, approved June eighth, one thousand nine hundred and thirty-six, entitled "An act to provide for the further development of vocational education in the several States and Territories," and conferring powers and imposing duties on the State Treasurer and the State Council of Education.

Preamble.

Whereas, An act of Congress, approved June eighth, one thousand nine hundred and thirty-six, to provide for the further development of vocational education requires the states participating in its benefits to accept the provisions of said act: therefore.

Vocational education.

Commonwealth accepts the provisions of the Federal act of June 8, 1936.

the provisions of said act; therefore,
Section 1. Be it enacted, &c., That the Commonwealth of Pennsylvania hereby accepts the provisions of the act of Congress, approved June eighth, one thousand nine hundred and thirty-six, entitled "An act to provide for the further development of vocational education in the several States and Territories."

The Commonwealth of Pennsylvania formally accepts the provisions of said act of Congress with respect to the following funds therein provided:

1. Appropriation for the salaries and travel of teachers, supervisors and directors of:

(a) Vocational agricultural subjects;

(b) Vocational trade and industrial subjects;

(c) Vocational home economics subjects;

(d) Vocational distributive occupational subjects.

2. Appropriation for the training of teachers of vocational subjects.

State Treasurer designated custodian of the Federal funds.

Section 2. The State Treasurer is hereby designated as the custodian of the Federal appropriation for vocational education, and shall receive money paid to the State from the United States Treasury under the provisions of said act of Congress, and shall pay out the same upon the warrant of the Auditor General of the State when the same is certified by the State Board for Vocational Education.

The State Council of Education designated to carry out the provisions of the act.

Section 3. The State Council of Education is hereby designated as the State Board for Vocational Education to carry out the provisions of said act so far as the same relates to the cooperation of the State and Federal governments, and shall have full power to take all necessary steps in the formulation of plans for the administration of education in agriculture, in trades, in home economics, in industries and distributive occupations and to formulate and execute plans for the preparation of teachers of vocational subjects.

Section 4. The Secretary of the Commonwealth is hereby directed to forward a certified copy of this act to the Federal Board of Vocational Education.

Secretary of the Commonwealth to furnish certified copy.

Section 5. This act shall become effective immediately when effective. upon final enactment.

## AN ACT

To re-enact and amend the title and act, approved the twentyeighth day of March, one thousand nine hundred and twentynine (Pamphlet Laws, eighty-six), entitled "An act relating to the grading and sale of grapes in this Commonwealth, providing penalties for violations, and imposing certain duties upon the Department of Agriculture," extending the provisions of said act to potatoes; and changing the penalties prescribed.

Section 1. Be it enacted, &c., That the title and act, approved the twenty-eighth day of March, one thousand nine hundred and twenty-nine (Pamphlet Laws, eighty-six), entitled "An act relating to the grading and sale of grapes in this Commonwealth, providing penalties for violations, and imposing certain duties upon the Department of Agriculture," are hereby reenacted and amended to read as follows:

## AN ACT

Relating to the grading and sale of grapes and potatoes in this Commonwealth; providing penalties for violations; and imposing certain duties upon the Department of Agriculture.

Section 1. Be it enacted, &c., That the term "closed Grapes and package," wherever used in this act, shall mean a basket, box, bag, or other container the contents of which cannot be adequately inspected without opening it. The Grading and sale. terms "shipment" or "ship for sale," wherever used Terms defined. in this act, shall mean movement to market in a railroad car, motor truck, or other medium of transportation, but shall not be construed to include process of

delivery to a local warehouse or shipping station.

Section 2. The Secretary of Agriculture of the De- of Sunday Standards partment of Agriculture of this Commonwealth is hereby authorized and empowered, after investigation, to establish and promulgate official standards of quality for grading, classifying, and packing grapes and potatoes packed or repacked within the State and to change any of them from time to time. [In establishing such standards he shall take into account, among other things, the factors of maturity, color, firmness of attachment to capstems, compactness of bunches, and damages caused by freezing or by disease or insects.] The official standards so established and promulgated shall
