providing such rooms and of maintaining the same, including salaries, and all incidental expenses, shall be paid by the county, and the other half by the municipality; for all which purposes the county commissioners and said authorities may, respectively, appropriate moneys.

Any part of any ground heretofore or hereafter so selected and acquired by any county for the purposes of a court house, jail or workhouse may be leased by such county to any municipality being the county seat of such county, for the purpose of the construction thereon of a public comfort station by such municipality.

AN ACT

Empowering municipalities to refund improvement bonds based solely on assessments for grading, street and sewer improve-ment; and imposing no municipal liability by a new issue of bonds.

Section 1. Be it enacted, &c., That in all cases where Municipalities any municipality has issued improvement bonds, based empowered to solely upon assessments for any grading, street or sewer ment bonds by improvements and imposing no municipal liability, and bonds. such bonds have matured or are about to mature and become due and payable, and such assessments and the liens filed thereon remain unpaid, in whole or in part, for any reason whatever, it shall be lawful for such municipality for the purpose of redeeming, exchanging or paying off any or all of such bonds to issue and exchange or sell registered or coupon bonds, based solely upon the assessments and liens filed for such improvements which remain unpaid and the lien whereof has not been lost, which bonds shall impose no municipal lia-Such bonds shall bear a rate of interest not bility. exceeding the rate expressed in the bonds to be redeemed, exchanged or paid off, shall be redeemable at any time not exceeding ten years from the date thereof, and shall not exceed in the aggregate the amount of bonds to be so redeemed, exchanged or paid off. Such bonds shall be exempt from taxation except for State purposes: Provided, however, That all moneys col- Proviso. lected which are by law made applicable to the redemption of the issue of bonds proposed to be refunded shall first be applied to the payment of the principal of such

issuing new

bonds, and the balance of such issue only shall be redeemed by the issue of new bonds.

AN ACT

To enable city, county, poor, ward, school, borough, and township tax collectors, their executors and administrators if they are deceased, or either surety or sureties, to collect taxes for the payment of which they have become personally liable without having collected the same by the expiration of the authority of their respective bonds, or by the expiration of the authority of their respective warrants, or by the expiration of their terms of office; and to extend the time for the collection of the same for a period of two years from the passage of this act.

Tax collectors.

Section 1. Be it enacted, &c., That in all cases in which the period of limitation of the warrants of the duplicates of the county, poor, road, city, township, ward, school, and borough tax collectors have expired, and in cases where the power and authority of the said tax collectors have expired or shall expire, during the year one thousand nine hundred and thirty-six, by virtue of the expiration of their terms of office and said tax collector or collectors have or shall become personally liable for the taxes contained in said duplicates and warrants, or any part thereof, by reason of the personal payment or otherwise by said tax collector or collectors of the said taxes, or any part thereof, without having recovered or collected the same from the person or persons against whom they have been levied and assessed, or without having recovered or collected the same from the person or persons owning the property against which the said taxes have been assessed and levied, the said duplicates and warrants and the power and authority of the said tax collectors, in all such cases, are hereby revived and extended for a period of two years after the passage of this act, and the said tax collector or collectors, their executors and administrators if they are deceased, or either surety or sureties, are hereby empowered to proceed and collect said taxes from all such persons who have not paid them, residing in said district within which said taxes are assessed, as well as from all persons who may remove or have removed from said city, ward, township or townships, or boroughs, and have neglected to pay the taxes aforesaid assessed, with the like effect as if said warrant or warrants had not expired or the term of office of said tax
