Section 804. Liability to Repay Compensation Unlawfully Received.—Any person who by reason of the nondisclosure or misrepresentation by him or by another of a material fact (irrespective of whether such nondisclosure or misrepresentation was known or fraudulent) has received any sum as compensation under this act, while any conditions for the receipt of compensation imposed by this act were not fulfilled in his case, or while he was disqualified from receiving compensation, shall be liable to repay to the Unemployment Compensation Fund to the credit of the Employers' Contribution Account a sum equal to the amount so received by him, and such sum shall be collectible in the manner provided in this act for the collection of past due contributions.

ARTICLE IX

SAVING CLAUSE; REPEALS; EFFECTIVE DATE

Section 901. Saving Clause.—The General Assembly Saving clause. reserves the right to amend or repeal all or any part of this act at any time, and there shall be no vested right of any kind against such amendment or repeal. All the rights, privileges, or immunities conferred by this act, or by acts done pursuant thereto, shall exist subject to the power of the General Assembly to amend or repeal. this act at any time.

Section 902. Repeals.—All acts or parts of acts in Inconsistent

consistent herewith are hereby repealed.

Section 903. Effective Date.—This act shall become When effective. effective immediately upon its final enactment.

AN ACT

Making an appropriation, out of the General Fund, to the Department of Labor and Industry for the administration and enforcement of the Unemployment Compensation Law; and providing for the reimbursement of the General Fund by the transfer of a similar amount from the Administration Fund.

Section 1. Be it enacted, &c., That the sum of fifty thousand dollars (\$50,000) is hereby appropriated, out of the General Fund, to the Department of Labor and Industry for payment into the Administration Fund created by the Unemployment Compensation Law, for the payment of salaries, wages, or other compensation of officers and employes, for the payment of postage, traveling expenses, mileage charges to the Department of Property and Supplies for the use of automobiles.

telephone rentals, telephone toll charges, telegrams, expenses of operating and maintaining automobile and other motor equipment, for the purchase of supplies, furniture, automobiles, and equipment, for the payment of rentals for buildings and other accommodations, for the payment of the cost of printing, and for the payment of any other expenses whatsoever necessary for the proper conduct of the work of the Department of Labor and Industry, the Unemployment Compensation Board of Review, and other agencies within the department in administering and enforcing the Unemployment Compensation Law.

Section 2. In order to reimburse the General Fund for the appropriation made by section one of this act, the sum of fifty thousand dollars (\$50,000) shall be transferred from the Administration Fund to the General Fund, in such amounts, at such times, as the Department of Labor and Industry, with the approval of the Governor, shall direct. Such transfers shall be made by the State Treasurer upon requisitions of the

Department of Labor and Industry.

A SUPPLEMENT

To act number seventy-seven-A, approved the twentieth day of July, one thousand nine hundred thirty-five (one thousand nine hundred thirty-five—Appropriation Acts, page seventy-one), entitled "An act to provide for the ordinary expenses of the Executive, Legislative, and Judicial Departments of the Commonwealth, interest on the public debt, and the support of the public schools for two years beginning June first, one thousand nine hundred and thirty-five; and for the payment of bills incurred and remaining unpaid at the close of the fiscal year ending May thirty-first, one thousand nine hundred and thirty-five," making an appropriation for the payment of certain expenses of the General Assembly convened in extraordinary session on the first day of December, one thousand nine hundred thirty-six.

Section 1. Be it enacted, &c., That the sum of ten thousand dollars (\$10,000), or as much thereof as may be necessary, is hereby appropriated to the Department of Property and Supplies for the payment of the cost of printing, including printing processes such as binding, ruling, and engraving, for the payment of telephone toll charges and telegrams, and for the purchase of paper, envelopes, stationery, supplies, and equipment required for the General Assembly convened in extraordinary session on the first day of December, one thou-
