AN ACT

To further amend section nine of the act, approved the ninth day of June, one thousand nine hundred and eleven (Pamphlet Laws, seven hundred thirty-six), entitled "An act making appropriations to institutions not wholly managed by the Commonwealth of Pennsylvania, liens on the premises of such institutions for the use of the Commonwealth, and providing for the collection thereof," authorizing the use of, and appropriating the proceeds of insurance for rebuilding, reequipping and repairing of property, subject to lieu.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. Section nine of the act, approved the ninth Appropriations to institutions not day of June, one thousand nine hundred and eleven (Pamphlet Laws, seven hundred thirty-six), entitled "An act making appropriations to institutions not wholly managed by the Commonwealth of Pennsylvania, liens on the premises of such institutions for the use of the Commonwealth, and providing for the collection thereof," as amended by the act, approved the second day of May, one thousand nine hundred and twenty-nine (Pamphlet Laws, one thousand five hundred and thirty-five), is hereby further amended to read as follows:

Section 9. In cases where real estate owned by institutions, corporations, or unincorporated associations, which have received appropriations of money made by the Commonwealth for the structures, erections, or permanent improvements of any kind, and for which the Commonwealth shall have a lien as herein provided, or as provided by any other act of Assembly, shall be sold or taken by eminent domain, and other property of equal or greater value be acquired by such institutions. corporations, or unincorporated associations, the Auditor General shall, upon the entry of a lien upon such acquired property in favor of the Commonwealth for an amount equal to that theretofore existing, release the real estate from the lien to which it was theretofore subject.

In cases where any such structures, erections, or improvements, are destroyed or damaged by fire or other casualty, against which insurance is carried by the institution, corporation, or unincorporated association, the proceeds of such insurance, if carried for the benefit of the Commonwealth to protect its lien, may, with the consent of the Department of Welfare, be expended for the rebuilding and reequipping, or the repair, as the case may be, of the property covered by the lien of the Commonwealth, or of any part thereof. Any such insurance proceeds made payable to the Com-

Insurance proceeds, in case of fire or other casualty, may be expended for rebuilding, repair-ing, etc., with consent of Department of Welfare.

Lien shall attach to new construction or repair.

Act effective immediately. monwealth are hereby appropriated to the Department of Welfare for such purposes. In all such cases the original lien shall continue and shall attach to the new construction, equipment or repairs.

Section 2. The provisions of this act shall become effective immediately upon final enactment.

No. 6 AN ACT

Relating to officers and employes of the Senate and House of Representatives; abolishing certain positions, creating other positions, providing compensation for positions created, changing certain existing compensations, making an appropriation, and ratifying action already taken in relation thereto.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Senate washroom custodian position abolished. Senate to elect chief custodian. Section 1. In the Senate, the position of custodian of washroom is hereby abolished. In addition to the employes of the Senate now provided for by law, the Senate is hereby authorized to elect one chief custodian and to prescribe his duties. The chief custodian so elected shall receive a salary of twenty-four hundred dollars (\$2,400) per annum.

Section 2. In the House of Representatives, the sal-

Salary of House storeroom superintendent reduced.

Chief Clerk of House to appoint one messenger.

Salary of House parliamentarian. reduced from three thousand dollars (\$3,000) as now provided by law, to eighteen hundred dollars (\$1,800) per annum. In addition to the employes of the House of Representatives now provided for by law, the Chief Clerk of the House of Representatives is hereby authorized to appoint one messenger and to prescribe his duties. The messenger so appointed shall receive a salary of twelve hundred dollars (\$1,200) per annum. The parliamentarian of the House of Representatives shall receive a salary of four thousand dollars (\$4,000) per

Salaries of custodians and pages in House and Senate. annum.

Section 3. For each regular biennial, special or extraordinary session, the assistant custodians of the Senate chamber and the hall of the House of Representatives shall each receive four dollars (\$4) per diem, and one hundred dollars (\$100) per month during the interim between legislative sessions.
