All permit fees collected under the provisions of this act shall be paid into the State Treasury.

To add subsection (c) to section 2503 of the act, approved the tenth day of March, one thousand nine hundred forty-nine (Pamphlet Laws 30), entitled "An act relating to the public school system, including certain provisions applicable as well to private and parochial schools; amending, revising, consolidating and changing the laws relating thereto," by supplying an omission from former law, providing for reimbursement for nonresident children; and validating such reimbursements heretofore made.

The General Assembly of the Commonwealth of Penn-

sylvania hereby enacts as follows:

Section 1. Section 2503 of the act, approved the tenth day of March, one thousand nine hundred fortynine (Pamphlet Laws 30), entitled "An act relating to the public school system, including certain provisions applicable as well to private and parochial schools; amending, revising, consolidating and changing the laws relating thereto," as amended by the act, approved the twenty-third day of May, one thousand nine hundred forty-nine (Pamphlet Laws 1806), is hereby further amended by adding, at the end thereof, a new subsection to read as follows:

Section 2503. Payments on Account of Tuition.—

(c) Each school district, regardless of classification, which accepts any non-resident child in its schools under the provisions of section one thousand three hundred five of the act to which this is an amendment, shall be paid by the Commonwealth an amount equal to the tuition charge per elementary pupil or the tuition charge per high school pupil, as the case may be, as defined in section two thousand five hundred sixty-one of the act to which this is an amendment, for each pupil so accepted. In the case of pupils attending the district's public schools for less than a full school term, the tuition
