Department of Property and Supplies, with approval of Governor, authorized to sell and convey certain land in City and County of Erie,

Description.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The Department of Property and Supplies acting on behalf of the Commonwealth of Pennsylvania, with the approval of the Governor, is hereby authorized to sell at public sale to the highest bidder and convey the following described tract of land situate in the City of Erie, County of Erie and Commonwealth of Pennsylvania, bounded and described as follows:

Beginning at an iron pin located 116.95 feet northerly of the northerly end of Wayne Street, measured along the west line of Wayne Street extended and 205 feet westerly at right angles from said west line extended of Wayne Street: thence north 26 degrees 52 minutes west 1478.72 feet, more or less, to a point; thence north 53 degrees 15 minutes west 1253.21 feet, more or less, to a point; thence south 19 degrees 12 minutes 30 seconds east 933.33 feet, more or less, to a point; thence south 13 degrees 30 seconds east 395.51 feet, more or less, to a point; thence south 80 degrees 56 minutes west 456.12 feet, more or less, to a point; thence south 15 degrees 14 minutes east 1574.05 feet, more or less, to a point; thence south 31 degrees 45 minutes east 68.14 feet, more or less, to a point; thence north 74 degrees 30 minutes east 122.42 feet, more or less, to a point; thence north 14 degrees 49 minutes west 82.40 feet, more or less, to a point; thence north 12 degrees 40 minutes 30 seconds east 404.43 feet, more or less, to a point; thence north 72 degrees 45 minutes east 1142.82 feet, more or less, to an iron pin, the place of beginning. The conveyance shall be made under and subject, nevertheless, to all easements, servitudes and rights of others, including, but not confined to, streets, roadways and rights of any telephone, telegraph, water, electric, gas or pipe line companies, as well as under and subject, nevertheless, to any estates or tenancies vested in third persons, whether or not appearing of record, for any portion of the said land or improvements erected thereon.

Section 3. The deed of conveyance shall be approved by the Department of Justice and shall be executed by the Secretary of Property and Supplies in the name of the Commonwealth of Pennsylvania.
