Authorizing the Department of Property and Supplies to sell and convey a certain tract of land consisting of .831 acre in the fifteenth ward of the City of Allentown, Lehigh County, Pennsylvania, and providing for the disposition of the proceeds of the purchase moneys.

sylvania hereby enacts as follows:

Section 1. The Department of Property and Supplies, with the approval of the Governor, is hereby authorized on behalf of the Commonwealth of Pennsylvania to sell at public sale to the highest bidder, the following described tract of land, situate in the fifteenth ward of the City of Allentown, Lehigh County, Penn- Lehigh County. sylvania, bounded and described as follows:

Beginning at a point in the northerly side line of Description. River Drive, said point being distant northerly 154.9 feet from station 774+75.18 of the stone monumented center line of the Lehigh and Susquehanna Railroad, measured on a radical line therefrom, being at the end of the ninth course in the conveyance from the Commonwealth of Pennsylvania to the Central Railroad Company of Pennsylvania dated October 31, 1951;

AN ACT

To add section five *to the act, approved the second day of July, one thousand nine hundred thirty-seven (Pamphlet Laws 2772), entitled "An act to require certain records of oil and gas wells drilled in the Commonwealth showing the location of the same and the geologic formations encountered therein, and to make copies of such records available upon payment of prescribed fees; and providing fees and penalties," by requiring all fees which have been collected or are collected in the future to be transmitted to the State Treasurer through the Department of Revenue and credited to the General Fund, and directing that appropriations to carry out the provisions of the act are made from the General Fund upon proper budgetary request.
