encountered therein, and to make copies of such records available upon payment of prescribed fees; and providing fees and penalties," is hereby amended by adding, immediately following section four thereof, a new section to read as follows:

Section 5. The Department of Internal Affairs is directed to transmit all fees heretofore collected and all fees collected in the future under the provisions of this act to the State Treasurer, through the Department of Revenue, for deposit to the credit of the General Fund, and appropriations to carry out the provisions of this act are to be made from the General Fund upon proper budgetary request.

Disposition of fees collected under provisions of act.

Section 2. The provisions of this act shall become effective immediately upon final enactment.

Authorizing the Department of Property and Supplies to sell and convey 3.01 acres, more or less, of land situate in Collier Township, Allegheny County, Pennsylvania, with the approval of the Governor.

sylvania hereby enacts as follows:

Section 1. The Department of Property and Supplies, with the approval of the Governor, is hereby authorized on behalf of the Commonwealth of Pennsylvania to sell at public sale to the highest bidder, the following described tract of land, situate in the Township of Collier, County of Allegheny and Commonwealth of Pennsylvania, bounded and described as follows:

Section 3. All moneys received from the sale of the land herein authorized to be conveyed shall be paid into the General Fund of the State Treasury.

Section 4. The tract of land herein authorized to be sold shall be sold free of any limitations or rights of reversion, more particularly set forth in section one of the act. approved the twenty-ninth day of September, one thousand nine hundred thirty-eight (Pamphlet Laws 53), entitled, as amended, "An act relating to institutions of counties, cities, wards, boroughs, townships, institution districts and other political subdivisions, for the care, maintenance, and treatment of mental patients; providing for the transfer to the Commonwealth for the care, maintenance and treatment of mental patients of such institutions, and all grounds, lands, buildings and personal property of such political subdivisions used for the care and maintenance of indigent persons connected with such mental institutions; providing for the management and operation or closing and abandonment thereof; and the maintenance of mental patients therein; including the collection of maintenance in certain cases; providing for the retransfer of certain property to counties, cities, wards, boroughs, townships, institution districts and other political subdivisions under certain circumstances; conferring and imposing upon the Governor, the Department of Welfare, the courts of common pleas and counties, cities, wards, boroughs, townships, institution districts and other political subdivisions certain powers and duties; prohibiting cities, counties, wards, boroughs, townships, institution districts and other political subdivisions from maintaining and operating institutions, in whole or in part, for the care and treatment of mental patients; and repealing inconsistent laws," and to such extent the provisions thereof are hereby repealed.

sylvania hereby enacts as follows:

Section 5.

Section 1. The consent of the Commonwealth of Pennsylvania is hereby granted, in accordance with the seventeenth clause, eighth section of the first article of the Constitution of the United States, to the acquisition by the United States of America of two tracts of land in the Township of Butler, County of Butler, known as the Veterans Administration Hospital, the first tract being bounded and described as follows:

Beginning at a point on the center line of State Highway Route No. 68, at the distance of 534.4 feet measured S 88° 30' W from a point common to the lands of Mc-Candless Heirs and Walter A.
