Section 2. In the taking of acknowledgements and Certificate. the performing of other notarial acts requiring certification, a certificate endorsed upon or attached to the instrument or documents which shows the date of the notarial act, and which states in substance that the person appearing before the officer acknowledges the instrument as his act, or made or signed the instrument or document under oath, shall be sufficient for all intents and purposes. The instrument or document shall not be rendered invalid by the failure to state the place of execution or acknowledgement.

Section 3. If the signature, rank and branch of service, or subdivision thereof, of any such commissioned officer appear upon such instrument or document or certificate, no further proof of the authority of such officer so to act shall be required; and such action by such commissioned officer shall be prima facie evidence that the person making such oath or acknowledgement is within the purview of this act.

Section 4. The provisions of this act shall become effective immediately upon final enactment.

AN ACT

To further amend section 1169 of the act, approved the tenth day of March, one thousand nine hundred forty-nine (Pamphlet Laws 30), entitled "An act relating to the public school system, including certain provisions applicable as well to private and parochial schools; amending, revising, consolidating and changing the laws relating thereto," by providing that school districts may make payment of salary to teachers on sabbatical leave who receive a grant for fellowship or from a foundation to an amount where the salary and the grant equal their salary payable during the year of leave.

Section 1169. Salary While on Leave.—The person on leave of absence shall receive one-half of his or her regular salary [: Provided, That the employe who is absent on sabbatical leave shall not receive] but not more than two thousand five hundred dollars (\$2500), if the employe's absence on sabbatical leave is for a full school year, and not more than one thousand two hundred fifty dollars (\$1250), if the employe's absence on sabbatical leave is for a half school year, as defined in this act. A school district may, but shall not be required to, pay a teacher on leave, during the period of leave, any salary over and above the amount received by the teacher as a grant for a fellowship or from a foundation that would make the total of the grant and the payment together not to exceed the salary payable during the year of leave.
