## AN ACT

To further amend the act, approved the ninth day of April, one thousand nine hundred twenty-nine (Pamphlet Laws 177), entitled "An act providing for and reorganizing the conduct of the executive and administrative work of the Commonwealth by the Executive Department thereof and the administrative departments, boards, commissions, and officers thereof, including the boards of trustees of State Normal Schools, or Teachers Colleges; abolishing, creating, reorganizing or authorizing the reorganization of certain administrative departments, boards and commissions; defining the powers and duties of the Governor and other executive and administrative officers, and of the several administrative departments, boards, commissions, and officers; fixing the salaries of the Governor, Lieutenant Governor, and certain other executive and administrative officers; providing for the appointment of certain administrative officers, and of all deputies and other assistants and employes in certain departments, boards, and commissions; and prescribing the manner in which the number and compensation of the deputies and all other assistants and employes of certain departments, boards and commissions shall be determined," by changing the name of the Selinsgrove State Colony for Epileptics.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. As much as applies to the Department of Welfare of section 202 of the act, approved the ninth day of April, one thousand nine hundred twenty-nine (Pamphlet Laws 177), entitled "An act providing for and reorganizing the conduct of the executive and administrative work of the Commonwealth by the Executive Department thereof and the administrative departments, boards, commissions, and officers thereof, including the boards of trustees of State Normal Schools. or Teachers Colleges: abolishing, creating, reorganizing or authorizing the reorganization of certain administrative departments, boards, and commissions; defining the powers and duties of the Governor and other executive and administrative officers, and of the several administrative departments, boards, commissions, and officers; fixing the salaries of the Governor, Lieutenant Governor, and certain other executive and administrative officers; providing for the appointment of certain administrative officers, and of all deputies and other assistants and employes in certain departments, boards, and commissions; and prescribing the manner in which the number and compensation of the deputies and all other assistants and employes of certain departments, boards and commissions shall be determined," as last amended by the acts, approved the twenty-sixth day of March, one thousand nine

As much as applies to Department of Welfare of section 202, act of April 9, 1929, P. L. 177, as last amended by acts of March 26, 1945, P. L. 63, May 25, 1945, P. L. 1015, May 31, 1945, P. Section 202. In addition to the foregoing, there are hereby created, as departmental administrative boards in the Department of Welfare, boards of trustees for the respective institutions which are acquired by the Commonwealth from counties, cities or institution districts for actual use as State mental hospitals under the provisions of act number twenty-one, approved the twenty-ninth day of September, one thousand nine hundred thirty-eight. Each respective board of trustees shall be known as the Board of Trustees of the

(descriptive name of political subdivision in which institution is located) State Hospital;

Section 2. Section 401 of said act, as last amended Section 401, said by the acts, approved the twenty-fourth day of May, one thousand nine hundred fifty-one (Pamphlet Laws 353), and the seventeenth day of August, one thousand nine hundred fifty one (Pamphlet Laws 1951, P. L. 1245, P. L. 124 nine hundred fifty-one (Pamphlet Laws 1245), is hereby further amended. further amended to read as follows:

Section 401. Board of Trustees of State Institutions. -The boards of trustees of each of the State institutions hereinafter mentioned shall consist of nine members. and the head of the department having supervision over the institution ex officio.

The terms of the members of each such board shall be four years, and until their successors are gualified.

Five members of any such board shall constitute a quorum.

Each such board shall annually elect a president and vice-president from among its members, and a secretary and treasurer who need not be members of the board. The secretary and treasurer may be the same person.

Provided. That from and after the third Tuesday of January, one thousand nine hundred and forty-three, the terms of the first three members to be appointed by the Governor to each of the following boards of trustees shall expire on the third Tuesday of January, one thousand nine hundred and forty-five, and the terms of the next three members to be appointed shall expire on the third Tuesday of January, one thousand nine hundred and forty-seven, and the terms of the next three members shall expire on the third Tuesday of January, one thousand nine hundred and forty-nine; the successors to each of the above mentioned members shall be appointed for terms of six years, and all appointments thereafter shall be for terms of six years, except those to fill vacancies created prior to the end of any term, which shall be only for the duration of the unexpired term:

## AN ACT

To further amend the act, approved the twenty-first day of January, one thousand nine hundred forty-seven (Pamphlet Laws 3), entitled "An act relating to officers and employes of the General Assembly; fixing the number, qualifications, compensation, mileage and duties of the officers and employes of the Senate and of the House of Representatives; providing for their election or appointment, term of office, or of service, removal, and manner of filling vacancies; and making appropriations to the Senate, House of Representatives and Legislative Reference Bureau," by changing the compensation of certain officers and employes.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. Sections 1, 2, 3, 4, 5, 6, 7 and 8, clauses (1) and (2) of section 21, and sections 22, 23, 24, 25, 26 and 47 of the act, approved the twenty-first day of January, one thousand nine hundred forty-seven (Pamphlet Laws 3), entitled "An act relating to officers and employes of the General Assembly; fixing the number, qualifications, compensation, mileage and duties of the officers and employes of the Senate and of the House of Representatives; providing for their election or appointment, term of office, or of service, removal, and manner of filling vacancies; and making appropriations to the Senate, House of Representatives and Legislative Reference Bureau," as last amended by the act, approved the sixth day of March, one thousand nine hundred fiftyone (Pamphlet Laws 18), and in part by the act, approved the twenty-eighth day of September, one thousand nine hundred fifty-one (Pamphlet Laws 1565), are hereby further amended to read as follows:
