Any person violating the provisions of this subsection shall be immediately removed from any position or office, if any, held under the provisions of clause (1) of section four of this act, and in addition thereto, he shall be sentenced to pay a fine, not to exceed one thousand dollars (\$1000), and to imprisonment, not to exceed one (1) year, or both.

Section 10. The act, approved the first day of May, one thousand nine hundred forty-five (Pamphlet Laws 370), entitled "An act relating to settlements; abolishing settlement and residence as a factor in eligibility for receiving public assistance, or liability of the Commonwealth, or any political subdivision thereof for granting assistance; and repealing inconsistent legislation," is hereby repealed.

Act of May 1, 1945, P. L. 370, repealed.

Section 11. All other acts or parts of acts inconsistent with the provisions of this act are hereby repealed.

Inconsistent acts repealed.

Section 12. This act shall become effective immediately upon final enactment.

AN ACT

To amend section 6 of the act, approved the twentieth day of May, one thousand nine hundred forty-nine (Pamphlet Laws 1633), entitled "An act providing and regulating State assistance for housing, including slum clearance and redevelopment; and making an appropriation," by changing limitation as to tenant admissions in urban redevelopment projects.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. Section 6 of the act, approved the twentieth day of May, one thousand nine hundred forty-nine (Pamphlet Laws 1633), entitled "An act providing and regulating State assistance for housing, including slum clearance and redevelopment; and making an appropriation," is hereby amended to read as follows:

Section 6. Tenant Limitations.—No capital grant pursuant to section 4 (a) of this act shall be made for any housing project unless the agency, authority or corporation receiving such capital grant shall contract to maintain rent levels within the means of persons of limited income as established by the State Planning Board and embodied in the contract, as hereinafter provided, which shall be substantially below those now available through equivalent non-subsidized construction and to limit the

"Housing and Redevelopment Assistance Law." Section 6, act of May 20, 1949, P. L. 1633, amended. tenant admissions of such project to families whose aggregate income does not exceed six times the net rental of the housing unit to be furnished any such family: Provided, however, That when this category of families is exhausted, then tenant admissions shall be limited to families whose aggregate income does not exceed eight times the net rental of the housing unit to be furnished any such family.

Employment by any specific employer or employers shall not be a requisite for occupancy in any housing

project built under the provision of this act.

Priority in occupancy shall be given to veterans and families of veterans for five years after the effective date of this act and thereafter, at the discretion of the board, and, so far as is consistent with the objectives of this act, to persons displaced by the necessary operations of public housing and redevelopment projects and other public improvements: Provided, That such persons or families meet the income qualifications established by the board.

AN ACT

Authorizing the Department of Property and Supplies, with the approval of the Governor, to acquire a tract of land comprised of three smaller tracts, together with the improvements thereon, erected in Susquehanna Township, Dauphin County, Pennsylvania, consisting of approximately seven acres, for use of the State Farm Products Show Commission; and making an appropriation.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The Department of Property and Supplies, with the approval of the Governor, is hereby authorized to acquire, in the name of the Commonwealth of Pennsylvania, for the use of the State Farm Products Show Commission, a tract of land consisting of three (3) smaller tracts, together with all improvements thereon erected, in the Township of Susquehanna, County of Dauphin, and Commonwealth of Pennsylvania, adjoining property now owned by the Commonwealth of Pennsylvania, and in the immediate vicinity of the Farm Show Buildings, bounded and described as follows:

Beginning at a point, said point being located at the southwest corner of land now owned by the Commonwealth of Pennsylvania on the easterly side of Cameron Street in the Township of Susquehanna, county of Dauphin, Commonwealth of Pennsylvania, also being the

State Farm Products Show Commission.

Department of Property and Supplies authorized to acquire certain land in Susquehanna Township, Dauphin County, for use of said commission.
