

tenant admissions of such project to families whose aggregate income does not exceed six times the net rental of the housing unit to be furnished any such family: *Provided, however, That when this category of families is exhausted, then tenant admissions shall be limited to families whose aggregate income does not exceed eight times the net rental of the housing unit to be furnished any such family.*

Employment by any specific employer or employers shall not be a requisite for occupancy in any housing project built under the provision of this act.

Priority in occupancy shall be given to veterans and families of veterans for five years after the effective date of this act and thereafter, at the discretion of the board, and, so far as is consistent with the objectives of this act, to persons displaced by the necessary operations of public housing and redevelopment projects and other public improvements: *Provided, That such persons or families meet the income qualifications established by the board.*

AN ACT

Authorizing the Department of Property and Supplies, with the approval of the Governor, to acquire a tract of land comprised of three smaller tracts, together with the improvements thereon, erected in Susquehanna Township, Dauphin County, Pennsylvania, consisting of approximately seven acres, for use of the State Farm Products Show Commission; and making an appropriation.

Description.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The Department of Property and Supplies, with the approval of the Governor, is hereby authorized to acquire, in the name of the Commonwealth of Pennsylvania, for the use of the State Farm Products Show Commission, a tract of land consisting of three (3) smaller tracts, together with all improvements thereon erected, in the Township of Susquehanna, County of Dauphin, and Commonwealth of Pennsylvania, adjoining property now owned by the Commonwealth of Pennsylvania, and in the immediate vicinity of the Farm Show Buildings, bounded and described as follows:

Beginning at a point, said point being located at the southwest corner of land now owned by the Commonwealth of Pennsylvania on the easterly side of Cameron Street in the Township of Susquehanna, county of Dauphin, Commonwealth of Pennsylvania, also being the

northwest corner of the land to be acquired; thence eastwardly along land owned by the Commonwealth of Pennsylvania to other land owned by the Commonwealth of Pennsylvania and used by the Harrisburg State Hospital; thence southwardly along land owned by the Commonwealth of Pennsylvania four hundred fifty (450) feet, more or less, to other land owned by the Commonwealth of Pennsylvania and the southeast corner of the land to be acquired; thence westwardly along land owned by the Commonwealth of Pennsylvania and used by the Harrisburg State Hospital to the easterly side of Cameron Street; thence in a northerly direction along the easterly side of Cameron Street four hundred fifty (450) feet, more or less, to the place of beginning; together with all improvements thereon erected; containing seven (7) acres, more or less, and being the same or a part of the same premises now or lately owned by the John E. Fox Estate, Sarah Hepford Estate and Amos Frazee Estate.

Being clause.

Section 2. Such land shall not be acquired until the title thereto has been approved by the Department of Justice.

Approval of title.

Section 3. The sum of seventy-five thousand dollars (\$75,000), or as much thereof as may be necessary, is hereby appropriated to the Department of Property and Supplies for the payment of the acquisition of such tracts of land and expenses incidental thereto, including the completion of an abstract of title thereon.

Appropriation.

Section *4. The provisions of this act shall become effective immediately upon final enactment.

Act effective immediately.

AN ACT

To further amend the last paragraph of section five hundred seven of the act, approved the ninth day of April, one thousand nine hundred twenty-nine (Pamphlet Laws 177), entitled "An act providing for and reorganizing the conduct of the executive and administrative work of the Commonwealth by the Executive Department thereof and the administrative departments, boards, commissions, and officers thereof, including the boards of trustees of State Normal Schools, or Teachers Colleges; abolishing, creating, reorganizing or authorizing the reorganization of certain administrative departments, boards, and commissions; defining the powers and duties of the Governor and other executive and administrative officers, and of the several administrative departments, boards, commissions, and officers; fixing the salaries of the Governor, Lieutenant Governor, and certain other executive and administrative
