AN ACT

To further amend the act, approved the ninth day of April, one thousand nine hundred twenty-nine (Pamphlet Laws 177). entitled "An act providing for and reorganizing the conduct of the executive and administrative work of the Commonwealth by the Executive Department thereof and the administrative departments, boards, commissions, and officers thereof. including the boards of trustees of State Normal Schools, or Teachers Colleges; abolishing, creating, reorganizing or authorizing the reorganization of certain administrative departments, boards, and commissions; defining the powers and duties of the Governor and other executive and administrative officers, and of the several administrative departments, boards. commissions, and officers; fixing the salaries of the Governor, Lieutenant Governor, and certain other executive and administrative officers; providing for the appointment of certain administrative officers, and of all deputies and other assistants and employes in certain departments, boards, and commissions; and prescribing the manner in which the number and compensation of the deputies and all other assistants and employes of certain departments, boards and commissions shall be determined," by transferring certain departmental administrative boards within the Department of Welfare to the Department of Justice; changing the title of certain boards of trustees and defining their duties.

As much as applies to Departments of Justice and Welfare of section 202, act of April 9, 1929, P. L. 177, as last amended by acts of March 26, 1945, P. L. 63, May 25, 1945, P. L. 1015, May 31, 1945, P. L. 1214. and June 6, 1945, P. L. 1398, further amended.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. As much as applies to the Departments of Justice and Welfare of section two hundred two of the act, approved the ninth day of April, one thousand nine hundred twenty-nine (Pamphlet Laws 177), entitled "An act providing for and reorganizing the conduct of the executive and administrative work of the Commonwealth by the Executive Department thereof and the administrative departments, boards, commissions, and officers thereof, including the boards of trustees of State Normal Schools, or Teachers Colleges; abolishing, creating, reorganizing or authorizing the reorganization of certain administrative departments, boards, and commissions; defining the powers and duties of the Governor and other executive and administrative officers, and of the several administrative departments, boards, commissions, and officers; fixing the salaries of the Governor, Lieutenant Governor, and certain other executive and administrative officers; providing for the appointment of certain administrative officers, and of all deputies and other assistants and employes in certain departments, boards, and commissions; and prescribing the manner in which the number and compensation of the deputies and all other assistants and employes of certain departments, boards and commissions shall be determined," as last amended by the acts, approved the twenty-sixth day of March, one thousand nine hundred forty-five (Pamphlet Laws 63), the twenty-fifth day of May, one thousand nine hundred forty-five (Pamphlet Laws 1015), the thirty-first day of May, one thousand nine hundred forty-five (Pamphlet Laws 1214), and the sixth day of June, one thousand nine hundred forty-five (Pamphlet Laws 1398), is hereby further amended to read as follows:

Section 202. Departmental Administrative Boards, Commissions, and Offices.—The following boards, commissions, and offices are hereby placed and made departmental administrative boards, commissions, or offices, as the case may be, in the respective administrative departments mentioned in the preceding section, as follows:

In addition to the foregoing, there are hereby created, as departmental administrative boards in the Department of Welfare, boards of trustees for the respective institutions which are acquired by the Commonwealth from counties, eities or institution districts for actual use as State mental hospitals under the provisions of act number twenty-one, approved the twenty-ninth day of September, one thousand nine hundred thirty-eight. Each respective board of trustees shall be known as the Board of Trustees of the

State Hospital;

Section 2. Article nine of said act, as last amended by the act, approved the twenty-first day of June, one thousand nine hundred thirty-seven (Pamphlet Laws 1865), is hereby further amended by adding, immediately following section nine hundred fifteen, a new section to read as follows:

Article IX, said act, as last amended by act of June 21, 1937, P. L. 1865, further amended by adding, immediately following section 915, a new section numbered 916.

Section 916. Boards of Trustees of State Institutions. -The boards of trustees of each State institution within the Department of Justice and the Commissioner of Correction shall have general direction and control of the property and management of such institutions. Together they shall have the power and their duties shall be:

- (a) Subject to the approval of the Governor, to appoint a superintendent or warden of the institution who shall, subject to the authority of the board and the Commissioner of Correction, administer the institution in accordance with law.
- (b) On nomination by the superintendent or warden, from time to time, to appoint such officers and employes as may be necessary.

(c) To fix the salaries of the employes in conformity with the standards established by the Executive Board.

(d) Subject to the approval of the Department of Justice, to make such by-laws, rules and regulations for the management of the institution.

The Governor, by Executive Order, shall designate which of the powers and duties referred to above shall be exercised by the Commissioner of Correction and which shall be exercised by the boards of trustees. Said order need not be uniform or applicable to all institutions.
