# AN ACT

To further amend the act, approved the twenty-second day of June, one thousand nine hundred thirty-one (Pamphlet Laws 594), entitled "An act establishing certain township roads as State highways; authorizing their construction, maintenance and improvement under certain conditions and restrictions; limiting the obligation of the Commonwealth in the construction of certain structures located on such highways; conferring certain powers upon the Department of Highways and local authorities, persons, associations and corporations for sharing the cost of the maintenance and construction of such highways; and making an appropriation to carry out the provisions of said act," by changing certain routes and adding a new route.

State highways.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Routes 12001 and 17069, act of June 22, 1931,P. L. 594, amended. Section 1. The following routes established by the act, approved the twenty-second day of June, one thousand nine hundred thirty-one (Pamphlet Laws 594), entitled "An act establishing certain township roads as State highways; authorizing their construction, maintenance and improvement under certain conditions and restrictions; limiting the obligation of the Commonwealth in the construction of certain structures located on such highways; conferring certain powers upon the Department of Highways and local authorities, persons, associations and corporations for sharing the cost of the maintenance and construction of such highways; and making an appropriation to carry out the provisions of said act," and its amendments, are hereby amended to read as follows:

Route 12001. Beginning at a point on Route 105 near Route 597, thence in a southeasterly direction in Grove Township about 0.7 of a mile [to a Forest Road and from a point on the Forest Road near the head of Wykoff Run thence in a southeasterly course in Gibson Township in the direction of Karthaus to the Cameron-Clearfield County line,] in Cameron County [, a distance of about 2.7 miles].

Route 17069. Beginning at a point on Route 17068 about 2.5 miles north of Karthaus, thence in a northerly direction [toward Driftwood to a point on the Cameron-Clearfield County line] in Karthaus Township, in Clearfield County, a distance of about [6] 2.7 miles.

Section 2. Said act is hereby further amended by adding thereto the following new route:

Route 17140 established.

# Clearfield County

Route 17140. Beginning at a point on Route 865 at Keewaydin, thence northeasterly in Covington and Karthaus Townships to Route 17068, in Clearfield County, a distance of about 2.5 miles.

Section 3. This act shall become effective immediately Act effective immediately. upon final enactment.

# AN ACT

Establishing a section of public road in Elk County as a State highway, and providing for the construction, reconstruction and maintenance thereof at the expense of the Commonwealth.

The General Assembly of the Commonwealth of Penn-State highway established. sylvania hereby enacts as follows:

Section 1. The section of public road beginning at a point on State Highway, Route 411, at Medix Run and extending southerly and easterly in Benezette Township, Elk County, a distance of about 9.3 miles is hereby established as a State highway to be constructed, reconstructed and maintained at the expense of the Commonwealth under the provisions of present or future laws governing State highways.

Section 2. This act shall become effective immediately Act effective immediately. upon final enactment.
