north 131/4 degrees west 115.5 feet to an iron pin the place of beginning, containing 38.5 perches, more or less, of land.

And being the same land conveyed to the Old Brown's Mill School Memorial Association by deed of the School District of Antrim Township, Franklin County, dated January 7, 1935, and recorded in Franklin County, Deed Book number 252 at page 559.

Section 2. The land shall not be acquired until its title has been approved by the Department of Justice and not before the sum of three thousand dollars (\$3000) is paid by the Old Brown's Mill School Memorial Association into the State Treasury for use of the Historical and Museum Commission for the repair and maintenance of the building.

Section 3. After title is acquired by the Commonwealth, the Pennsylvania Historical and Museum Commission is authorized to acquire, by gift, all the assets of the Old Brown's Mill School Memorial Association, and the commission shall have power to adopt and carry into effect, plans for its maintenance using therefor any funds at the disposal of the commission, and to make and enforce rules and regulations for the preservation of the property and visitation thereof by the public.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The last paragraph of section five, act of May 23, one thousand eight hundred seventy-four (Pamphlet Laws 230), entitled "An act dividing the cities of this state into three classes, regulating the passage of ordinances, providing for contracts for supplies and work for said cities, authorizing the increase of in-

AN ACT

Amending the act of June twenty-four, one thousand nine hundred thirty-seven (Pamphlet Laws 2051), entitled "An act relating to public assistance; providing for and regulating assistance to certain classes of persons designated and defined as dependent children, aged persons, blind persons and other persons requiring relief; providing for the administration of this act by the Department of Public Assistance and county boards of assistance hereby created for this purpose; authorizing the Department of Public Assistance to cooperate with, and to accept and disburse moneys received from, the United States Government for assistance to such persons; providing for the liquidation of the State Emergency Relief Board, Boards of Trustees of the Mothers' Assistance Fund, and Boards of Trustees of Pension Fund for the Blind; and repealing laws relating to mothers' assistance, pensions for the blind, old age assistance, and the State Emergency Relief Board," including financial assistance for nursing home care within the word assistance, and making an appropriation.

The General Assembly of the Commonwealth of Penn-Public Assistance sylvania hereby enacts as follows:

Section 1. Section two, act of June twenty-four, one thousand nine hundred thirty-seven (Pamphlet Laws 2051), known as the "Public Assistance Law," amended. August twenty-two, one thousand nine hundred fiftythree (Pamphlet Laws 1361), is amended to read:

Definitions.—As used in this act, unless Section 2. otherwise indicated.

"Assistance" means assistance in money, goods, shelter, medical care, work relief or services, provided from or with State or Federal funds, for indigent persons who reside in Pennsylvania and need assistance to provide for themselves and their dependents a decent and healthful standard of living, and for indigent homeless or transient persons. The word, assistance, shall be construed to include pensions for those blind. persons who are entitled to pensions, as provided in this act, and to include also burial for those indigent persons who were receiving assistance at the time of their death. The word, assistance, shall also be construed to include sufficient financial assistance to enable physically disabled persons who require nursing
