but shall not exceed [twenty (20)] thirty (30) days leave with full pay in any one year. No employe's salary shall be paid if the accidental injury is incurred while the employe is engaged in remunerative work unrelated to school duties.

Whenever the boards of school directors of two or more school districts may establish any joint elementary public school, high school or department, or whenever two or more school districts shall merge or form a union school district, the professional or temporary professional employes employed by the several boards of school directors establishing such joint school or department or merged or union school district shall be entitled to the sick leave accumulated in the individual school districts subsequently establishing such joint school or department or merged or union school district.

The board of school directors may require the employe to furnish a certificate from a physician or other practitioner certifying that said employe was unable to perform his or her duties during the period of absence for which compensation is required to be paid under this section.

Act effective immediately.

Section 2. This act shall become effective immediately.

AN ACT

Amending the act of June 24, 1939 (P. L. 872) entitled "An act to consolidate, amend and revise the penal laws of the Commonwealth," changing penalties with respect to misrepresentation of age of minors in the purchase of intoxicating liquor.

The Penal Code.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

of June 24, 1939 (P. L. 1939, P. L. 872, 872), known as "The Penal Code," is amended to read: amended.

Section 675. Misrepresentation of Age by Minor to Secure Liquor.-Whoever, being under the age of twenty-one (21) years, knowingly and falsely represents himself to be twenty-one (21) years of age to any licensed dealer or other person, for the purpose of procuring or having furnished to him, any intoxicating liquors, is guilty of a misdemeanor, and upon conviction thereof, shall be sentenced to pay a fine of not less than one hundred dollars (\$100) and not exceeding [fifty

dollars (\$50)] three hundred dollars (\$300), or undergo imprisonment not exceeding [sixty (60) days] six months, or both.

Section 2. This act shall take effect in ten days.

AN ACT

Authorizing the Pennsylvania Historical and Museum Commis-sion to acquire land on which is located the Old Bradford House in the City of Washington, Washington County; pro-viding for its repair; authorizing an agreement for the ad-ministration thereof by the Washington County Historical Society and replicing an appropriation Society, and making an appropriation.

The General Assembly of the Commonwealth of Penn- Real property. sylvania hereby enacts as follows:

The Pennsylvania Historical and Museum The Pennsyl-Section 1. Commission, with the approval of the Governor, is authorized to purchase, in the name of the Commonwealth of Pennsylvania, a tract of land in the City of Washington, Washington County, on which is erected the Old Bradford House, from Charles W. McWreath, present owner.

The Pennsylvania Historical and Museum Section 2. Commission is directed to repair or contract for the repair of the Old Bradford House to its original state.

Section 3. When the Old Bradford House is repaired, the Pennsylvania Historical and Museum Commission, with the approval of the Governor, is authorized to enter into agreement with the Washington County Historical Society whereby it shall have possession and administration of the property including the grounds, in consideration of the covenant of that society to preserve and maintain the Old Bradford House in a good state of repair and to maintain it as an historic monument open to visitation by the public.

The land shall not be acquired until its Section 4. title has been approved by the Department of Justice.

The sum of fifty thousand Section 5. (\$50,000), or as much thereof as may be necessary, is appropriated to the Pennsylvania Historical and Museum Commission for the payment of the purchase price and incidental expenses, including the completion of an abstract of title, and for the repairing of the Old Bradford House.
