(25) years prior to the current year, which is used for participation in club activities, exhibits, tours, parades, occasional transportation and similar uses, but is not used for general daily transportation.

Section 806. Number of Driving Lamps Required or Permitted.—

. . . . .

(f) Any motor vehicle may be equipped with [not more than] two (2) or more back-up lamps, either separately or in combination with another lamp, except that no such back-up lamp shall be continuously lighted when the motor vehicle is in forward motion.

Section 840. School Buses; Safety Requirements.-

(a) "School Bus," for the purpose of this section, is any vehicle registered as a commerical vehicle, motor bus or motor omnibus, [or any vehicle having a lineal seating space, including the space for the operator, of more than one hundred (100) inches, and] used for the transportation of school children: Provided, That the term "school bus" shall not include any motor buses operated by common carriers holding a certificate of the Public Utility Commission, who also operate such motor buses over routes approved by such commission: And provided further, That all such buses comply with the safety regulations of that commission and the State Council of Education.

\* \* \* \* \*

Penalty.—Any person violating any of the provisions of this section, shall, upon summary conviction before a magistrate, be sentenced to pay a fine of not less than ten dollars (\$10.00) and not more than twenty-five dollars (\$25.00) and costs of prosecution, and, in default of the payment thereof, shall undergo imprisonment for not less than five (5) days and not more than ten (10) days.
