reports under the laws imposing taxes for State purposes, or to pay license fees or other moneys to the Commonwealth, or any agency thereof, every State depository and every debtor or creditor of the Commonwealth," changing the day for rendering certain reports.

The Fiscal Code.

Section 1. Section 901, act of April 9, 1929 (P. L. 343), known as "The Fiscal Code," amended June 1, 1931 (P. L. 318), is amended to read:

Section 901. Reports to the Secretary of Revenue.— On the first Monday after the first Tuesday of each month, it shall be the duty of each city and county officer to render to the Department of Revenue, under oath or affirmation, returns of all moneys received during the preceding month for the use of the Commonwealth, designating, under proper headings, the source from which such moneys were received, and to pay the same into the State Treasury, through the Department of Revenue, less any compensation and reimbursement for expenses allowable by law for having made the collections.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Clause (2), section 2501, act of March 10, 1949, P. L. 30, amended July 27, 1953, P. L. 629, further Section 1. Clause (2) of section 2501, act of March 10, 1949 (P. L. 30), known as the "Public School Code of 1949," amended July 27, 1953 (P. L. 629), is amended to read:

Section 2501. Definitions.—For the purposes of this article the following terms shall have the following meanings:

(2) "Teaching Units" consist of twenty-two (22) high school pupils or thirty (30) elementary school pupils. Fractions thereof shall be fractional teaching units. If a district's pupil-teacher ratio exceeds thirty-

three (33), its district teaching unit shall be obtained by multiplying the total number of all teaching units, as defined above, by thirty-three (33), and dividing the product so obtained by the pupil-teacher ratio of the district. High school pupils are those pupils in a secondary school program classified as such by the Department of Public Instruction, but in no case shall include any pupils below grade seven (7).
