Section 1. Section 699.4, act of June 24, 1939 (P. L. of June 24, 1939 (P. L. 1938, P. L. 872, 872), known as "The Penal Code," is amended to read: amended.

> Section 699.4. Worldly Employment or Business on Sunday.-Whoever does or performs any worldly employment or business whatsoever on the Lord's day, commonly called Sunday (works of necessity and charity only excepted), or uses or practices any game, hunting, shooting, sport or diversion whatsoever on the same day, not authorized by law, shall, upon conviction thereof in a summary proceeding, be sentenced to pay a fine of four dollars (\$4), for the use of the Commonwealth, or, in default of the payment thereof, shall suffer six (6) days' imprisonment.

> Nothing herein contained shall be construed to prohibit the dressing of victuals in private families, bake-houses, lodging-houses, inns and other houses of entertainment for the use of sojourners, travellers or strangers, or to prohibit the sale of newspapers, or to hinder watermen from landing their passengers, or ferrymen from carrying over the water travellers, or persons removing with their families on the Lord's day, commonly called Sunday, nor to the delivery of milk or the necessities of life, before nine of the clock in the forenoon, nor after five of the clock in the afternoon of the same day.

AN ACT

Authorizing the Department of Property and Supplies, with the approval of the Secretary of Public Welfare and the Governor, to assign, transfer and set over to the Pennsylvania Game Commission the control and jurisdiction of 158.89106 acres, more or less, of land situate in Limerick Township, Montgomery County.

Real property.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Department of Property and Supplies, with approval of Sec-retary of Public Welfare and the Governor, authorized to transfer certain land in Limerick Township, Mont-gomery County.

Section 1. The Department of Property and Supplies, with the approval of the Secretary of Public Welfare and the Governor, is hereby authorized on behalf of the Commonwealth of Pennsylvania to transfer, assign and set over to the Pennsylvania Game Commission and its successors in function the use, control and jurisdiction of the following described tract of land in the Township of Limerick, County of Montgomery and Commonwealth of Pennsylvania:

Beginning at a point at the intersection of the center Description. line of Linfield Road (33 feet wide) with the northeasterly side of a 20 feet wide right-of-way (extended); thence along the center line of Linfield Road north 33 degrees 2 minutes 30 seconds east 40.52 feet to a point; thence along land of the Reading Company, the three following courses and distances north 64 degrees 12 minutes east 218.12 feet, north 32 degrees 47 minutes east 183 feet, north 64 degrees 36 minutes east 774.2 feet; thence south 24 degrees 21 minutes east 397.24 feet to a stake: thence south 65 degrees 6 minutes east 840 feet to a point on the westerly bank of the Schuylkill River; thence along said westerly bank of the Schuylkill River the five following courses and distances south 10 degrees 31 minutes west 489.52 feet, south 80 degrees 3 minutes east 103 feet, south 19 degrees 31 minutes east 1252.11 feet, south 13 degrees 6 minutes east 441.49 feet, south 5 degrees 33 minutes west 495.16 feet; thence along lands of the Kinsey Distillery Corporation, the eight following courses and distances south 74 degrees 48 minutes west 122.1 feet, north 69 degrees 2 minutes west 269 feet to a monument, south 80 degrees 48 minutes west 1203.9 feet along a fence to a monument, north 16 degrees 21 minutes west 192.49 feet along a fence, south 76 degrees 6 minutes west 895.48 feet along a fence, north 13 degrees 29 minutes 30 seconds west 1070.97 feet along a fence to a monument, north 78 degrees 38 minutes east 208.74 feet along a fence, north 21 degrees 46 minutes west 1046.90 feet along a fence; thence along lands of the Strafford Knitting Mills, the two following courses and distances north 82 degrees 18 minutes east 150.46 feet, north 4 degrees 22 minutes west 60.08 feet; thence along various owners north 78 degrees 13 minutes east 625.16 feet to a point on the northeasterly side of 20 foot wide right-of-way; thence along said right-ofway, the two following courses and distances north 19 degrees 10 minutes west 560.6 feet to a monument, north 50 degrees 4 minutes west 108.12 feet to a point in the center line of Linfield Road to the place of beginning, containing 158.89106 acres of land, more or less, with the exception of the Reading Railroad Spur right-of-way described as follows: Beginning at a point a corner of lands of Kinsey Distillery Corporation, Strafford Knitting Mills and hereinafter described railroad spur rightof-way; thence partly along lands of Strafford Knitting Mills, north 82 degrees 18 minutes east 482.69 feet to a point; thence on a curve to the left with a radius of 420 feet an arc distance of 637.74 feet to a point; thence north 4 degrees 42 minutes west 240.08 feet to a point; thence on a curve to the right with a radius of 480 feet an arc distance of 418.04 feet to a point; thence north 45 degrees 12 minutes east 76.45 feet to a point; thence

along lands of the Reading Company, north 64 degrees 36 minutes east 180.64 feet to a point; thence south 45 degrees 12 minutes west 246.83 feet to a point; thence on a curve to the left with a radius of 420 feet an arc distance of 365.79 feet to a point; thence south 4 degrees 42 minutes east 240.08 feet to a point; thence on a curve to the right with a radius of 480 feet an arc distance of 728.85 feet to a point; thence south 82 degrees 18 minutes west 467.65 feet to a point; thence along lands of Kinsey Distillery Corporation, north 21 degrees 46 minutes west 61.86 feet to a point and the place of beginning, containing 2.6891 acres of land, more or less.

And being composed of the tracts of land conveyed to the Commonwealth of Pennsylvania (1) by deed of Josephine C. Jackson and Irving Leighton and Margaret M. Leighton, his wife, dated January 13, 1917, and recorded in Montgomery County Deed Book Volume 753, at page 259, (2) by deed of Daniel Stauffer dated February 1, 1918, and recorded in Deed Book Volume 766, at page 89, (3) by Kathryn Kendall and others, administrators by deed dated February 26, 1925, and recorded in Deed Book Volume 942, at page 311.

Conditions.

The conveyance shall be made under and subject, nevertheless, to all easements, servitudes and rights of others, including but not confined to streets, roadways and rights of any telephone, telegraph, water, electric, gas or pipe line companies, as well as under and subject, nevertheless, to any estate or tenancies vested in third persons, whether or not appearing of record, for any portion of the said land or improvements erected thereon.

Approval and execution of deed.

Section 2. The assignment and transfer shall be approved by the Department of Justice and shall be executed by the Secretary of Property and Supplies in the name of the Commonwealth of Pennsylvania with the approval of the Secretary of Public Welfare and the Governor.

Act effective immediately.

Section 3. This act shall take effect immediately.
