Section 301. Exclusive Jurisdiction.—The orphans' court shall have exclusive jurisdiction of:

(1) Decedents' Estates. The administration and distribution of the real and personal property of decedents' estates and the control of the decedent's burial.

Section 302. Concurrent Jurisdiction [; Title to Real Estate].—The orphans' court shall have concurrent jurisdiction [to determine] of:

- (1) Title to Real Estate. The determination of the persons to whom the title to real estate of a decedent or of the creator of an estate or trust subject to the jurisdiction of the orphans' court has passed by devise or descent or by the terms of the trust instrument: Provided, That nothing herein shall be construed to restrict the exclusive jurisdiction of the orphans' court to distribute real estate in an estate or trust within its jurisdiction.
- (2) Guardian of Person. The appointment, control and removal of the guardian of the person of any incompetent.

Act effective immediately.

Section 2. This act shall take effect immediately.

AN ACT

Amending the act of April 29, 1959 (P. L. 58), entitled "An act consolidating and revising the Vehicle Code, the Tractor Code, the Motor Vehicle Financial Responsibility Act and other acts relating to the ownership, possession and use of vehicles and tractors," authorizing the operation of a vehicle having two others attached thereto in certain cases.

The Vehicle Code.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 902, subsection (c), clause (1), act of April 29, 1959, P. L. 58, amended.

Section 1. Section 902, subsection (c) clause (1) of the act of April 29, 1959 (P. L. 58), known as "The Vehicle Code," is amended to read:

Section 902. Size of Vehicles, Tractors and Loads .-

(c) * * *

(1) No motor vehicle or tractor, except a tractor of the first class, shall be operated upon a highway drawing, or having attached thereto, more than one (1) other vehicle: Provided, That a trailer not exceeding ten (10) feet in length may be attached to one (1) motor vehicle for the purpose of towing another vehicle requiring service, to which such trailer is also attached: And provided further, That not more than two truck tractors, empty commercial motor vehicles, or the chassis therefor, may be attached to and transported by a truck tractor, commercial motor vehicle, or the chassis therefor, if the rear wheels of the vehicles so transported are the only wheels thereof which touch the road surface and the overall length of such combination of vehicles does not exceed fifty (50) feet in length.

AN ACT

Amending the act of July 5, 1947 (P. L. 1217), entitled "An act to promote the education and educational facilities of the people of the Commonwealth of Pennsylvania; creating a State Public School Building Authority as a body corporate and politic with power to construct, improve and operate projects and to lease the same and to fix and collect fees, rentals and charges for the use thereof; authorizing school districts to enter into contracts to lease; authorizing and regulating the issuance of bonds by said Authority; and providing for the payment of such bonds and the rights of the holders thereof; granting the right of eminent domain; increasing the powers and duties of the Department of Public Instruction; and providing that no debt of the Commonwealth shall be incurred in the exercise of any of the powers granted under this act; and making an appropriation to said Authority to pay expenses incident to its formation." authorizing the Authority to sell bonds at private sale when no bid is received which complies with the terms and conditions contained in the advertisement for public sale.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The second paragraph of subsection (a) of section 6, act of July 5, 1947 (P. L. 1217), known as the "State Public School Building Authority Act," amended April 20, 1949 (P. L. 636), is amended to read:

Section 6. Purposes and Powers; Bonds.—(a)

Said bonds shall be sold to the highest responsible bidder or bidders after public notice by advertisement once a week for three weeks in not less than six (6) or more than twelve (12) newspapers of large general circulation in different parts of the Commonwealth, the
