APPROPRIATION ACTS

No. 1-A.

AN ACT

Making an appropriation for disaster relief to the State Council of Civil Defense in connection with the flood damage of January, 1959.

Whereas, in January, 1959, there occurred a catastrophic flooding of underground mines in Luzerne County in the area east of the Susquehanna River, and floods and high water in other areas of the Commonwealth where the danger of floods has historically been imminent; and

Whereas, twelve mine workers in one flooded area are missing and immediate measures are necessary to effect rescue operations for these men; and

Whereas, these floods have endangered the homes, factories, schools, churches and commercial establishments located in these areas because of the possibility of surface subsidence; and

Whereas, the floods have created a condition of grave danger to the safety and to the lives of citizens in these areas because of potential gas formations and subsidence, the extent of which is yet to be determined; and

Whereas, the above conditions have resulted in economic dislocation of large numbers of people in these areas, including the temporary, and the prospect of permanent unemployment of many citizens; and

Whereas, the widespread unemployment will have severe impact upon the status of the Unemployment Compensation Fund of the Commonwealth; and

Whereas, the Governor of the Commonwealth and the President of the United States have declared that a state of emergency exists in these areas:

Now, therefore, in order to effect rescue operations, to alleviate human misery and economic hardship, to prevent the spreading and provide measures that will reduce the hazards from these disastrous floods, and to protect the health, safety and property of the citizens of the Commonwealth.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The Department of Mines and Mineral Industries shall—

- (a) conduct rescue operations;
- (b) without advertising or competitive bidding, purchase material and equipment, and provide labor and technicians for pumping of water from the mines, constructing ditches, flumes and other devices for mine drainage, for sealing, backfilling and for the performance of any other work designated by the Secretary of Mines and Mineral

Industries as expedient to prevent the spreading and reduce the hazards from the flooding of mines;

- (c) pay for power and for other costs attendant upon the operation and maintenance of pumping and other devices for mine drainage;
- (d) perform the purposes of the act with personnel of the department or by contract with others;
- (e) pay for the foregoing whether already undertaken or to be undertaken hereafter;
- (f) reimburse any person, agency or corporation for material, labor and equipment furnished at the request of the Department of Mines and Mineral Industries in the performance of the aforesaid duties;
- (g) renegotiate any contracts or projects under the Act of July 7, 1955 (P. L. 258), by reason of the conditions arising through this emergency;
- (h) conduct investigations to determine the cause of this disaster and to institute measures to insure the future safety and health of persons in the area;
- (i) to take all necessary and expedient actions to effect the purposes of this act.
- Section 2. The Department of Forests and Waters is hereby authorized to institute at the earliest possible moment a program of channel enlargement, rectification and realignment in order to alleviate conditions contributing to the hazards of flood.
- Section 3. The sum of three million dollars (\$3,000,000), or as much thereof as may be necessary, is hereby appropriated to the Special Disaster Relief Fund of the State Council of Civil Defense for the purposes of this act.
- Section 4. The sum of two million five hundred thousand dollars (\$2,500,000), or as much thereof as may be necessary, is allocated to the Department of Mines and Mineral Industries to carry out the purposes of this act.
- Section 5. The sum of five hundred thousand dollars (\$500,000), or as much thereof as may be necessary, is allocated to the Department of Forests and Waters to carry out the purposes of this act.
- Section 6. No payment shall be made from the appropriation herein until the Department of Mines and Mineral Industries and Forests and Waters shall have first filed with the State Council of Civil Defense sworn proofs of loss expenditures, losses and damages in detailed statements.

The Department of Property and Supplies, and such other State agencies as the Governor may designate, shall review the same and recommend to the Governor the amounts which, in their opinion, represent the value of the expenditures, losses and damages by reason of the flood damage of January, 1959.

Section 7. This act shall take effect immediately.

AN ACT

Amending the act of September 3, 1955 (Appropriation Act No. 17-A) entitled "An act making an appropriation to the *Council of Civil Defense for disaster relief in connection with the hurricane and flood damage of August, one thousand nine hundred fifty-five," making the moneys appropriated available for flood damage of January, one thousand nine hundred fifty-nine.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. Section 1, act of September 3, 1955 (Appropriation Act No. 17-A) entitled "An act making an appropriation to the Council of Civil Defense for disaster relief in connection with the hurricane and flood damage of August, one thousand nine hundred fifty-five," amended April 18, 1957 (Appropriation Act No. 7-A), is amended to read:

The sum of twelve million dollars (\$12,000,000) is hereby appropriated, out of the Special Disaster Relief Fund, to the Council of Civil Defense for disaster relief in connection with the hurricane and flood damage of August and October, one thousand nine hundred fifty-five, and any flood damage during the year of one thousand nine hundred and fifty-six and January of one thousand nine hundred fiftynine, and for **payment or reimbursement to the various departments and agencies of the Commonwealth for their participation in disaster relief activities, including but not limited to materials, supplies, services, food, clothing, equipment, drugs and medicines, channel enlargement, rectification and realignment, side slope paving, transportation and the acquisition, by amicable means up to the amount of five hundred thousand dollars (\$500,000), of lands and any improvements thereon in flood areas, and repairs to the flood and hurricane damaged historical properties of Pennsbury Manor, in the County of Bucks, Governor Printz Park and John Morton Homestead, in the County of Delaware, and Warrior Run Church, in the county of Northumberland.

No payment, except payments as herein provided to the Department of Forests and Waters and the Pennsylvania Historical and Museum Commission, shall be made from the appropriation herein until the various departments and agencies of the Commonwealth shall have first filed with the Council of Civil Defense sworn proofs of loss expenditures, losses and damages in detailed statements. Payments may be made to the Department of Forests and Waters and the Pennsylvania Historical and Museum Commission from the appropriation herein provided on account of any disaster relief project in which they are participating after the plans, specification and costs of said project have been reviewed by the Department of Property and Supplies, and such other State agencies as the Governor may designate, and have been recommended to the Governor by such agencies and filed with the Council of Civil Defense with such recommendations.

The Department of Property and Supplies, and such other State agencies as the Governor may designate, shall review the same and recommend to the Governor the amounts which, in their opinion, represent the value of the expenditures, losses and damages by reason of the hurricane and floods of August and October, one thousand nine hundred fifty-five, and any flood damage during the year one thousand nine hundred and fifty-six and January of one thousand nine hundred fifty-nine. Payment from said appropriation shall be made by requisition of the Council of Civil Defense in the manner provided by law.

Section 2. This act shall take effect immediately.

L. 1609), such sum to be credited to the Industrial Development Fund and expended as authorized by said act.

AN ACT

Authorizing a loan and transferring money from the Motor License Fund to the General Fund and providing for the subsequent return from the General Fund of the borrowed money.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. Pursuant to the provisions of article IX., section 18 of the Constitution of the Commonwealth of Pennsylvania, the State Treasurer is hereby authorized, after the effective date of this act, to arrange a loan for the Commonwealth from the Motor License Fund not to exceed the sum of thirty-five million dollars (\$35,000,000), or any part thereof, and transfer such money upon warrant of the Auditor General and requisition of the Governor to the General Fund.

The purpose of this loan and transfer is to provide funds for the payment of ordinary and usual expenses of the State government or any general appropriation bill and the money so borrowed shall be

used for these purposes and no other.

Section 2. The moneys loaned and transferred from the Motor License Fund to the General Fund shall be repaid to the Motor License Fund in accordance with the provisions of article IX., section 18 of the Constitution of the Commonwealth of Pennsylvania.

Section 3. This act shall take effect immediately.

AN ACT

Making an appropriation to the joint committee appointed by the House of Representatives and the Senate to study and investigate the recent mine disaster.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The sum of fifty thousand dollars (\$50,000), or as much thereof as may be necessary, is hereby specifically appropriated to the joint committee appointed by the Speaker of the House of Representatives and the President Pro Tempore of the Senate on February 9, 1959, pursuant to a House Concurrent Resolution of 1959, designated as House Resolution, Serial No. 19, to study and investigate the recent mine disaster and all matters relating thereto.

The money shall be used for the payment of expenses of the committee and the members thereof in performance of the functions and

duties for which the committee was created.

Section 2. The sum appropriated shall be paid on warrant of the auditor general in favor of either of the co-chairmen of the joint committee on the presentation of his requisition for the same. The

co-chairmen of the joint committee shall, not later than thirty days after the termination of their term of office or until their successors are elected and also within thirty days after the adjournment sine die of this General Assembly, file an account with the auditor general of the committee's expenses since the filing of any prior account.

Section 3. This act shall take effect immediately. The appropriation made hereby shall be available only for expenditures made and obligations incurred during the continuance of the 1959 session of the General Assembly.

The sum of three million dollars (\$3,000,000.00) or as much thereof as is necessary, is hereby specifically appropriated to the Department of Public Welfare for State headquarters, administration of the Public Assistance Law and supervision of county boards of assistance, disbursement of assistance grants, collection of restitution and reimbursements and for making public assistance grants.

Section 2. This act shall take effect immediately.

AN ACT

Making a deficiency appropriation from the Motor License Fund to the Department of Labor and Industry for the payment of the Commonwealth's share of Social Security Taxes.

Section 1. The total sum of one million eight hundred seventy-three thousand dollars (\$1,873,000), or as much thereof as may be necessary, is hereby appropriated from the Motor License Fund to the Department of Labor and Industry for the payment of the deficiency in the appropriation expended in paying the Commonwealth's share of Social Security Taxes.

Section 2. This act shall take effect immediately.

AN ACT

Making an appropriation to the Department of Military Affairs for certain expenses in connection with the Korean Conflict Veterans Compensation Act.

The General Assembly of the Commonwealth of Pennsylvania

hereby enacts as follows:

Section 1. The sum of two hundred thousand dollars (\$200,000), or as much thereof as may be necessary, is hereby appropriated to the Department of Military Affairs for the purpose of paying salaries and other necessary expenses incurred by the Adjutant General and the State Treasurer in preparation for the payment of the compensation provided for in the "Korean Conflict Veterans' Compensation Act," approved July 8, 1957 (P. L. 569). The amount that shall be necessarily expended from said appropriation for the purposes stated shall be repaid from the Korean Conflict Veterans' Compensation Fund into the General Fund from the receipts of the sale of said bonds.

Section 2. This act shall take effect immediately.

AN ACT

Making an appropriation to the Department of Public Welfare and providing for certain allocations therefrom for the purpose of carrying out the Public Assistance Law, for the two fiscal years beginning June first, one thousand nine hundred fifty-nine, and for the payment of assistance and expenses accrued or incurred prior to and remaining unpaid on May 31, 1959, and limiting the amount thereof available for administrative expenses.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The sum of twenty-two million five hundred thousand dollars (\$22,500,000), or as much thereof as may be necessary, is hereby specifically appropriated to the Department of Public Welfare, for the payment of assistance for the fiscal biennium beginning June 1, 1959, and for the payment of assistance and administrative expenses

incurred prior to and remaining unpaid on May 31, 1959.

Section 2. Out of the moneys appropriated by this act the Department of Public Welfare shall allocate funds from time to time for the several assistance programs (old age assistance, aid to dependent children, pensions for the blind, aid to the disabled, general assistance, and other programs provided by the Public Assistance Law), for administrative expenses of the several county boards of assistance, for such administrative expenses incurred by the department which are chargeable to such boards, and for the payment of attorneys' fees and court costs necessary for the proper conduct of the work of the department.

Section 3. Out of the moneys appropriated by this act, allocations shall be made to the Department of the Auditor General and the Treasury Department, respectively, in such amounts as may be deemed necessary to pay the administrative expenses of such departments in auditing and disbursing appropriations for or relating to public assistance, including any Federal sums supplementing such appropriations. In the case of the Department of the Auditor General, said allocation shall be made by the Governor, President pro tempore of the Senate, Speaker of the House of Representatives, Secretary of Public Welfare and the Auditor General, or a majority thereof, and in the case of allocations made to the Treasury Department, such allocations shall be made by the Governor, President pro tempore of the Senate, Speaker of the House of Representatives, Secretary of Public Welfare and the State Treasurer, or a majority thereof.

Section 4. Out of the moneys appropriated by this act, the Department of Public Welfare shall allocate funds from time to time to provide necessary medical, dental and surgical care for children as provided in the act of July five, one thousand nine hundred forty-seven

(P. L. 1301).

Section 5. Out of moneys appropriated by section one of this act, not over one-half of one per centum thereof may be used under the direction of the Governor for surveys, investigations and studies relative to the more efficient enforcement of the public assistance law.

Section 6. This act shall become effective immediately upon its

final enactment.

Whereas, Under the Constitution and the laws of this Commonwealth the State Treasurer may not pay out any moneys unless they be specifically appropriated by act of the General Assembly; therefore,

The General Assembly of the Commonwealth of Pennsylvania

hereby enacts as follows:

Section 1. The sum of one hundred million dollars (\$100,000,000), or as much thereof as may be necessary, is hereby specifically appropriated to the State Treasurer of the Commonwealth of Pennsylvania, for the purpose of paying the salaries and wages of the officers and employes and other ordinary and general expenses of the State government in the interim between the thirty-first day of May, one thousand nine hundred fifty-nine, and such time as moneys appropriated by the General Appropriation Act and other appropriation acts of one thou-

sand nine hundred fifty-nine may become available for such purposes; and for the payment of bills incurred and remaining unpaid at the close of the fiscal year ending May thirty-first, one thousand nine hundred fifty-nine.

Section 2. Payments out of the appropriation of this act shall be made by the State Treasurer upon requisitions by the several departments, boards, commissions or officers, in the same manner as payments

are ordinarily made.

Section 3. All amounts paid by the State Treasurer in accordance with this act shall be charged against the appropriations made for the salaries and wages of the officers and employes and other ordinary and general expenses of the State government in the General Appropriation Act and other appropriation acts of one thousand nine hundred fifty-nine.

Section 4. This act shall become effective immediately upon its

final enactment.

sary, from the various funds of the Commonwealth and in the amounts hereinafter listed, is hereby appropriated to the Department of Labor and Industry for payment into the Social Security Contribution Fund created under the provisions of the act of January 5, 1952 (P. L. 1833), as *reenacted and amended by the act of June 1, 1956 (P. L. 1973), to be expended in paying the Commonwealth's share of Social Security taxes to the Federal government with respect to compensation, for the period June 1, 1959, to May 31, 1961, of employes of the Commonwealth whose compensation is paid from such funds and compensation, for the period January 1, 1956, to May 31, 1961, for employes entering Social Security coverage under the re-opening program in accordance with the State-wide coverage agreement or agreements entered into between the State Agency and the U. S. Department of Health, Education and Welfare for the extension of Social Security coverage to such employes.

Section 2. The following sums, or as much thereof as may be necessary, are hereby appropriated to the Department of Labor and Industry to be expended as provided in this act in paying the Commonwealth's share of Social Security taxes to the Federal government:

AN ACT

Making an appropriation to the Department of **Public Welfare and providing for certain allocations therefrom for the purpose of carrying out the Public Assistance Law, for the two fiscal years beginning June first, one thousand nine hundred fifty-nine, and for the payment of assistance and expenses accrued or incurred prior to and remaining unpaid on May 31, 1959, and limiting the amount thereof available for administrative expenses.

The General Assembly of the Commonwealth of Pennsylvania

hereby enacts as follows:

Section 1. The sum of thirty million four hundred thousand dollars (\$30,400,000), or as much thereof as may be necessary, is hereby

specifically appropriated to the Department of Public Welfare, for the payment of assistance for the fiscal biennium beginning June 1, 1959, and for the payment of assistance and administrative expenses incurred prior to and remaining unpaid on May 31, 1959.

- Section 2. Out of the moneys appropriated by this act, the Department of Public Welfare shall allocate funds from time to time for the several assistance programs (old age assistance, aid to dependent children, pensions for the blind, aid to the disabled, general assistance, and other programs provided by the Public Assistance Law), for administrative expenses of the several county boards of assistance, for such administrative expenses incurred by the department which are chargeable to such boards, and for the payment of attorneys' fees and court costs necessary for the proper conduct of the work of the department.
- Section 3. Out of the moneys appropriated by this act, allocations shall be made to the Department of the Auditor General and the Treasury Department, respectively, in such amounts as may be deemed necessary to pay the administrative expenses of such departments in auditing and disbursing appropriations for or relating to public assistance, including any Federal sums supplementing such appropriations. In the case of the Department of the Auditor General, said allocation shall be made by the Governor, President pro tempore of the Senate, Speaker of the House of Representatives, Secretary of Public Welfare and the Auditor General, or majority thereof, and in the case of allocations made to the Treasury Department, such allocations shall be made by the Governor, President pro tempore of the Senate, Speaker of the House of Representatives, Secretary of Public Welfare and the State Treasurer, or a majority thereof.
- Section 4. Out of the moneys appropriated by this act, the Department of Public Welfare shall allocate funds, from time to time, to provide necessary medical, dental and surgical care for children as provided in the act of July five, one thousand nine hundred forty-seven (P. L. 1301).
- Section 5. Out of moneys appropriated by section one of this act, not over one-half of one per centum thereof may be used under the direction of the Governor for surveys, investigations and studies relative to the more efficient enforcement of the Public Assistance Law.
- Section 6. This act shall become effective immediately upon its final enactment.

Making an appropriation to the State Treasurer, for the purpose of paying salaries and wages of State officers and employes and other ordinary and general expenses in the interim between the thirty-first day of May, one thousand nine hundred fifty-nine, and such time as the funds provided by the General Appropriation Act and other appropriation acts become available; and for the payment of bills incurred and remaining unpaid at the close of the fiscal year ending May thirty-first, one thousand nine hundred fifty-nine.

Whereas, Under the Constitution and the laws of this Commonwealth the State Treasurer may not pay out any moneys unless they be specifically appropriated by act of the General Assembly; therefore, The General Assembly of the Commonwealth of Pennsylvania

hereby enacts as follows:

The sum of two hundred five million four hundred thousand dollars (\$205,400,000), or as much thereof as may be necessary, is hereby specifically appropriated to the State Treasurer of the Commonwealth of Pennsylvania, for the purpose of paying the salaries and wages of the officers and employes and other ordinary and general expenses of the State government in the interim between the thirty-first day of May, one thousand nine hundred fifty-nine, and such time as moneys appropriated by the General Appropriation Act and other appropriation acts of one thousand nine hundred fifty-nine may become available for such purposes; and for the payment of bills incurred and remaining unpaid at the close of the fiscal year ending May thirty-first, one thousand nine hundred fifty-nine.

Section 2. Payments out of the appropriation of this act shall be made by the State Treasurer upon requisitions by the several departments, boards, commissions or officers, in the same manner as pay-

ments are ordinarily made.

All amounts paid by the State Treasurer in accordance with this act shall be charged against the appropriations made for the salaries and wages of the officers and employes and other ordinary and general expenses of the State government in the General Appropriation Act and other appropriation acts of one thousand nine hundred fifty-nine.

L. 1633), as amended, known as the "Housing and Redevelopment Assistance Law." Not more than twenty per centum of the amount herein appropriated shall be allocated or granted to any one political subdivision.
