

Section 8. That part of all appropriations in this act unexpended, uncommitted and unencumbered as of May 31, 1961, shall automatically lapse as of that date.

Section 9. The provisions of this act shall be severable. If any provision of this act is found by a court of record to be unconstitutional and void, the remaining provisions of the act shall, nevertheless, remain valid, unless the court finds the valid provisions of the law are so essentially and inseparably connected with and depend upon the void provision that it cannot be presumed the Legislature would have enacted the remaining valid provisions without the void one, or unless the court finds the remaining valid provisions standing alone are incomplete and are incapable of being executed in accordance with the legislative intent.

Section 10. No part of the appropriations made by this act shall be used to pay for hospital or institutional care or training at rates in excess of those charged to the general public for the same care and services.

Making an appropriation to the Department of Property and Supplies for payment to the Borough of Ebensburg for defraying the Commonwealth's share of expenses and charges in connection with capital improvements to the Ebensburg State School.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The sum of two hundred twenty-five thousand dollars (\$225,000), or as much thereof as may be necessary, is hereby specifically appropriated to the Department of Property and Supplies for payment to the Borough of Ebensburg for defraying the Commonwealth's share of the expenses and charges to be incurred in establishing and contracting with an authority for the purpose of acquiring, holding, constructing, improving, maintaining and operating a sewage disposal plant and system for disposing of sewage from the Ebensburg State School.

The sum of forty thousand dollars (\$40,000), or as much thereof as may be necessary, is hereby specifically appropriated to the Department of Property and Supplies for payment to the Borough of Indiana for defraying the Commonwealth's share of the expenses and charges to be incurred by, and contracting with the borough for the purpose of constructing a sanitary trunk sewer to carry the sewage from the western portion of the borough, including the Indiana State Teachers' College, to a point in White Township where it will connect with the main outfall sewer of the borough.

AN ACT

Making an appropriation to the Department of Agriculture for expenses incurred in a geological survey to be made in conjunction with the Federal government.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The sum of thirty thousand dollars (\$30,000), or as much thereof as may be necessary, is appropriated to the Department of Agriculture for the payment of necessary expenses incurred in making a geological survey, in conjunction with the Federal government, in order to collect data regarding runoff and suspended sediment movement of certain streams in Pennsylvania, to determine what effect soil conservation practices within the watershed have on the flood flows and suspended sediment load passing from the watershed, providing Federal matching funds are available.

Making an appropriation to the Department of Commerce for rendering financial assistance to industrial development agencies engaged in promoting the development and expansion of business, industry and commerce in the respective counties of the Commonwealth.

## APPROPRIATION ACTS,

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The sum of four hundred thousand dollars (\$400,000), or as much thereof as may be necessary, is appropriated to the Department of Commerce for payment of grants to recognized industrial development agencies, to assist such agencies in the financing of their operational costs for the purposes of making studies, surveys and investigations, the compilation of data and statistics, and in the carrying out of planning and promotional programs.

Section 2. Expenditures of the funds appropriated in section 1 shall be made by the Department of Commerce in accordance with the provisions of Industrial Development Assistance Law, the act of May 31, 1956 (P. L. 1911).

The sum of nine hundred thousand dollars (\$900,000), or as much thereof as may be necessary, is hereby specifically appropriated to the Department of Forests and Waters for the maintenance, repair and improvement of the Port of Philadelphia for the fiscal biennium beginning June 1, 1959. The money so appropriated shall be extended as authorized and directed by Council of the City of Philadelphia and shall be drawn from the State Treasury, upon warrants drawn by the Auditor General, upon requisition by the Chief of the Bureau of Port Operations of said city.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. In order that the Commonwealth of Pennsylvania, as a whole, and the counties of western and northwestern Pennsylvania may, through the Port of Erie, be placed in a position to take full advantage of economic benefits envisioned from the St. Lawrence Seaway Project, the sum of five hundred fifty thousand dollars (\$550,000), or as much thereof as may be necessary, is hereby appropriated to the Department of Forests and Waters to be expended for pier and harbor improvements, leading to completion of the Duquesne Marine Terminal facilities, in order that the Port of Erie may be able to handle deep-drought water-borne commerce.

Section 2. Expenditures of the funds appropriated in section 1 shall be made by the Department of Forests and Waters for the general purposes of improvement of the Port of Erie in accordance with plans approved by the Port Commission of the City of Erie, the City Council of the City of Erie and the Secretary of Forests and Waters.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The sum of five million three hundred eighteen thousand eight hundred forty-four dollars (\$5,318,844), or as much thereof as may be necessary, is hereby specifically appropriated to the Trustees of the University of Pittsburgh for the fiscal biennium beginning June 1, 1959, for the general maintenance of the University of Pittsburgh and for the purchase of such apparatus and equipment as the trustees may deem necessary for the best interest of the University.

Section 2. The sum of one million eight hundred eighty-seven thousand nine hundred eighty-five dollars (\$1,887,985), or as much thereof as may be necessary, is hereby specifically appropriated to the Trustees of the University of Pittsburgh for the fiscal biennium beginning June 1, 1959, for the general maintenance of the School of Medicine, including the purchase of such apparatus and equipment as the trustees may deem necessary, and maintenance of teaching facili-

ties in hospitals for students of the School of Medicine, including the Maternity Dispensary and other dispensaries.

Section 3. The sum of fifty thousand dollars (\$50,000), or as much thereof as may be necessary, is hereby specifically appropriated to the Trustees of the University of Pittsburgh for the fiscal biennium beginning June 1, 1959, for a Professorship in Experimental Medicine in the School of Medicine of the University, to be known as the Commonwealth Jonas E. Salk professorship of experimental medicine, and to be filled by that member of the medical profession who, in the opinion of the Trustees of the University of Pittsburgh, has made an outstanding contribution in the field of Experimental Medicine.

Section 4. The sum of three million eight hundred fifty-seven thousand two hundred eighty-two dollars (\$3,857,282), or as much thereof as may be necessary, is hereby appropriated to the Trustees of the University of Pittsburgh for the fiscal biennium beginning June 1, 1959, for the general maintenance and operation of the Western Psychiatric Institute and Clinic by the University of Pittsburgh, and the purchase of such apparatus and equipment as the trustees may deem necessary for the best interests of the purposes of the institute and clinic, which purposes shall include the teaching of personnel for the staffs of the various mental institutions of the Commonwealth and the conduct of research in the treatment, prevention and cause of the various types of nervous disorders and mental diseases in compliance with the act of May 20, 1949 (P. L. 1643), providing for the lease of the Western State Psychiatric Institute and Clinic to the University of Pittsburgh. In addition to the above amount, all income and all moneys collected at the institute and paid into the General Fund of the State Treasury under existing laws are hereby appropriated out of the General Fund to the institute for the same purpose, the institute to receive from such appropriation the exact amount which was collected at said institute during the said fiscal years.

Such children must have lived in the Commonwealth of Pennsylvania for five years immediately preceding the date upon which the application is filed.

Section 2. Gratuities shall be paid out of the appropriation for the account of such children as shall be certified by the State Veterans' Commission (1) as coming within the class described above, and (2) as attending any State or State-aided educational or training institution of a secondary or college grade or other institution of higher education, business school, trade school, hospital providing training for nurses, school or institution providing courses in beauty culture, art, radio or undertaking or embalming or such other educational training within this Commonwealth, as approved by the State Veterans' Commission, and (3) as being unable without such gratuity to pursue his or her education or training. Payments not to exceed the sum of two hundred dollars (\$200) per semester per child shall be made to such institution upon the submission by them of proof that bills have been incurred or contracted for matriculation fees and other necessary fees, tuition, board, room rent, books and supplies for such children in a definite amount for the school year. Such proof shall be submitted to the State Veterans' Commission which shall attach the same to the requisitions prepared for payments out of the appropriations made by this act.

Section 3. Where a child within the class described is completing an educational or training course and arrives at the age of twenty-one years before completing the course, the gratuity may be paid until the course is completed: Provided, however, That gratuities may not be paid for any child for a longer period than four scholastic years.

The sum of twenty-eight million dollars (\$28,000,000), or as much thereof as is necessary, is appropriated to the Department of Public Welfare for the two fiscal years beginning June 1, 1959, to be, by it, paid to the hospitals hereinafter designated, in the amounts hereinafter specified, for the purpose of the maintenance of such hospitals in accordance with the rules and regulations issued by the Department of Public Welfare and the Department of the Auditor General, as prescribed by law, at the rate of ten dollars (\$10) per diem, but not to exceed the regularly established ward rate, nursery rate, pediatric rate or any lesser rate contracted between the hospital and patient, for the medical and surgical services rendered to and maintenance of persons treated in the hospital who are entitled to free service, such rates to include only room, board and general bed care, but not to exceed rates charged other classes of patients or the actual cost to the hospital of such services and maintenance, whichever is the least, and all moneys received on account of the care of the patient shall be reported as a credit against the gross earnings of free and part pay service \*chargeable against this appropriation:

Section 2. Any unexpended balance of the appropriation, as determined by the Department of the Auditor General, shall be allocated by the Department of Public Welfare and the Department of the Auditor General among the hospitals, the amounts for which herein specified have not been sufficient to pay for the services rendered by them to persons entitled to free service in the proportion which the total amount to which each hospital is entitled under the formulae set forth in section 1 hereof and for which it has not been paid bears to the total of such amounts of all the hospitals that have not been paid in full. The amount allocated to any hospital shall not be greater than the amount to which the hospital is entitled under the formulae set forth in section 1. All amounts so allocated shall be paid by the department to the hospitals entitled thereto in the manner prescribed by law.

Section 3. Except in cases of accident or emergency, only bonafide residents of Pennsylvania shall be entitled to the free service provided for in this act.

Section 4. All participating hospitals shall file a report with the Department of the Auditor General within ninety days of the last day

of each quarter. Failure to file the report timely as required hereunder shall disqualify the institution from receiving an appropriation for the quarter covered by the untimely filed report.

The sum hereby appropriated shall be in addition to other sums heretofore appropriated for the acquisition of the aforesaid tracts of land.

## AN ACT

Making an appropriation to the Department of Health for payments to municipalities and municipality authorities under the provisions of the act of August 20, 1953 (P. L. 1217), entitled "An act providing for payments by the Commonwealth to municipalities which have expended money to acquire and construct sewage treatment plants in accordance with the Clean Streams Program and the act, approved the twenty-second day of June, one thousand nine hundred thirty-seven (Pamphlet Laws 1987), and making an appropriation," and for the repair, improvements or additions of certain sewage treatment plants.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The sum of four million six hundred eighty thousand dollars (\$4,680,000), or as much thereof as may be necessary, is appropriated to the Department of Health for payments to municipalities and municipality authorities toward the cost of maintaining, repairing, replacing and other expenses relating to sewage treatment plants an amount not to exceed two percentum of the costs (1) for the acquisition and construction of the sewage treatment plants by the municipalities and municipality authorities to control stream pollution expended by the municipalities and municipality authorities from the effective date of the act of June 22, 1937 (P. L. 1987), up to and including the thirty-first day of December of the year preceding the year in which the payment is made as ascertained by the Secretary of Health and approved by the Governor as provided by the act of August 20, 1953 (P. L. 1217), entitled "An act providing for payments by the Commonwealth to municipalities which have expended money to acquire and construct sewage treatment plants in accordance with the Clean Streams Program and the act, approved the twenty-second day of June, one thousand nine hundred thirty-seven (Pamphlet Laws 1987), and making an appropriation," and (2) for the repair, improvements or additions since 1937 of plants constructed prior to that date.

Section 2. Within the meaning of this act, the word "construction" shall include, in addition to the construction of new treatment works, pumping stations and intercepting sewers which are an integral part of the treatment facilities (including those intercepting sewers of municipalities which collect at least fifty per cent of the sewage of the municipality which enters a public sewage system in the municipality and discharge same into the collection system of the municipality which has constructed the main sewage plant), the altering, improving or adding to of existing treatment works, pumping stations and intercepting sewers which are essential to the sewage treatment plant system.

Section 3. If any section, sentence, clause or part of this act is for any reason held to be unconstitutional, the decision of the court shall not affect or impair any of the remaining provisions of this act. It is hereby declared as the legislative intent that this act would have been

adopted had such unconstitutional sentence, section, clause or part thereof not been included herein.

Appropriating all revenues exceeding a stated amount over the aggregate amount appropriated by the General Assembly for all purposes for the reduction of the bonded indebtedness of the Commonwealth.

All revenues received by the Commonwealth payable into the General Fund during the fiscal biennium beginning June 1, 1959, in excess of five million dollars (\$5,000,000) over the aggregate amount heretofore appropriated by the General Assembly for all General Fund purposes and executive authorization made according to law shall be applied and are hereby appropriated for the reduction of the bonded indebtedness of the Commonwealth.

Such excess revenues shall be applied as nearly as possible in equal proportions to the various sinking funds created for the reduction of said indebtedness.

## AN ACT

Amending the act of September 3, 1955 (Appropriation Acts, page 18), entitled "An act providing for reconstruction and repair of roads, streets, highways and bridges, damaged or destroyed, by the hurricane, flood or high water of August, 1955; making appropriations out of the Motor License Fund to the Department of Highways for allocation to political subdivisions, subject to approval of the State Council of Civil Defense, and for the reconstruction and repair of State highways and bridges thereon, and free bridges under the jurisdiction of the Delaware River Joint Toll Bridge Commission, and for allocation to cities, boroughs, towns and townships for general highway purposes," extending the provisions of the act to political subdivisions for damages caused by later disasters, making them eligible for moneys out of said appropriations, and extending the time that appropriations are available.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. Sections 1 and 2, act of September 3, 1955 (Appropriation Acts, page 18), entitled "An act providing for reconstruction and repair of roads, streets, highways and bridges, damaged or destroyed, by the hurricane, flood, or high water of August, 1955; making appropriations out of the Motor License Fund to the Department of Highways for allocation to political subdivisions, subject to approval of the State Council of Civil Defense, and for the reconstruction and repair of State highways and bridges thereon, and free bridges under the jurisdiction of the Delaware River Joint Toll Bridge Commission, and for allocation to cities, boroughs, towns and townships for general

highway purposes," amended June 1, 1956 (Appropriation Acts, page 114), are amended to read:

Section 1. The sum of fifteen million dollars (\$15,000,000) is appropriated out of the Motor License Fund to the Department of Highways, for payment to political subdivisions, for rebuilding or repairing roads, streets, highways and bridges, destroyed or damaged, by the hurricane, flood or high water of August, 1955, or by any like disaster happening since that date and prior to [the effective date of this amendment] *August 28, 1959*.

Section 2. Each political subdivision, the roads, streets, highways or bridges of which have been damaged or destroyed by the hurricane, flood or high water of August, 1955, or by any like disaster happening since that date and prior to [the effective date of this amendment] *August 28, 1959*, shall submit, no later than \**[sixty]* *ninety* days from the occurrence of the disaster, \*\**[or]* and in cases of disaster happening after August, 1955, no later than thirty days from the final enactment of this [amendment] *amending act*, to the department a statement of the specific damage done to its roads, streets, highways and bridges and an overall plan of reconstruction and repair showing specifically what work has been completed and what additional work must be done in order to make the roads, streets, highways and bridges serviceable and safe for travel and an estimate of the cost of the additional work. There shall also be submitted a statement, (1) that the political subdivision has made a substantial effort to meet the emergency in accordance with its financial resources, and the amount expended and to be expended by the political subdivision and (2) that the political subdivision has applied for aid from the Federal Government and the amount of such aid that may be available to it.

Section 2. Section 3 of the act, amended June 5, 1957 (Appropriation Acts, page 12), is amended to read:

Section 3. Upon consideration of the applications including applications made because of damages caused by disasters happening after August, 1955, and after such investigation as he deems necessary the Secretary of Highways, with the approval of the State Council of Civil Defense, shall allocate to each applicant as much of the fund hereby appropriated as the application shall justify and reasonably warrant. No application or amendment thereof shall be received or permitted [after September 30, 1957,] *unless submitted within ninety days of the occurrence of the disaster*. Payments of the \*\*\*amounts allocated shall be made to the \*\*\*\*treasurers of the several political subdivisions by requisition of the Department of Highways in the manner provided by law. The department may make rules and regulations for carrying out the provisions of this act. All funds not allocated shall lapse and revert to the Motor License Fund.

Section 3. This act shall take effect immediately.

## AN ACT

Lapsing a balance of an appropriation made from the Motor License Fund to the Department of Highways in Section 4 of the act of September 3, 1955 (Appropriation Act, No. 18-A).

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. All funds which are not required to carry out the provisions of section 4, act of September 3, 1955 (Appropriation Act, No. 18-A), which section made an appropriation of thirty million dollars (\$30,000,000) out of the Motor License Fund, are hereby lapsed and said funds shall revert to the Motor License Fund in the State Treasury.
