Temporary Investment of School Dis-Section 440.1. trict Funds.—The board of school directors in any school district of the first class, first class A, second, third or fourth class may authorize the treasurer of such school district to make temporary investment of school district funds in United States treasury bills, or to place such funds in savings accounts or share accounts of institutions insured by the Federal Deposit Insurance Corporation or the Federal Savings and Loan Insurance Corporation to the extent that such accounts are so insured when, in its judgment, the interests of the school district will be enhanced thereby, and to dispose of such securities when the funds may be needed by the school district. Any such purchase or sale shall be made by the treasurer of the school district on a resolution adopted by the board of school directors.

Act effective immediately.

Section 2. This act shall take effect immediately.

# AN ACT

Amending the act of May 26, 1933 (P. L. 1088), entitled "An act authorizing the State Treasurer under certain conditions to transfer sums of money between the Motor License Fund and the General Fund; providing for subsequent transfers of equal sums between such funds; and making appropriations necessary to effect such transfers," authorizing the transfer of funds during each fiscal period and requiring the retransfer of the funds not later than thirty days after such fiscal period.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. Sections 1 and 2, act of May 26, 1933 (P. L. 1088), entitled "An act authorizing the State Treasurer under certain conditions to transfer sums of money between the Motor License Fund and the General

Sections 1 and 2, act of May 26, 1933, P. L. 1088, amended. Fund; providing for subsequent transfers of equal sums between such funds; and making appropriations necessary to effect such transfers," are amended to read:

Section 1. Be it enacted, &c., That whenever the Governor shall ascertain that the cash balance and the current estimated receipts of the General Fund or of the Motor License Fund shall be insufficient at any time during any fiscal [biennium] period to meet promptly the expenses of the Commonwealth payable from either fund, the State Treasurer is hereby authorized and directed. from time to time during such fiscal [biennium] period, to transfer to such fund from the Motor License Fund or the General Fund, as the case may be, such sums as the Governor shall direct. Any sums so transferred shall be available for the purposes for which the fund to which they are transferred is appropriated by law. Transfers shall be made hereunder upon warrant by the Auditor General upon requisitions of the Governor.

Section 2. In order to reimburse the Motor License Fund or the General Fund, as the case may be, an amount equal to that transferred from such fund during any fiscal [biennium] *period* under section one of this act shall be transferred to such fund from the other fund [before] not later than thirty days after the end of such fiscal [biennium] period, in such amounts and at such times as the Governor shall direct. Such transfers shall be made by the State Treasurer upon warrant of the Auditor General upon requisitions of the Governor.

Section 2. This act shall take effect immediately.
