tion, levy taxes upon all real property and upon all occupations, or upon real property alone, within the township made taxable for township purposes, as ascertained by the last adjusted valuation for county purposes, for the purposes and at the rates hereinafter specified. All taxes shall be collected in cash.

* * * *

4. [A] An annual tax, not exceeding two mills, [and not exceeding the amounts hereinafter limited, for the purpose of purchasing and maintaining fire apparatus and to provide, with the assent of the electors of the township as hereinafter provided, a suitable place for the housing of the same, and to make appropriations to fire companies for the purchase and maintenance of fire apparatus; but no new fire apparatus shall be thereafter purchased by the township, or by any fire company from appropriations made by the township, without the consent of the electors as hereinafter provided] pursuant to provision therefor in the township budget, for the purpose of purchasing and maintaining fire apparatus, for the purpose of making appropriations to fire companies for the purchase and maintenance of fire apparatus, and with the assent of the electors of the township, for the purpose of providing a suitable place for the housing of fire apparatus.

AN ACT

Authorizing the Department of Forests and Waters to acquire approximately five acres of land in Milford Township, Juniata County, for State forest administrative purposes.

Real property.

Department of Forests and Waters authorized to acquire certain land in Milford Township, Juniata County. The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The Department of Forests and Waters is hereby authorized and empowered to purchase on behalf of the Commonwealth approximately five acres of land situate in Milford Township, Juniata County, presently under option from the Mifflintown Municipal Authority, at a purchase price of eighty dollars (\$80) per acre, notwithstanding present limitations on the price to be paid for State forest *land, the land herein referred to being deemed necessary by said department for State forest administrative purposes.

Section 2. The title to said real estate shall be taken in the name of the Commonwealth and shall, before its acquisition, be approved by the Department of Justice.

AN ACT

Amending the act of April 9, 1929 (P. L. 177), entitled "An act providing for and reorganizing the conduct of the executive and administrative work of the Commonwealth by the Executive Department thereof and the administrative departments, boards, commissions and officers thereof, including the boards of trus-tees of State Normal Schools, or Teachers Colleges; abolishing, creating, reorganizing or authorizing the reorganization of certain administrative departments, boards, and commissions; defining the powers and duties of the Governor and other executive and administrative officers, and of the several administrative departments, boards, commissions, and officers; fixing the salaries of the Governor, Lieutenant Governor, and certain other executive and administrative officers; providing for the appointment of certain administrative officers, and of all deputies and other assistants and employes in certain departments, boards, and commissions; and prescribing the manner in which the number and compensation of the deputies and all other assistants and employes of certain departments, boards and commissions shall be determined," authorizing the Department of Forests and Waters to exchange State park land.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. Clause (b) of section 1806, act of April 9, 1929 (P. L. 177), known as "The Administrative Code of 1929," amended June 21, 1937 (P. L. 1865), is amended to read:

Section 1806. Parks.—The Department of Forests and Waters shall have the power, and its duty shall be:

* * * * *

(b) For the purpose of promoting healthful outdoor recreation and education, and making available for such use natural areas of unusual scenic beauty, especially such as provide impressive views, water falls, gorges, creeks, caves, or other unique and interesting features, to acquire, in the name of the Commonwealth, by purchase, gift, lease, or condemnation, any lands which, in the judgment of the department, should be held, controlled, protected, maintained and utilized as State park lands, and to exchange any previously acquired land for
