the amount thereof to the bureau for the purpose of including the same in the upset price.

No sale of property shall be made by the bureau unless a bid equal to the upset price is made, and where sufficient is not bid, the sale shall be continued from month to month without further advertisement for not more than three (3) months in order to give the bureau a chance to sell the property at private sale, or to petition court for an order to sell the same, freed and discharged of all liens as hereinafter provided.

Section 2. This act shall take effect immediately.

#### AN ACT

Authorizing the Department of Property and Supplies, with the approval of the Governor, to sell and convey .78 acres, more or less, of land situate in the Borough of East Stroudsburg, Monroe County.

The General Assembly of the Commonwealth of Penn- Real property. sylvania hereby enacts as follows:

Section 1. The Department of Property and Sup- Department of plies, with the approval of the Governor, is hereby authorized on behalf of the Commonwealth of Pennsylvania to sell to the Borough of East Stroudsburg the following described tract of land, together with all improvements thereon except two sheet metal buildings burg Borough, Monroe County. presently under the jurisdiction of the Department of Highways, situate in East Stroudsburg Borough, Monroe County, for the consideration of three hundred sixtyfive dollars (\$365), all that certain piece or tract of land bounded and described as follows:

Section 3. All moneys received from the sale of the Disposition of land shall be deposited in the Motor License Fund.

#### AN ACT

Amending the act of April 29, 1959 (P. L. 58), entitled "An act consolidating and revising the Vehicle Code, the Tractor Code, the Motor Vehicle Financial Responsibility Act and other acts relating to the ownership, possession and use of vehicles and tractors," making a correction for a typographical error.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. Subsection (a.1), section 618, act of April 29, 1959 (P. L. 58), known as "The Vehicle Code," added January 8, 1960 (P. L. 2118), is amended to read:

Section 618. Suspension of Licenses or Operating Privileges .---

(a.1) The secretary shall suspend the operating privileges of any person, with or without a hearing before the secretary or his representative, upon receiving proceedings in which such person pleaded guilty, entered a plea of nolo contendere, or was found guilty by a judge or jury of violating the provisions of section [1040] 1041 of this act.
