(d) Is able to work and available for suitable work: Provided, That a claimant who is attending a training or retraining course approved by the department as meeting a suitable and realistic employment or reemployment objective of the employe shall be deemed to be able to work and available for suitable work if the claimant is otherwise in fact able and available: Provided, That a pregnant claimant not disqualified under the provisions of subsection 402 (b) (1) or 402 (f) of this act shall be conclusively presumed to be unavailable for work and ineligible for benefits under the provisions of this act with respect to the period beginning thirty days prior to anticipated birth and ending thirty days after birth of the child.

* * * * *

Section 4. This act shall take effect September 1, Applicable dates. 1961, and subsection (u) of section 4 and subsection (d) of section 401 shall be applicable to claims for benefits filed for weeks beginning on or after September 1, 1961.

AN ACT

Authorizing the Department of Property and Supplies, with the approval of the Department of Forests and Waters, to lease land in Valley Forge State Park to the United States Post Office Department for the purpose of the construction and operation of a post office.

The General Assembly of the Commonwealth of Penn- Real property. sylvania hereby enacts as follows:

Department of Property and Supplies, wit with approval of Secretary of For-ests and Waters, authorized to lease certain land in Valley Forge State Park to the United States Post Office Depart-ment with a re-versionary title and possession of improvements after certain ex-tended terms. authorized to

Section 1. The Department of Property and Supplies, with the approval of the Secretary of Forests and Waters, is hereby authorized to enter into a lease agreement with the United States Post Office Department under the terms of which the United States Post Office Department may lease land in Valley Forge State Park and construct thereon a permanent building to be used as a post office. The lease agreement may provide for a term of twenty years with options for four renewal terms of five years each, which options may be exercised in the sole discretion of the United States Post Office Department. The lease agreement shall also provide that, upon the termination of the operation of a post office upon the land, title to all buildings and improvements erected thereon shall vest in the Commonwealth of Pennsylvania and the Commonwealth of Pennsylvania shall have the full right of possession of the land and buildings.

Approval and execution.

Section 2. The lease agreement shall be approved as to form and legality by the Attorney General.

Act effective immediately.

Section 3. This act shall take effect immediately.
