and address of the registered owner or operator. provisions of this section shall not apply to (a) commercial motor vehicles, truck tractors, trailers or semitrailers, owned or operated by any public utility or contract carrier regulated by the Pennsylvania Public Utility Commission or the Interstate Commerce Commission, (b) or to commercial motor vehicles, truck tractors, trailers or semi-trailers used in agriculture, (c) or to commercial motor vehicles, truck tractors, trailers or semi-trailers, which are clearly identified by the name or trade name of the registered owner or operator, or to (d) commercial motor vehicles, truck tractors, trailers or semi-trailers, being demonstrated or delivered by manufacturer or dealer thereof.

Penalty.-Any owner or operator who shall fail to comply with any of the provisions of this section shall, upon summary conviction before a magistrate, be sentenced to pay a fine of ten dollars (\$10.00) and costs of prosecution, and in default of the payment thereof, shall undergo imprisonment for not more than five (5) days.

This act shall take effect June 30, 1962.

AN ACT

Requiring the erection and maintenance of medial barriers or guards on the Pennsylvania Turnpike.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Pennsylvania Turnpike Commission.

Section 1. The Pennsylvania Turnpike Commission shall erect and thereafter maintain and repair along not less than one hundred fifty miles of the Pennsylvania Turnpike medial guards or barriers which shall be of sufficient strength and height to effectively prevent vehicular traffic moving in one direction on the turnpike from crossing the medial line and entering the lanes provided for vehicular traffic moving in the opposite direction.

Medial guards or barriers auth-orized for 150 miles.

Section 2. Commencing on the effective date of this Rate of erection: act. the Pennsylvania Turnpike Commission shall erect year. and thereafter maintain and repair not less than twentyfive miles of medial guards or barriers each year until

such time as the minimum length of one hundred fifty miles of the turnpike is so equipped.

Section 3. This act shall take effect immediately.

AN ACT

Amending the act of May 4, 1927 (P. L. 519), entitled "An act concerning boroughs, and revising, amending, and consolidating the law relating to boroughs," providing for the appointment of special school police, defining their powers and duties, and providing for their compensation by the borough.

The Borough Code.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Act of May 4, 1927, P. L. 519, reenacted and amended July 10, 1947, P. L. 1621, amended by adding a new section 1129.1.

Section 1. The act of May 4, 1927 (P. L. 519), known as "The Borough Code," reenacted and amended July 10, 1947 (P. L. 1621), is amended by adding, after section 1129, a new section to read:

Section 1129.1. Special School Police.—Upon request of the board of school directors of the school district of the borough, the borough council may appoint special school police who shall have the duty of controlling and directing traffic at or near schools and who shall be in suitable and distinctive uniform and shall display a badge or other sign of authority. Such police shall be vested with all the power of local police officers and while on duty shall be under and subject to the direction of the chief of police. They shall serve at the pleasure of the borough council and shall not come within the civil service provisions of this act and shall not be entitled to participate in any police pension plan or plans now in effect or hereinafter effective. The compensation of the school police, if any, shall be fixed by the borough council and shall be paid by the borough.

Act effective immediately.

Section 2. This act shall take effect immediately.
